**STATEMENT OF THE CASES**

In **Case No. 25856**, Permian Resources seeks an order pooling all uncommitted interests in the First Bone Spring interval of the Bone Spring formation underlying a 320-acre, more or less, standard, overlapping horizontal spacing unit comprised of the W/2 W/2 of Sections 27 and 22, Township 22 South, Range 35 East, Lea County, New Mexico. This unit will be dedicated to the **Bridge State Unit 27 301H** well, which will be drilled from a surface hole location in the SE/4

SW/4 (Unit N) of Section 27 to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 22. This unit will overlap with the spacing unit for the Bridge State Unit 27 501H (API No. 30-025-54229) well, which produces from the Rock Lake; Bone Spring Pool (Code 52766).

In **Case No. 25864**, Permian Resources seeks an order pooling all uncommitted interests in the First Bone Spring interval of the Bone Spring formation underlying a 320-acre, more or less, standard, overlapping horizontal spacing unit comprised of the W/2 E/2 of Sections 27 and 22, Township 22 South, Range 35 East, Lea County, New Mexico. This unit will be dedicated to the **Bridge State Unit 27 303H** well, which will be drilled from a surface hole location in the SE/4 SE/4 (Unit P) of Section 27 to a bottom hole location in the NW/4 NE/4 (Unit B) of Section 22. This unit will overlap with the spacing unit for the Bridge State Unit 27 503H (API No. 30-025-54232) well, which produces from the Rock Lake; Bone Spring Pool (Code 52766).

In **Case No. 25866**, Permian Resources seeks an order pooling all uncommitted interests in the First Bone Spring interval of the Bone Spring formation underlying a 320-acre, more or less, standard, overlapping horizontal spacing unit comprised of the E/2 W/2 of Sections 27 and 22, Township 22 South, Range 35 East, Lea County, New Mexico. This unit will be dedicated to the **Bridge State Unit 27 302H** well, which will be drilled from a surface hole location in the SE/4 SW/4 (Unit N) of Section 27 to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 22. This unit will overlap with the spacing unit for the Bridge State Unit 27 502H (API No. 30-025-54231) well, which produces from the Rock Lake; Bone Spring Pool (Code 52766).

A depth severance exists within the Bridge State Units. Accordingly, Applicant seeks to pool uncommitted interests from the top of the Bone Spring formation to the base of the First Bone Spring interval, at a stratigraphic equivalent of 10,122' TVD, as observed on the Northern AKQ State #1 well log (API No. 30-025-25443).

The completed intervals of the Bridge State wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells, the allocation of the costs, the designation of Applicant as operator of the units and wells, and a 200% charge for the risk involved in drilling and completing the wells.
