STATEMENT OF THE CASE

Select seeks authorization to drill, complete, and operate a proposed saltwater disposal well in Lea County, New Mexico. Select seeks to inject produced water into the Bell Canyon and Cherry Canyon formations (SWD; Bell Canyon-Cherry Canyon; Code 96802) for the purposes of disposal through its Javelina Fed 4 SWD #1 well ("Well"). The Well will be drilled at a location 408' from the south line and 831' from the east line (Unit P) of Section 4, Township 26 South, Range 35 East, Lea County, New Mexico. Select proposes to inject an average of 15,000 barrels of water per day up to a maximum of 20,000 barrels of water per day and requests that the Division approve a maximum surface injection pressure of 1,072 psi.

The Well was originally proposed to inject produced water into the Bell Canyon and Cherry Canyon formations at a depth of approximately 5,360 feet to 7,550 feet. Since the filing of the application and based on discussions with the parties, Select has agreed to narrow the injection interval and is now seeking authorization to inject at a depth of approximately 5,360 feet to 6,500 feet. This change is reflected in Select's hearing exhibits.

The Well, as proposed in the C-108, will not cause waste, impair correlative rights, or harm public health or the environment, including through the risk of induced seismicity. Further, the Well will be beneficial because additional saltwater disposal capacity is needed in this area.
