STATEMENT OF THE CASES

In **Case No. 25776**, Applicant applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 400-acre, more or less, standard horizontal spacing unit comprised of the S/2 S/2 of Sections 33 and 34 and the S/2 SW/4 of Section 35, Township 21 South, Range 26 East, Eddy County, New Mexico. The unit will be dedicated to the **Buffalo Nickel 33/35 State Com #527H** well, which will be drilled from a surface hole location in the NE/4 SE/4

(Unit I) of Section 32 to a bottom hole location in the SE/4 SW/4 (Unit N) of Section 35. The completed interval of the well will be orthodox.

In **Case No. 25777**, Applicant applies for an order pooling all uncommitted interests in the Wolfcamp formation underlying an 800-acre, more or less, standard horizontal spacing unit comprised of the S/2 of Sections 33 and 34 and the SW/4 of Section 35, Township 21 South, Range 26 East, Eddy County, New Mexico. The unit will be dedicated to the following wells: **Buffalo Nickel 33/35 State Com #716H** well, which will be drilled from a surface hole location in the NE/4 SE/4 (Unit I) of Section 32 to a bottom hole location in the NE/4 SW/4 (Unit K) of Section 35; and **Buffalo Nickel 33/35 State Com #718H** well, which will be drilled from a surface hole location in the NE/4 SE/4 (Unit I) of Section 32 to a bottom hole location in the SE/4 SW/4 (Unit N) of Section 35. The completed intervals of the wells will be orthodox.

Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Applicant as the operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.
