### **STATEMENT OF THE CASES**

In **Case No. 25793**, Permian Resources seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 640-acre, more or less, standard, overlapping, horizontal spacing unit comprised of the E/2 of Section 34, Township 19 South, Range 32 East, and the E/2 of Section 3, Township 20 South, Range 32 East, Lea County, New Mexico. This unit will be dedicated to the **Colonel Freckles Fed Com 15H**, **Colonel Freckles Fed Com 17H**, and **Colonel Freckles Fed Com 19H**, which will be drilled from surface hole locations in the NE/4 NE/4 (Unit A) of Section 34, Township 19 South, Range 32 East, to bottom hole locations in the SE/4 SE/4 (Unit P) of Section 3, Township 20 South, Range 32 East; and **Colonel Freckles Fed Com 16H**, **Colonel Freckles Fed Com 18H**, and **Colonel Freckles Fed Com 20H** which will be drilled from surface hole locations in the NW/4 NE/4 (Unit B) of Section 34, Township 19 South, Range 32 East, to bottom hole locations in the SW/4 SE/4 (Unit O) of Section 3, Township 20 South, Range 32 East.

The completed interval of the **Colonel Freckles Fed Com 18H** well will be located within 330' of the quarter-quarter section line separating the E/2 E/2 and W/2 E/2 of Section 34, Township 19 South, Range 32 East, and Section 3, Township 20 South, Range 32 East, to allow for the creation of a 640-acre standard, horizontal spacing unit.

The spacing unit for the Bone Spring Colonel Freckles wells partially overlaps with the spacing units for the Ocelot 34 Fed 1H (API No. 30-025-40142) well, which is located in the W/2

E/2 of Section 34, Township 19 South, Range 32 East, and produces from the Lusk; Bone Spring, South Pool (Code 41460).

In **Case No. 25796**, Permian Resources seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 640-acre, more or less, standard horizontal spacing unit comprised of the E/2 of Section 34, Township 19 South, Range 32 East, and the E/2 Section 3, Township 20 South, Range 32 East, Lea County, New Mexico. This unit will be dedicated to the **Colonel Freckles Fed Com 13H**, which will be drilled from a surface hole location in the NE/4 NE/4 (Unit A) of Section 34 to a bottom hole location in SE/4 SE/4 (Unit P) of Section 3; and **Colonel Freckles Fed Com 14H**, which will be drilled from a surface hole location in the NW/4 NE/4 (Unit B) of Section 34 to a bottom hole location in SW/4 SE/4 (Unit O) of Section 3.

The completed interval of the **Colonel Freckles Fed Com 13H** well will be located within 330 feet of the quarter-quarter section line separating the E/2 E/2 and W/2 E/2 of Section 34, Township 19 South, Range 32 East, and Section 3, Township 20 South, Range 32 East, to allow for the creation of a standard, 640-acre horizontal spacing unit.

The completed intervals of the Colonel Freckles wells will be orthodox. Also to be considered will be the cost of drilling and completing the Colonel Freckles wells, the allocation of the costs, the designation of Applicant as operator of the units and the Colonel Freckles wells, and a 200% charge for the risk involved in drilling and completing the Colonel Freckles wells.
