Pride Energy Company ("Applicant") files this application with the Oil Conservation Division (the "Division") for an order pooling all uncommitted mineral interest owners in the Wolfbone formation (Scharb; Wolfbone Pool/Pool Code 98397) underlying a horizontal spacing unit comprised of the W/2W/2 of Section 12 and the W/2W/2 of Section 13, Township 19 South, Range 34 East, NMPM, Lea County, New Mexico (the "Unit"). In support of this application, Applicant states:

1. Applicant is an interest owner in the Unit, and has the right to drill a well or wells thereon.
2. Applicant proposes to drill the Go State Com. Well No. 401H in the Unit to a depth sufficient to test the Wolfbone formation, The first take point will be in the SW/4SW/4 of Section 13 and the last take point will be in the NW/4NW/4 of Section 12.
3. Although Applicant has in good faith sought to obtain voluntary joinder of all other mineral interest owners in the Unit to participate in the drilling of the well or to otherwise commit their interests to the well, certain interest owners have failed or refused to commit their interests. Therefore, Applicant seeks an order pooling all uncommitted mineral interest owners in the Wolfbone formation underlying the Unit, pursuant to NMSA 1978 Sec. 70-2-17.


4. Due to a depth severance in the Unit, the Division will consider the allocation of production between the Third Bone Spring Sand and the Wolfcamp A Shale within the Wolfbone pool.

5. The pooling of all uncommitted mineral interest owners in the Wolfbone formation underlying the Unit will prevent the drilling of unnecessary wells, prevent waste, and protect correlative rights.

**WHEREFORE**, Applicant requests this application be set for hearing before an Examiner of the Division, and, after notice and hearing, the Division issue its order:

- A. Pooling all uncommitted mineral interest owners in the Wolfbone formation (Scharb; Wolfbone Pool) underlying the Unit;
- B. Designating Applicant as operator of the well and the Unit;
- C. Considering the cost of drilling, completing, testing, and equipping the well, and allocating the cost thereof among the well's working interest owners pursuant to an allocation formula approved by the Division;
- D. Approving actual operating charges and costs charged for supervision, together with a provision adjusting the rates pursuant to the COPAS accounting procedure; and
- E. Setting a 200% charge for the risk involved in drilling, completing, testing, and equipping the well in the event a working interest owner elects not to participate in the well.

**REVISED SELF-AFFIRMED STATEMENT OF LANDMAN MATTHEW PRIDE**

I, Matthew Pride, do hereby state and affirm the following:

1. I am over the age of 18, and have the capacity to execute this Affirmation, which is based on my personal knowledge.

2. This statement is submitted in connection with the filing by Pride Energy Company (“Pride”) of the above-referenced compulsory pooling applications pursuant to 19.15.4.12.A(1) NMAC.

3. I am the land manager for Pride. I am familiar with the subject applications and the lands involved.

4. I have previously testified before the New Mexico Oil Conservation Division as an expert witness in petroleum land matters. My credentials as a petroleum landman have been accepted by the Division and made a matter of record.

5. The purpose of this application is to force pool working interest owners into the horizontal spacing unit (“HSU”) described below and in the well to be drilled in the HSU.

6. In **Case No. 25562**, Pride seeks an order from the Oil Conservation Division pooling all uncommitted mineral interests in the Wolfbone formation (Scharb; Wolfbone Pool [98397]) in a standard 320-acre, more or less, horizontal spacing and proration unit (“HSU”),



comprised of the W/2W/2 of Sections 12 and 13, all in Township 19 South, Range 34 East, in Lea County, New Mexico. Pride proposes to drill the Go State Com. Well No. 401H (“Go State 401H”) in the HSU, to be horizontally drilled from a surface hole location 250’ FSL and 380’ FWL of Section 13, T19S-R34E, to a bottom hole location 100’ FNL and 350’ FWL of Section 12, T19S-R34E. The first take point will be 300’ FSL and 350’ FWL of Section 13, T19S-R34E. The last take point will be 350’ FWL and 100’ FNL of Section 12, R19S-T34E. The Go State 401H will be drilled to a depth sufficient to test the Wolfbone pool, targeting the Wolfcamp A Shale. The first and last take points and completed interval for Go State 401H will meet the setback requirements set forth in the statewide rules for horizontal oil wells.

7. In **Case No. 25564**, Coterra Energy Co. (“Coterra”) seeks an order pooling all uncommitted mineral interest owners in the Wolfbone formation (Scharb; Wolfbone Pool [98397]) in the same HSU proposed by Pride. Upon information and belief, Coterra proposes to drill the Showbiz 13-12 State Com 301H Well (“Showbiz 13-12 301H”), to be horizontally drilled from a surface hole location 216’ FSL and 100’ FWL of Section 13, T19S-R34E, to a bottom hole location 100’ FNL and 330’ FWL of Section 12, T19S-R34E. Coterra proposes to drill the Showbiz 13-12 301H to a depth sufficient to test the Wolfbone pool, targeting the Third Bone Spring.

8. Pride filed its first application to pool the subject acreage and drill the Go State 401H on May 3, 2022, seeking to pool the Wolfcamp formation in Case No. 22853. More than seven months later, on December 15, 2022, Coterra’s predecessor Cimarex Energy Co. filed its first application to pool the subject acreage and drill the Showbiz 13-12 301H, among others, seeking to pool the Bone Spring formation in Case No. 23295.<sup>1</sup>

9. A Form C-102 for the Go State 401H is attached as **Exhibit A-1**.
10. A map illustrating the tracts within the acreage to be pooled and information regarding the working interest ownership of each individual tract, the working interest ownership within the unit, and the leases within the unit are attached as **Exhibit A-2**.
11. A sample letter with the initial well proposal and AFE, a supplemental letter to interest owners with a revised AFE, and a supplemental letter informing working interest owners of revision of the proposed operating rates and new date for contested hearing are attached as **Exhibit A-3**. Pride's revised AFE is \$1,418,364 less than Coterra's most recent AFE.
12. A chronology of contacts with parties being pooled is attached as **Exhibit A-4**.
13. A chart with all working interest owners and their commitment status is attached as **Exhibit A-5**.
14. Coterra filed applications to drill wells in the First, Second, and Third Bone Spring, and the Division approved the application to drill the First and Second Bone Spring wells in Case No. 255637. However, anticipated production from the First and Second Bone Spring wells does not justify drilling these wells with today's oil prices.
15. There is a depth severance at the base of the Third Bone Spring in Tract 3. Coterra owns the interest above the base of the Third Bone Spring in Tract 3. Pride has an interest below the base of the Third Bone Spring in Tract 3. No other interest owners have a depth severance. The parties have stipulated that the Third Bone Spring and the Wolfcamp A Shale will contribute equally to production, with 50% attributed to the Third Bone Spring and 50% attributed to the Wolfcamp A Shale. Based on this agreement, Pride determined that it has 50% of the total 80-acre Tract 3, that is 40 acres, and that Coterra also has 50% of the total 80-acre Tract 3, that is 40 acres. Thus, Pride has a 40-acre interest in the proposed HSU and Coterra has a 132-acre interest.

Based on surface acreage, Pride's ownership interest in the proposed unit is 12.5%, and Coterra's ownership interest is 41.25%. Because the only depth severance is between Pride and Coterra in Tract 3, and no other owner has an interest in Tract 3, the production allocated to any other interest owner is not impacted by pooling over the depth severance. Therefore, the interest owners' correlative rights will not be adversely impacted by pooling over the depth severance.

16. Pride currently operates six wells in Section 13, including the Go State Com #101H, #102H, #203H, #204H, #305H, and #306H, and can use the same facilities for the proposed Go State 401H. Consequently, Pride's proposal will result in less surface disturbance and significant cost savings to the working interest owners.

17. Coterra has operated one well in Section 12, the Teal 12 State Com #002H, since 2014, and one well in Section 11, the Quail 11 State #001H, since 2013. However, Coterra took no steps to propose drilling any of the Bone Spring wells it proposed until the end of 2022, seven months after Pride proposed drilling the Go State #401H.

18. The surface location is owned by the State of New Mexico. Upon approval of Pride's application, Pride will promptly obtain the necessary approval from the State Land Office for the proposed surface location.

19. Pride has been drilling wells in New Mexico for over 25 years and has drilled multiple horizontal multi-well units. Pride Energy Company's staff and consulting drilling engineers have over 100 years of combined experience in drilling horizontal Wolfcamp and Bone Spring wells in Eddy and Lea Counties, New Mexico. Pride diligently bids out all expenditures to assure that the best price and service is obtained for the joint account which is a part of prudently operating the wells and thereby preventing waste.

20. Pride conducted a diligent search of the public records in Lea County, New Mexico, where the wells will be located, and conducted phone directory and computer searches to obtain contact information for parties entitled to notification.

21. Pride has made a good faith effort to obtain voluntary joinder of all interest owners in the proposed wells. In particular, Pride and Coterra have conferred since the filing of the initial applications in Case Nos. 22853 and 23295 in 2022. *See* chronology of contacts, attached as Exhibit A-4.

22. Pride and Coterra have agreed that operating charges and costs of supervision while drilling of \$10,000/month and, after completion, \$1,000/month are reasonable. However, in its application, Pride requested that the Division approve costs of \$8,000/month and \$800/month, together with a provision adjusting the rates pursuant to the COPAS accounting procedures. Pride therefore requests approval of operating charges and costs of supervision while drilling of \$10,000/month and, after completion, \$1,000/month, together with a provision adjusting the rates pursuant to the COPAS accounting procedures, subject to any objection from a working interest owner to this increase in requested rates. A letter to the working interest owners regarding the revised proposed operating rates for Pride was mailed on January 14, 2026.

23. Pride requests the maximum cost, plus 200% risk charge, be assessed against non-consenting working interest owners. Pride requests that it be designated operator of the wells.

24. The exhibits attached hereto were prepared by me or compiled from Pride's business records under my supervision.

25. The granting of Pride's application is in the interests of conservation, the prevention of waste, and the protection of correlative rights.

26. The foregoing is correct and complete to the best of my knowledge and belief.

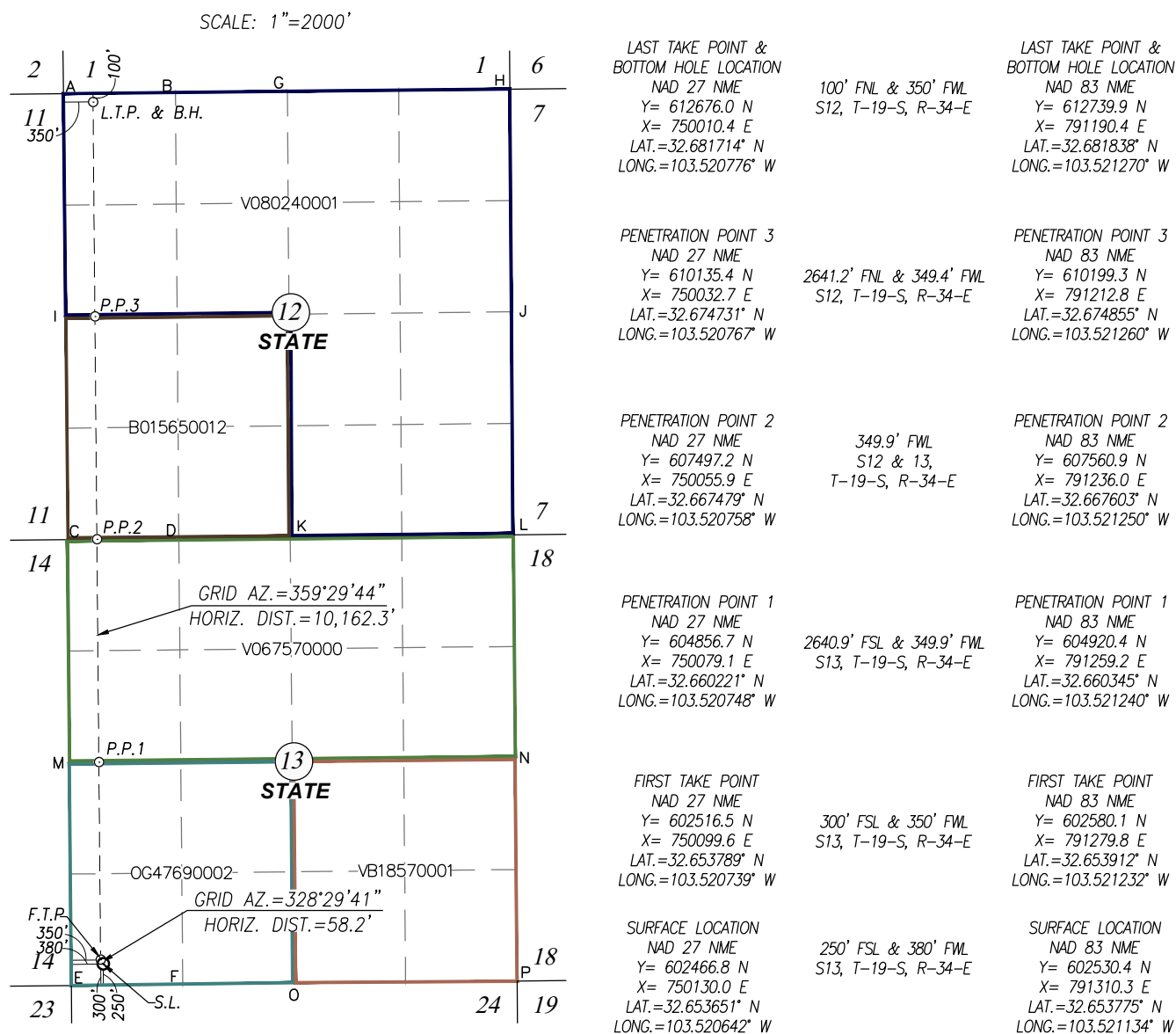

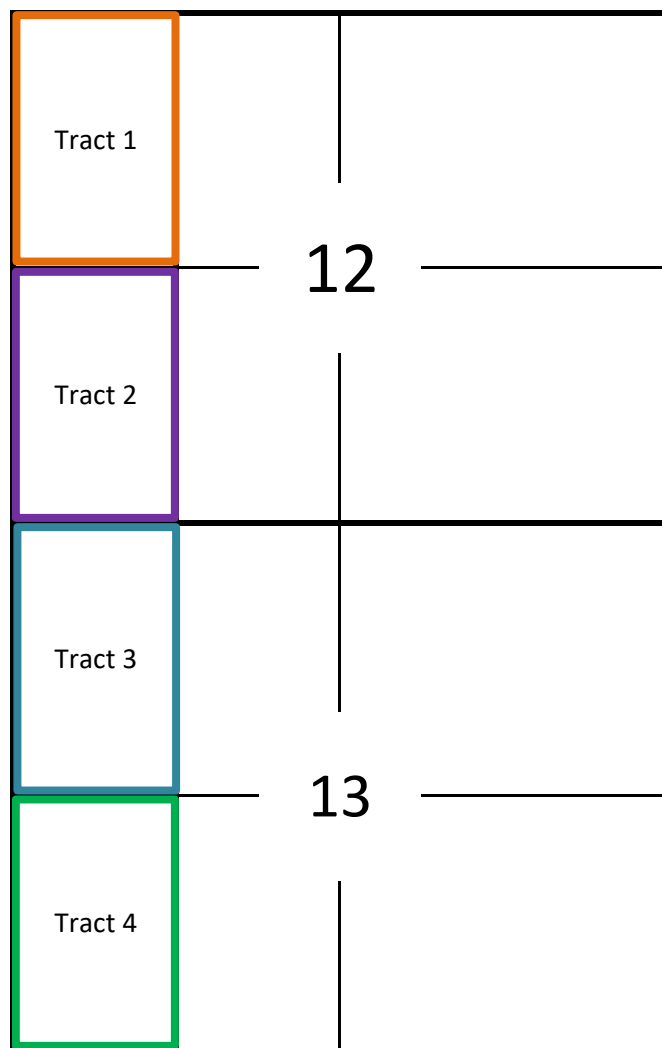

In reference to the above, this correspondence is to provide an update as to the status of the proposed well. Pride Energy Company (“Pride”) hereby proposed to drill the Go State Com #401H well, a horizontal well to be located in the W/2 W/2 of Section 12, Township 19 South, Range 34 East, and the W/2 W/2 of Section 13, Township 19 South, Range 34 East, Lea County, New Mexico, to a depth sufficient to test the Wolfcamp formation. This well will be drilled from a surface location in the SW/4 SW/4 of Section 13, Township 19 South, Range 34 East to a bottom-hole location in the NW/4 NW/4 of Section 12-19S-34E, with an estimated True Vertical Depth (TVD) of 11,025', and projected 9,960' horizontal lateral across Sections 12 and 13-19S-34E, (approximately 20,985' Total Measured Depth (TMD). An updated AFE dated December 29, 2025 for this well was mailed to you on December 30, 2025. The original well proposal letter remains in effect subject to the changes set out in this letter.

**SELF-AFFIRMED STATEMENT OF GEOLOGIST HARVIN L. BROUGHTON**

I, Harvin Broughton, being first duly sworn on oath, state the following:

1. I am over the age of 18, and have the capacity to execute this affirmation, which is based on my personal knowledge.

2. This affirmation is submitted in connection with the filing by Pride of the above-referenced compulsory pooling applications pursuant to 19.15.4.12.A(1) NMAC.

3. I am employed as a contract geologist for Pride Energy Company (“Pride” or “Applicant”), and I am familiar with the subject applications and the lands involved.

4. I have previously testified before the New Mexico Oil Conservation Division as an expert witness in petroleum geology matters. My credentials as a petroleum geologist have previously been accepted by the Division and made a matter of record.

5. **Exhibit B-1** is a general location map indicating the location of the proposed horizontal spacing units (“HSU”).

6. **Exhibit B-2** is a subregional structure map showing the structure of the top of the Wolfcamp A formation. Contour interval is 50’. The structural dip across this area is to the South Southwest. Additionally displayed are the Go State HSU boundary and cross-section reference line, A-A’.

7. **Exhibit B-3** is a stratigraphic cross-section, A-A', showing the Third Bone Spring Sand and the Wolfcamp A intervals. The cross-section is flattened on the Wolfcamp A top. The total gross thickness of the Wolfbone pool is approximately 655' thick, as reflected in the Super Cobra State C 1H type log.

8. **Exhibit B-4** is a type log with defined pool, target interval and reference map.

9. **Exhibit B-5** is a wellbore profile and gunbarrel view showing the proposed well trajectory and target interval based on type log.

10. **Exhibit B-6** is a gross isopach map of the Scharb Wolfbone Pool interval, from the top of the Third Bone Spring Sand to the base of the Wolfcamp A with 50' contour intervals, showing the gross Wolfbone Pool thickness across the HSU. This gross thickness is being calculated from the top of the Third Bone Spring Sand to the base of the Wolfcamp A interval. The total gross thickness of the Wolfbone Pool in this HSU area is approximately 750'. This gross isopach map covers the defined Scharb Wolfbone Pool, thus goes from the top of the 3rd BS Sand (10,745') down to the base of the Wolfcamp A (11,400') interval as designated in the previous order establishing the Scharb Wolfbone pool, referenced to the Super Cobra well. This gross interval thickness is 655' at the Super Cobra well, thickening to approximately 750' at the Go State location.

11. The planned measured depth of the Go State Com #401H is 20,985' at a true vertical depth of 11,025'.


12. Based on my geologic study of the area, I conclude the following:


- a. The horizontal spacing and proration unit is justified from a geologic standpoint.
- b. There are no structural impediments or faults that will interfere with horizontal development.



- c. Each quarter-quarter section in the HSU will contribute more or less equally to production.
  - d. The most efficient way to develop the acreage in each case is as proposed by Pride. There is no established and generally accepted preferential drilling orientation based on present-day stress regime or other geological factors that would counter the proposed South-North well orientation. Successfully developed Bone Spring horizontal wells oriented South-North have been drilled in the region, so an established trend is present. This orientation also fits our lease boundaries and aligns with the remainder of Pride's planned development in the adjoining tracts. This preferred well orientation does not strand any acreage or reserves.
13. The exhibits attached hereto were prepared by me or compiled from Pride's business records under my supervision.
14. The granting of the applications is in the interests of conservation, the prevention of waste, and the protection of correlative rights.
15. The foregoing is correct and complete to the best of my knowledge and belief.

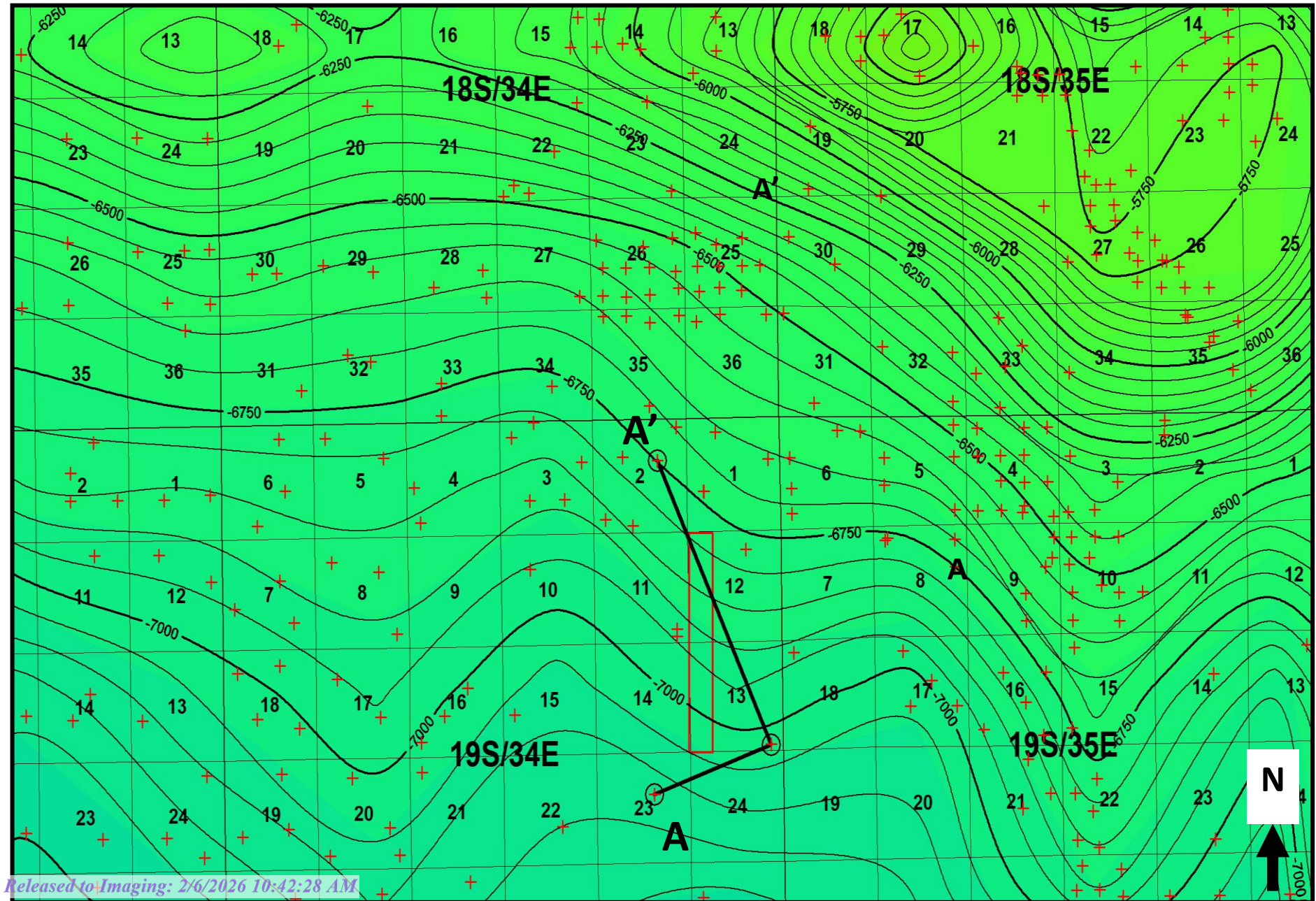

I, Will Gifford, do hereby state and affirm the following:

1. I am over the age of 18, and have the capacity to execute this Affirmation, which is based on my personal knowledge.

2. This statement is submitted in connection with the filing by Pride Energy Company ("Pride") of the above-referenced compulsory pooling applications pursuant to 19.15.4.12.A(1) NMAC.

3. I am a petroleum engineer employed by Pride. I am familiar with the subject applications and the lands involved.

4. I seek to be qualified as an expert petroleum engineer. I have not previously testified before the Division. My education and work experience are detailed in my resume, appended hereto. A summary of my education and work experience is as follows: I obtained my bachelor of science degree in petroleum engineering from the University of Oklahoma (OU) in 2016. After OU and seven consecutive summers spent interning for oil and gas companies, I have spent nine years working many roles at three different upstream oil and gas companies of varying sizes with experience in production engineering, reservoir engineering, oil & gas facilities, well optimization, well interventions, and drilling and completion.



5. From an engineering perspective, Pride's proposed well is superior to the competing proposal of Coterra Energy Company because landing the well in the Wolfcamp formation will provide for greater recovery of total reserves including both the Wolfcamp and the Third Bone Spring, thus likely delivering a higher EUR (estimated ultimate recovery), for the following reasons:

- When a well is fractured, the fractures tend to grow up and out, and it is common industry knowledge that a frac will grow up much more than it will grow down. Therefore, the fractures generated in a well landed in the Wolfcamp will almost certainly grow up into the Third Bone Spring sand, thereby capturing its reserves. It is not likely that a well landed in the Third Bone Spring sand will be able to capture nearly the amount of reserves within the Wolfcamp as compared to landing a well in the Wolfcamp.
- This means from a capital efficiency standpoint, that at end of well life, Pride's proposed wellbore should deliver more oil and gas than Coterra's proposed wellbore even if the AFE cost were identical. In this case, Pride's AFE is ~\$1.4 million lower than Coterra's AFE, due mainly to Pride already having a facility in place.
- Exhibit C-1 attached hereto is a slide from Coterra taken from "Application of Cimarex Energy Co. for a Horizontal Spicing Unit and Compulsory Pooling, Lea County, New Mexico" which is a public hearing document (Case No. 23295) received and released to imaging by NMOCD on 7/13/2023. This slide shows that back in 2023, Coterra made the same argument in its first application to pool Coterra's subject well that I am making now, thereby further validating Pride

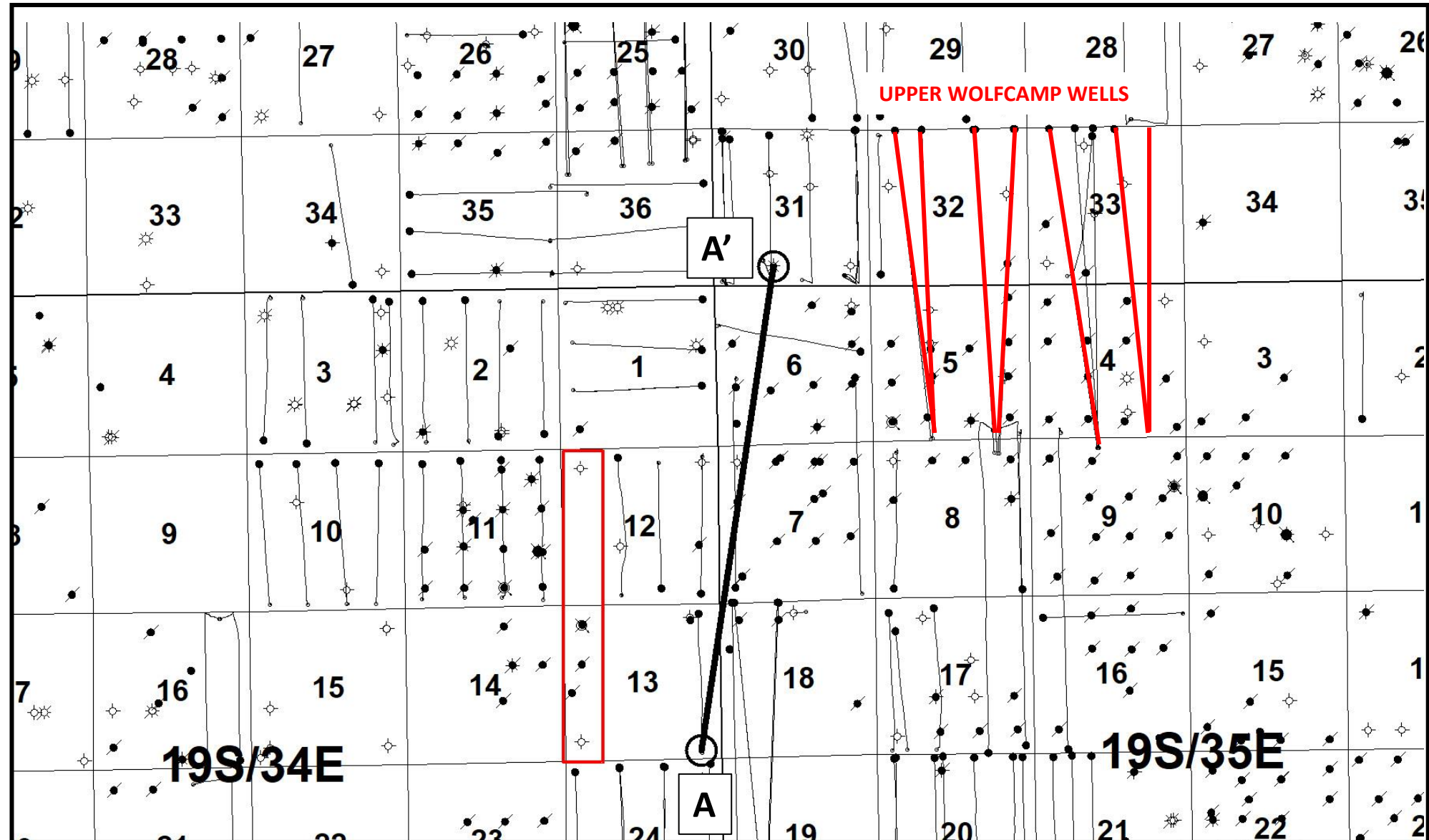

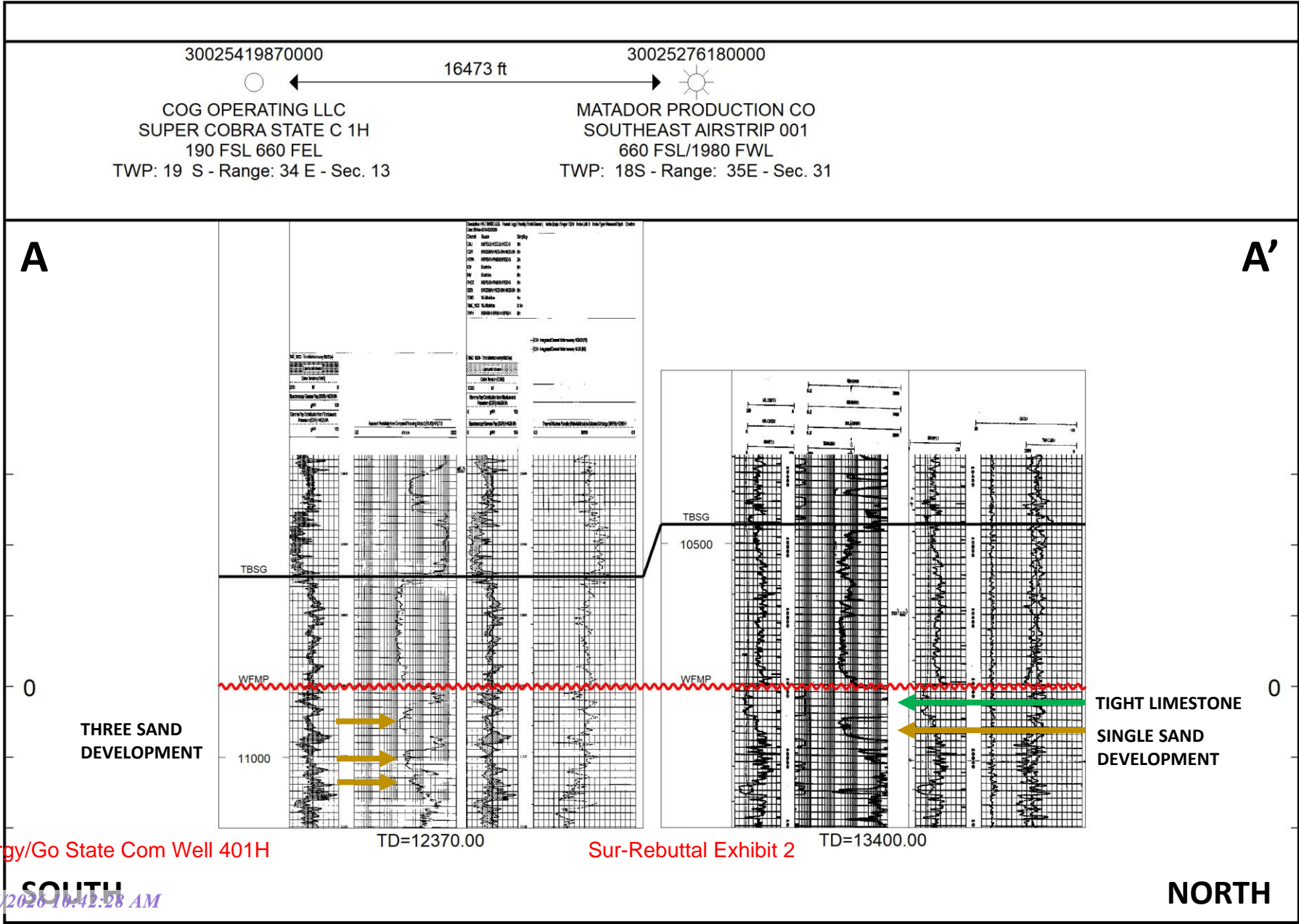


# SOUTH TO NORTH CROSS SECTION REFERENCE MAP
