**NEW MEXICO OIL CONSERVATION DIVISION'S AGREED MOTION FOR  
CONTINUANCE**

**NOW COMES** Movant, the New Mexico Oil Conservation Division ("OCD"), moves for an order continuing the hearing on the above Notice of Violation ("NOV"), and in support thereof, states:

1. The above-referenced matter is currently set for hearing on April 15, 2026.
2. Respondent, Echo Production, Inc., has agreed with the undersigned to continue the hearing until May 5, 2026, since the parties have agreed in principle to the terms of an SFO and Respondent has represented to OCD that the well at issue has been plugged, but that the proper paperwork had not been filed with OCD. Based upon information and belief, those documents have now been submitted to OCD, and Respondent is awaiting OCD approval of the paperwork. Given the prospect of the wells being brought into compliance and a settlement of the NOV being possible, OCD agreed with Respondent to a short continuance of this case until the May 5, 2026 OCD docket.
3. This continuance is not being sought for purposes of delay, but so that justice may be done. A proposed order is attached hereto as **Exhibit A**.

WHEREFORE, premises considered, Movant requests that this case be continued to the May 5, 2026 OCD docket.
