**MOTION TO REMOVE AND RELEASE XTO HOLDINGS, LLC
FROM POOLING ORDER NO. 23990**

Riley Permian Operating Company, LLC (OGRID No. 372290) (“**Riley**”) moves for the New Mexico Oil Conservation Division to remove and release XTO Holdings, LLC (“**XTO**”) as a pooled party under Order issued on September 8, 2025 (Order No. R-23990) pursuant to the following:

1. The District of the New Mexico Oil Conservation Division (“**OCD**”) heard the Application for Compulsory Pooling in the above styled case on July 10, August 7, and August 13, 2025.
2. The OCD issued an Order dated September 8, 2025 (Order No. R-23990) pooling the uncommitted interests in the Unit, including XTO Holdings, LLC, as described in the Application.
3. Riley wishes to have XTO removed and released from the Order as an uncommitted interest owner to facilitate reaching an agreement regarding the interest of XTO.
