**STATEMENT OF THE CASE**

Applicant seeks an order pooling additional uncommitted interests under the terms of Division Order No. R-22905 (“Order”). The Order pooled uncommitted interests in the Bone Spring formation underlying a 640-acre, more or less, non-standard horizontal spacing unit, comprised of the S/2 of Sections 8 and 9, Township 18 South, Range 29 East, Eddy County, New

Mexico (“Unit”). The Order dedicated the Unit to the Double Stamp 9/8 Federal Com No. 526H and Double Stamp 9/8 Federal Com No. 528H wells (“Wells”) and designated Applicant as operator of the Unit and Wells.

Since the Order was entered, Applicant has identified additional interests in the Unit that should be pooled under the terms of the Order to allow Applicant to obtain its just and fair share of the oil and gas underlying the subject lands.
