APPLICANT'S STATEMENT OF THE CASES

Under these consolidated cases, MRC seeks orders pooling all uncommitted interests in the following proposed horizontal well spacing units underlying acreage all within Township 21 South, Range 31 East, NMPM, Eddy County, New Mexico:

- Under **Case No. 26057**, MRC seeks an order pooling the uncommitted interest owners in a standard 478.67-acre, more or less, horizontal well spacing unit in the Bone Spring formation (WC-025 G-06 S213217K; Bone Spring [97961]) underlying the N/2 N/2 of Sections 16 and 17, and Lot 1, NE/4 NW/4 and N/2 NE/4 (N/2 N/2 equivalent) of irregular Section 18. MRC seeks to dedicate this horizontal spacing unit to the proposed **Corby Federal Com 101H, Corby Federal Com 105H, Corby Federal Com 111H, and Corby Federal Com 145H** wells, all to be horizontally drilled from surface locations in the SE/4 NW/4 (Unit F) of irregular Section 18, with first take points in Lot 1 (NW/4 NW/4 equivalent) of irregular Section 18, and last take points in the NE/4 NE/4 (Unit A) of Section 16.
- Under **Case No. 26058**, MRC seeks an order pooling the uncommitted interest owners in a standard 478.73-acre, more or less, horizontal well spacing unit in the Bone Spring formation (WC-025 G-06 S213217K; Bone Spring [97961]) underlying the S/2 N/2 of Sections 16 and 17, and Lot 2, SE/4 NW/4 and S/2 NE/4 (S/2 N/2 equivalent) of irregular Section 18. MRC seeks to dedicate this horizontal spacing unit to the proposed **Corby Federal Com 102H, Corby Federal Com 106H, Corby Federal Com 112H, and Corby Federal Com 146H** wells, all to be horizontally drilled from surface locations in the SE/4 NW/4 (Unit F) of irregular Section 18, with first take points in Lot 2 (SW/4 NW/4 equivalent) of irregular Section 18, and last take points in the SE/4 NE/4 (Unit H) of Section 16.

The completed interval for the wells will comply with statewide setbacks for oil. MRC has sought and been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject acreage.
