**APPLICANT’S STATEMENT OF THE CASES**

Under these consolidated cases, MRC seeks orders pooling for the referenced acreage as follows:

- In **Case No. 26091**, MRC seeks an order pooling all uncommitted interests in a standard 480.44-acre, more or less, horizontal well spacing unit in the Barnett formation [this is a wildcat pool, to be assigned by the Division] underlying Lot 4, the SW/4 NW/4, and W/2 SW/4 (W/2 W/2 equivalent) of irregular Section 4, and

the W/2 W/2 of Sections 9 and 16, Township 24 South, Range 36 East, NMPM, Lea County, New Mexico. Applicant seeks to initially dedicate the above-referenced horizontal spacing unit to the proposed **Roy Turner State Com 811H** well, to be horizontally drilled from a surface location in the Lot 4 (NW/4 NW/4 equivalent) of irregular Section 4, with a first take point in Lot 4 (NW/4 NW/4 equivalent) of irregular Section 4, and a last take point in the SW/4 SW/4 (Unit M) of Section 16.

- In **Case No. 26092**, MRC seeks an order pooling all uncommitted interests in a standard 480.42-acre, more or less, horizontal well spacing unit in the Barnett formation [this is a wildcat pool, to be assigned by the Division] underlying Lot 3, SE/4 NW/4, and E/2 SW/4 (E/2 W/2 equivalent) of irregular Section 4, and the E/2 W/2 of Sections 9 and 16, Township 24 South, Range 36 East, NMPM, Lea County, New Mexico. Applicant seeks to initially dedicate the above-referenced horizontal spacing unit to the proposed **Roy Turner State Com 812H** well, to be horizontally drilled from a surface location in Lot 4 (NW/4 NW/4 equivalent) of irregular Section 4, with a first take point in Lot 3 (NE/4 NW/4 equivalent) of irregular Section 4, and a last take point in the SE/4 SW/4 (Unit N) of Section 16.
- In **Case No. 26094**, MRC seeks an order pooling all uncommitted interests in a standard 480.44-acre, more or less, horizontal well spacing unit in the Woodford formation [this is a wildcat pool, to be assigned by the Division] underlying Lot 4, the SW/4 NW/4, and W/2 SW/4 (W/2 W/2 equivalent) of irregular Section 4, and the W/2 W/2 of Sections 9 and 16, Township 24 South, Range 36 East, NMPM, Lea County, New Mexico. Applicant seeks to initially dedicate the above-

referenced horizontal spacing unit to the proposed **Roy Turner State Com 911H** well, to be horizontally drilled from a surface location in the Lot 4 (NW/4 NW/4 equivalent) of irregular Section 4, with a first take point in Lot 4 (NW/4 NW/4 equivalent) of irregular Section 4, and a last take point in the SW/4 SW/4 (Unit M) of Section 16.

- In **Case No. 26095**, MRC seeks an order pooling all uncommitted interests in a standard 480.42-acre, more or less, horizontal well spacing unit in the the Woodford formation [this is a wildcat pool, to be assigned by the Division] underlying Lot 3, SE/4 NW/4, and E/2 SW/4 (E/2 W/2 equivalent) of irregular Section 4, and the E/2 W/2 of Sections 9 and 16, Township 24 South, Range 36 East, NMPM, Lea County, New Mexico. Applicant seeks to initially dedicate the above-referenced horizontal spacing unit to the proposed **Roy Turner State Com 912H** well, to be horizontally drilled from a surface location in Lot 4 (NW/4 NW/4 equivalent) of irregular Section 4, with a first take point in Lot 3 (NE/4 NW/4 equivalent) of irregular Section 4, and a last take point in the SE/4 SW/4 (Unit N) of Section 16.

The completed interval for the wells will meet the statewide setbacks for oil wells. Applicant has sought and been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject spacing unit.
