**APPLICANT’S STATEMENT OF THE CASE**

Under these consolidated cases, Mewbourne seeks orders pooling for the referenced acreage, all in Township 18 South, Range 33 East, NMPM, Lea County, New Mexico in the Bone Spring formation (Corbin, Bone Spring, South [13160]) as follows:

- In **Case No. 26121**, Mewbourne seeks an order pooling all uncommitted interest owners in a standard 320-acre, more or less, well spacing unit underlying the W/2 W/2 of Sections 20 and 29, and initially dedicating the spacing unit to the proposed **Undertaker 20/29 Fed Com 521H** well, to be drilled from a surface location in

the SW/4 SE/4 (Unit O) of Section 17, to a bottomhole location in the SW/4 SW/4 (Unit M) of Section 29.

- In **Case No. 26122**, Mewbourne seeks an order pooling all uncommitted interest owners in a standard 320-acre, more or less, well spacing unit underlying the E/2 W/2 of Sections 20 and 29, and initially dedicating the spacing unit to the proposed **Undertaker 20/29 Fed Com 523H** well, to be drilled from a surface location in the SW/4 SE/4 (Unit O) of Section 17, to a bottomhole location in the SE/4 SW/4 (Unit N) of Section 29.

The completed interval for the wells will comply with statewide setbacks for oil wells. Mewbourne has sought but been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject spacing units.
