Pursuant to NMSA § 70-2-17, Coterra Energy Operating Co. (“Applicant”) (OGRID No. 215099), through its undersigned attorney, hereby files this Application with the Oil Conservation Division of the State of New Mexico (“Division”) for an order (1) creating a 1,280-acre, more or less, standard horizontal well spacing unit comprised of the W/2 of Sections 13, 24, 25, and 36, all located in Township 19 South, Range 35 East, NMPM, Lea County, New Mexico (“Unit”), and (2) pooling all uncommitted interest within the Bone Spring formation underlying said Unit. In support of its Application, Applicant states the following:

1. Applicant is a working interest owner in the Unit and has the right to drill thereon.
2. Applicant seeks to dedicate the above-referenced Unit to the following well, referred to herein as the Well:
  - a. **Sun State Com 221H** well (API No. Pending), which will be horizontally drilled from a surface hole location 320’ FNL and 1,263’ FWL of Section 13, Township 19 South, Range 35 East, to a bottom hole location 100’ FSL and 888’ FWL of Section 36, Township 19 South, Range 35 East.
3. Applicant provides notice that the proposed Unit partially overlaps 2 existing standard horizontal spacing units dedicated as follows:
  - a. Sun State Com #502H well (API No. 30-025-51880), a Pearl; Bone Spring, South [49685] well producing from the E/2 SW/4 of Section 24, and the E/2 W/2 of Sections 25 and 36, all located in Township 19 South, Range 35 East, NMPM, Lea County, New Mexico (400 acres). This well was pooled in Case No. 23906 by Order No. R-22989. This overlap affects approximately 400 acres in Sections 24, 25, and 36.
  - b. Blue Box Federal Com #505H well (API No. 30-025-52080), a Scharb; Bone Spring [55610], Pearl; Bone Spring [49680], WC-025 G-07 S193513B; Bone Spring [97926] well producing from the W/2 SW/4 of Section 1, the W/2 W/2 of Sections 12 and 13 (400 acres), the E/2 SE/4 of Section 2, and the E/2 E/2 of Sections 11 and

14 (400 acres), all located in Township 19 South, Range 35 East, NMPM, Lea County, New Mexico (800 acres in total). This well was pooled in Case No. 23965 by Order No. R-23031. This overlap affects approximately 160 acres in Section 13.

4. The completed interval of the Well will be orthodox and remain within 330 feet of the adjoining quarter-quarter section (or equivalent) tracts to allow inclusion of these proximity tracts within the proposed Unit under NMAC 19.15.16.15(B)(4).
5. Applicant has undertaken diligent, good-faith efforts to obtain voluntary agreements from all interest owners to participate in the drilling of the Well but has been unable to obtain voluntary agreements from all interest owners.
6. The approval of this Unit and pooling of uncommitted interests within the Unit will avoid the drilling of unnecessary wells, prevent waste, and protect correlative rights.
7. In order to allow Applicant to obtain its just and fair share of the oil and gas underlying the subject lands, all uncommitted interests in the Unit should be pooled and Applicant should be designated the operator of the Well and Unit.

WHEREFORE, Applicant requests this Application be set for hearing on June 4, 2026, and that after notice and hearing, the Division enter an order:

- A. Pooling all uncommitted interests in the Unit;
- B. Approving the Well in the Unit;
- C. Designating Applicant as operator of the Unit and the Well;
- D. Authorizing Applicant to recover its costs of drilling, equipping and completing the Well;
- E. Approving the actual operating charges and costs of supervision while drilling and after completion, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and
- F. Imposing a 200% penalty for the risk assumed by Applicant in drilling and completing the Well against any working interest owner who does not voluntarily participate in the drilling of the Well.

Application of Coterra Energy Operating Co. for Compulsory Pooling, Lea County, New Mexico. Applicant seeks an order pooling all uncommitted interest within the Bone Spring formation underlying a 1,280-acre, more or less, standard horizontal well spacing unit comprised of the W/2 of Sections 13, 24, 25, and 36, located in Township 19 South, Range 35 East, NMPM, Lea County, New Mexico (the "Unit"). The Unit will be dedicated to the following well (the "Well"): **Sun State Com 221H** well, which will be horizontally drilled from a surface hole location 320' FNL and 1,263' FWL of Section 13, to a bottom hole location 100' FSL and 888' FWL of Section 36, Township 19 South, Range 35 East, NMPM, Lea County, New Mexico. The completed interval of the Well will be orthodox and remain within 330 feet of the adjoining quarter-quarter section tracts, allowing inclusion of these proximity tracts within the proposed Unit under NMAC 19.15.16.15(B)(4). Also, to be considered will be the cost of drilling and completing the Well and the allocation of the cost, the designation of Applicant as the operator of the Well and Unit, and a 200% charge for the risk involved in drilling and completing the Well against any working interest owner who does not voluntarily participate. The Well is located approximately 16 miles west of Hobbs, New Mexico.

**SELF AFFIRMED STATEMENT OF BLAIR NUTTER**

Blair Nutter, being first duly sworn and upon oath, deposes and states as follows:

1. My name is Blair Nutter, and I am a landman with Coterra Energy Operating Co. (“Coterra”). I have worked horizontal development in New Mexico from June 2025 to present. My present responsibilities in the land department include managing all exploration subsurface land matters related to federal, state, and fee minerals for approximately 30,000 gross acres in Lea County. The lands at issue in this application are included within this area. I have been a petroleum landman for 13 years and have earned the Certified Professional Landman certification from the American Association of Professional Landmen. I hold a Master of Science in Energy Legal Studies from Oklahoma City University and prior to beginning my career as a landman, I earned a Bachelor’s Degree in Elementary Education. I believe that my education and work experience qualify me as an expert in oil and gas land matters. A copy of my resume is attached to this self-affirmed statement.

2. I am submitting this self-affirmed statement, being Coterra Exhibit A-2, in support of Coterra’s application in the above-referenced case pursuant to 19.15.14.12(A)(1) NMAC.

3. I am familiar with the application filed by Coterra in this case, and I am familiar with the status of the lands in the subject area. Copies of Coterra’s Application and the Proposed Hearing Notice are attached as Coterra Exhibit A-1.

4. None of the parties to be pooled in this case have indicated opposition to this matter proceeding by affidavit to the Division, and therefore, I do not expect any opposition at the hearing.

5. In this case, Coterra seeks an order pooling all uncommitted interest owners in the Bone Spring formation into following spacing unit:

a. The proposed spacing unit is a 1,280-acre, more or less, standard horizontal spacing unit within the Bone Spring formation, designated as an oil pool. The proposed spacing unit will be comprised of the W/2 of Sections 13, 24, 25, and 36, all located in Township 19 South, Range 35 East, NMPM, Lea County, New Mexico (“Spacing Unit”). The Spacing Unit includes proximity tracts, and the defining well for proximity tract purposes is the Sun State Com 221H (“Well”). The completed interval of the Well will be within 330 feet of the adjoining half-section line separating the W/2 W/2 and E/2 W/2 of Sections, 13, 24, 25 and 36 to allow inclusion of those tracts within the proposed 1,280-acre horizontal spacing unit under NMAC 19.15.16.15B(1)(b).

b. The Spacing Unit will be initially dedicated to the following Well:

i. **Sun State Com 221H** well (API No. Pending), which will be horizontally drilled from a surface hole location 320’ FNL and 1,263’ FWL of Section 13, Township 19 South, Range 35 East, to a bottom hole location 100’ FSL and 888’ FWL of Section 36, Township 19 South, Range 35 East.

6. Coterra Exhibit A-3 contains the form C-102s for the Well. The Oil Conservation Division has placed the Well in the Pearl; Bone Spring, South (Pool Code 49685) and WC-025 G-07 S193513B; Bone Spring (Pool Code 97926). The location of the Well is orthodox and meets the Division’s offset requirements.

7. There are no depth severances in the Formation Interval underlying the subject acreage.

8. Coterra Exhibit A-4 contains a plat outlining the Spacing Unit being pooled in Case No. 26140. This Exhibit also identifies each tract number, tract percentage interest, and state lease number.

9. Coterra Exhibit A-5 provides a Unit Recap depicting ownership totals for the proposed Spacing Unit, including the Spacing Unit percentage interest for the interest owners being pooled and their last known addresses. The uncommitted owners that remain to be pooled in this case are marked in yellow. In compiling these addresses, I conducted a diligent search of the public records in Lea County, New Mexico, where the wells are located, phone directories, internet databases, and performed internet searches to locate the contact information for parties entitled to notification.

10. Coterra provides notice that the proposed Unit partially overlaps 2 existing standard horizontal spacing units depicted on the plat included as Coterra Exhibit A-6. These units are dedicated as follows:

- a. Sun State #502H well (API No. 30-025-51880), a Pearl; Bone Spring, South [49685] well producing from the E/2 SW/4 of Section 24, and the E/2 W/2 of Sections 25 and 36, all located in Township 19 South, Range 35 East, NMPM, Lea County, New Mexico (400 acres). The well was pooled in Case No. 23906 by Order No. R-22989. This overlap affects approximately 400 acres in Sections 24, 25, and 36. I have included a plat of the overlap as Coterra Exhibit A-6. Coterra is the operator of this overlapped horizontal spacing unit.

b. Blue Box Federal Com #505 well (API No. 30-025-52080), a Scharb; Bone Spring [55610], Pearl; Bone Spring [49680], WC-025 G-07 S193513B; Bone Spring [97926] well producing from the W/2 SW/4 of Section 1, the W/2 W/2 of Sections 12 and 13 (400 acres), the E/2 SE/4 of Section 2, and the E/2 E/2 of Sections 11 and 14 (400 acres), all located in Township 19 South, Range 35 East, NMPM, Lea County, New Mexico (800 acres in total). This well was pooled in Case No. 23965 by Order No. R-23031. This overlap affects approximately 160 acres in Section 13. I have included a plat of the overlap as Coterra Exhibit A-6. Coterra is the operator of this overlapped horizontal spacing unit.

11. Coterra sent well proposal letters for the Wells, together with corresponding AFEs, to the uncommitted interest owners in this case. Coterra Exhibit A-7 is a sample of the well proposal letter, along with the AFEs, sent to these uncommitted interest owners. The estimated costs of the Wells set forth in the AFEs are fair, reasonable, and comparable to the costs of other wells of similar depths and lengths drilled in this area of New Mexico.

12. Coterra made good faith diligent efforts to locate all parties that it seeks to pool, notice was provided to all locatable parties, and various of the parties returned delivery receipts; see Coterra Exhibit C-3 and C-4 for proof of mailing. In an effort to notice the unlocatable owners, and out of an abundance of caution for any noticed owners, Coterra caused notice to be published more than ten (10) business days prior to the compulsory pooling hearing in the Hobbs News-Sun in accordance with 19.15.4.12(B) NMAC; Coterra Exhibit C-5 contains a copy of the legal advertisement, as well as the affidavit of publication. I provided the law firm of Holliday Energy Law Group, PC, with the name and addresses for all uncommitted interests.

13. Coterra requests overhead and administrative rates of \$8,000/month for drilling each well and \$800/month for producing each well. These rates are fair and comparable to the rates charged by other operators for wells of this type in this area of New Mexico. Coterra respectfully requests that these administrative and overhead costs be incorporated into any orders entered by the Division in this case.

14. Coterra requests the maximum cost, plus 200% risk charge, be assessed against the non-consenting working interest owners.

15. Coterra requests that it be designated operator of the Unit and Well.

16. Coterra has been able to locate contact information for all interest owners that it seeks to pool and has undertaken good faith efforts to reach an agreement with the locatable uncommitted interest owners. Coterra Exhibit A-8 contains a chronology of the contacts with the interest owners that Coterra seeks to pool. Coterra has made a good faith effort to obtain voluntary joinder of the interest owners in the Well through joint operating agreement and lease.

17. The interest owners being pooled either have been contacted regarding the Well or have been provided notice by publication as set forth above but in either case have failed or refused to voluntarily commit their interest in the Wells. If a mutually agreeable Joint Operating Agreement is reached between Coterra and an interest owner, I will inform the Division that Coterra is no longer seeking to pool that party, and Coterra requests that the voluntary agreement become operative and supersede the Division's order for said parties, except to the extent that the Division deems it necessary to maintain spacing criteria for the purpose of conservation, the prevention of waste, and the protection of correlative rights.

18. Coterra Exhibits A-1 through A-8 were either prepared by me or compiled under my direction and supervision.

19. The granting of this application is in the best interest of conservation, the prevention of waste and the protection of correlative rights, and will avoid the drilling of unnecessary wells.

20. I swear that to the best of my knowledge and belief, all of the matters set forth herein and in the exhibits are true, correct, and accurate.

**SELF-AFFIRMED DECLARATION OF STACI FREY**

Staci Frey hereby states and declares as follows:

1. I am over the age of 18, I am a geologist for Coterra Energy Operating Co. (“Coterra”) and have personal knowledge of the matters stated herein.

2. I have previously testified before the Oil Conservation Division (“Division”) and my credentials as an expert in petroleum geology have been accepted as a matter of record.

3. My area of responsibility at Coterra includes the area of Lea County in New Mexico.

4. I am familiar with the applications Coterra filed in Case No. 26140.

5. I conducted a geological study of the Bone Spring formation underlying Coterra’s Sun Development Area.

6. **Exhibit B.2** is a locator map showing the approximate location of the Sun Development Area, identified by a black/yellow box. This locator map also includes an outline of Coterra’s 3-D seismic covering the Sun Development Area, which will aid in geosteering.

7. **Exhibit B.3** is an excerpt from Snee & Zoback, 2018, identifying the horizontal stress orientation in this area. The preferred well orientation in this area is North South due to the  $S_{Hmax}$  direction.

8. **Exhibit B.4** is a gun barrel diagram showing Coterra’s Sun development plan. The eastern two wells (223H and 224H), shown as blue circles, will be straight 4 mile wells, while the western well (221H) is a slant well. The three wells will target the Second Bone Spring Sand.

9. **Exhibit B.5** shows both a structure map and isopach map of the Second Bone Spring. The Sun Development Area is identified by a red box and the approximate location of the Sun wells are each identified by bold black lines. The contour interval of the structure map is 100 feet, and the contour interval of the isopach map is 50 feet. The structure map shows that the structure dips to the south and the thickness of the Second Bone Spring Sand ranges from approximately 300 – 388 feet.

10. **Exhibit B.6** is a structural cross section across the Sun Development Area. The well logs on the cross-section give a representative sample of the Second Bone Spring formation in the area. The target zone is identified by yellow shading. Exhibit B.6 also contains an inset map that identifies five wells in the vicinity of the proposed wells, which I used for the cross-section, shown by a line of cross-section running from A to A'.

11. Based on the cross section, I conclude that the Second Bone Spring is present and porous in the Sun Development Area.

12. I conclude from the maps that:

- a. The horizontal spacing units are justified from a geologic standpoint.
- b. There are no structural impediments or faulting that will interfere with horizontal development.
- c. Each quarter quarter section in the proposed unit will contribute more or less equally to production.

13. In my opinion, the granting of Coterra's applications are in the interests of conservation and the prevention of waste.

14. The attachments to my declaration were prepared by me or compiled under my direction or supervision.

15. Pursuant to Rule 1-011 NMRA, I declare and affirm under penalty of perjury under the laws of the State of New Mexico that the foregoing statements are true and correct to the best of my knowledge and belief.

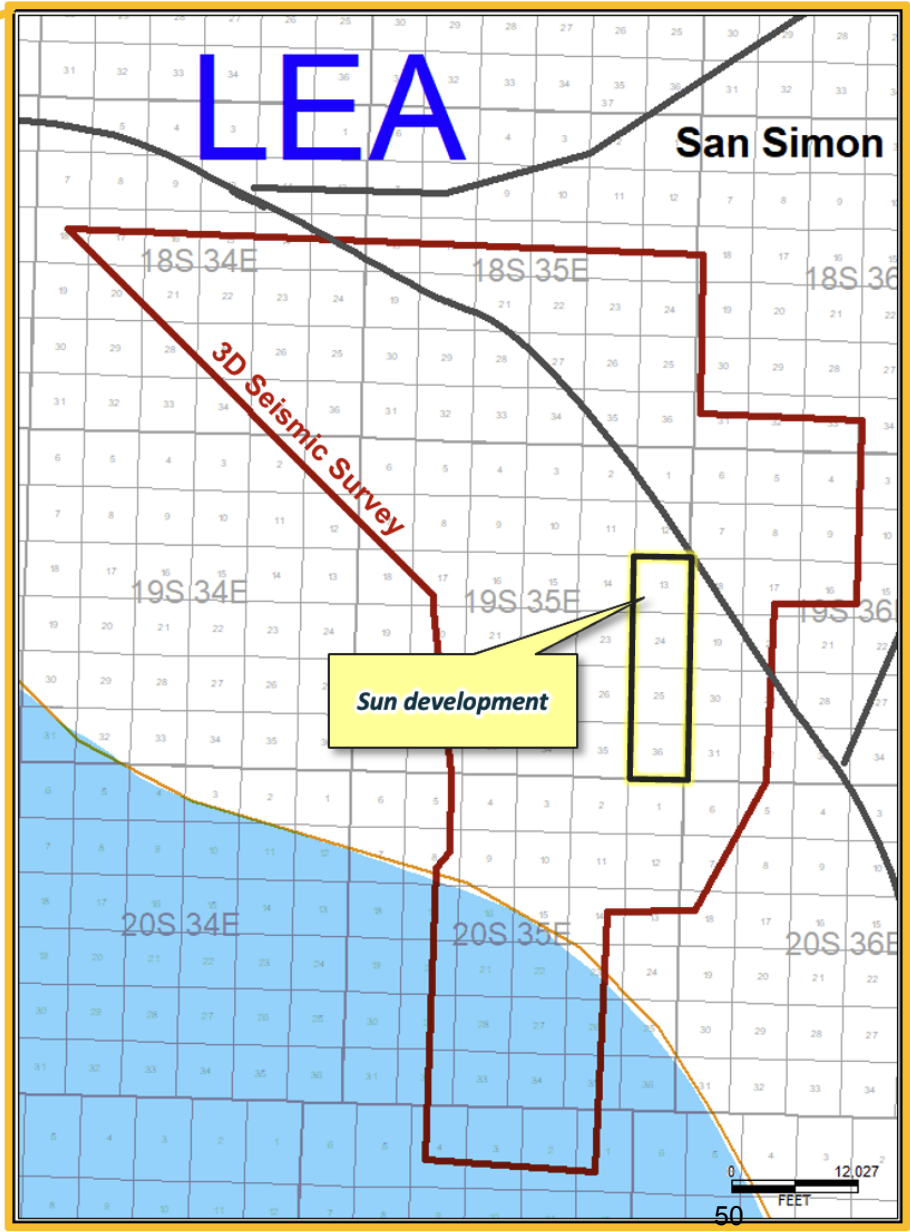

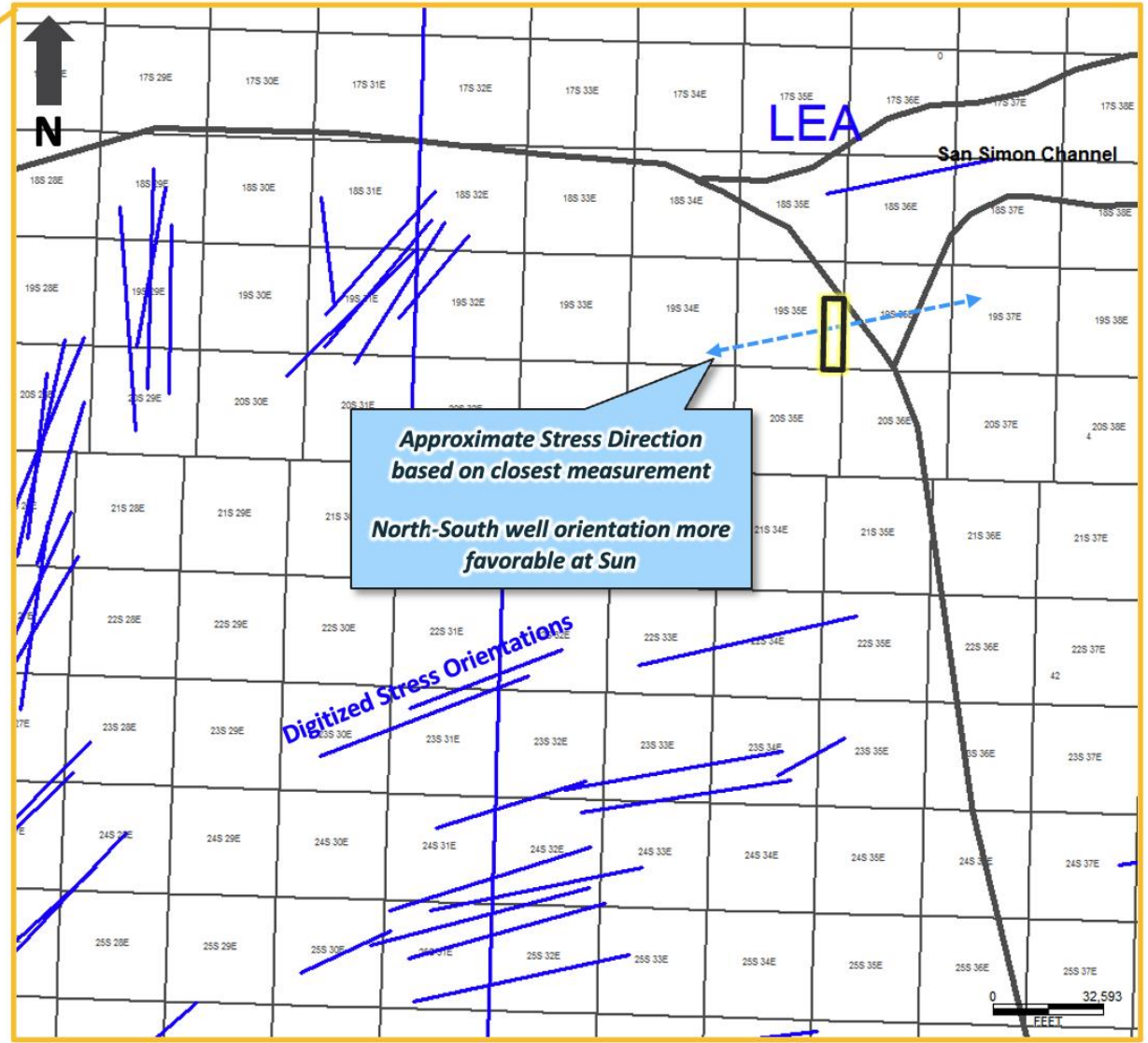

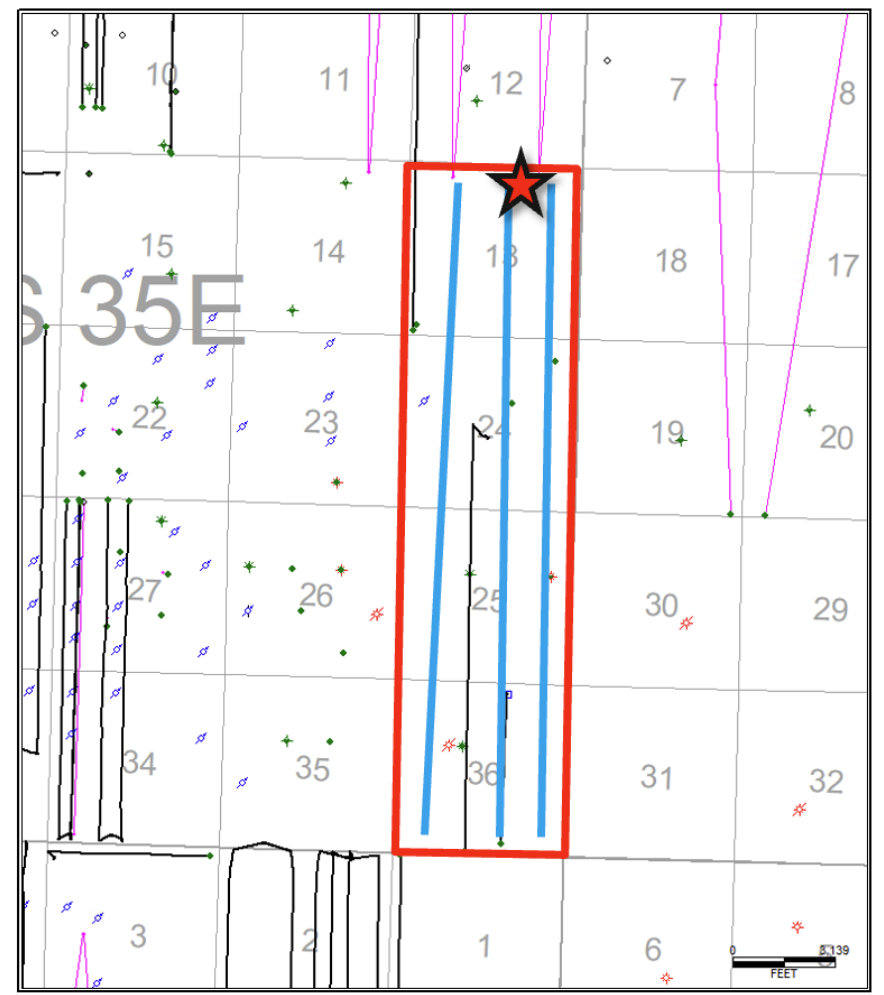
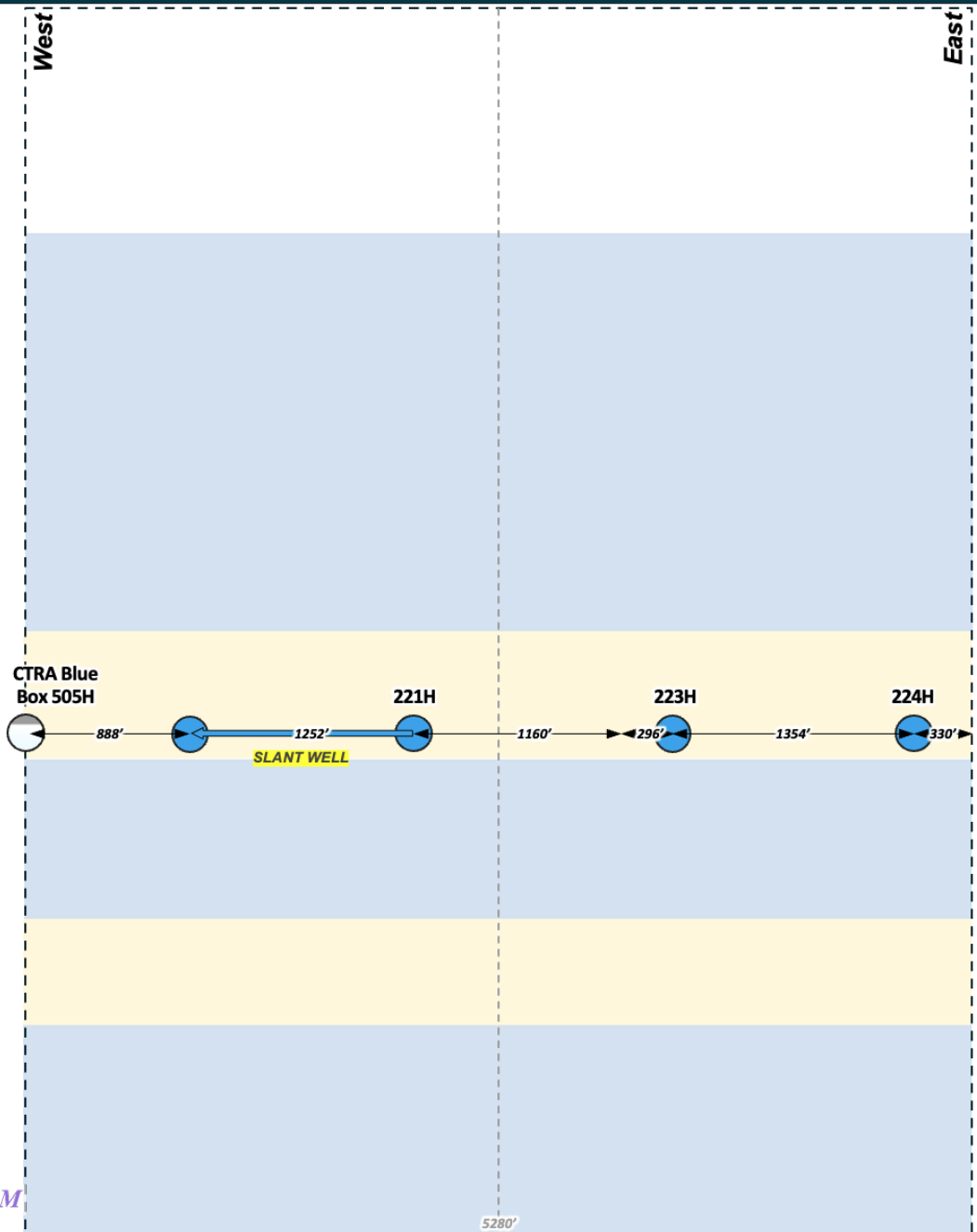
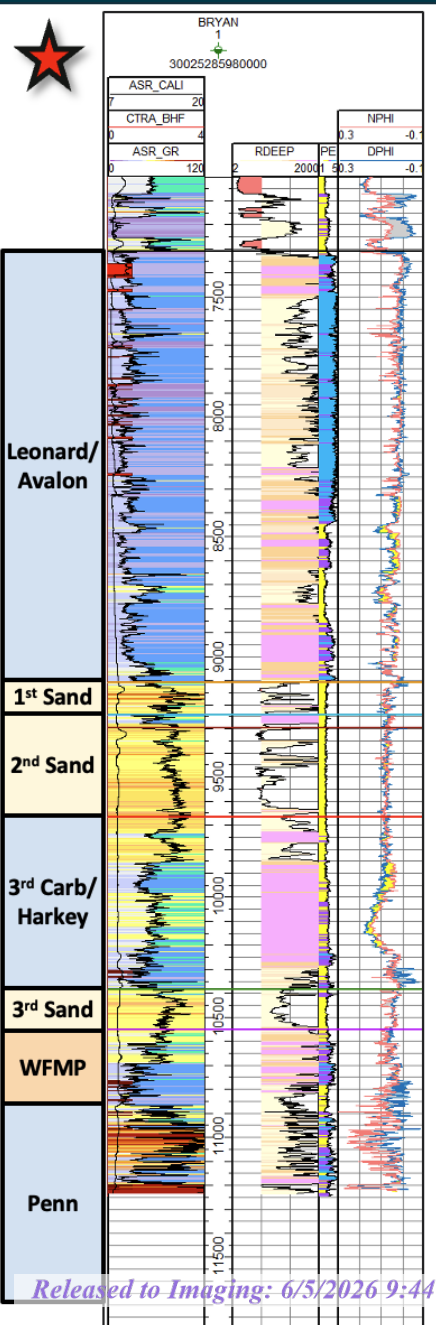
# Stress Direction Map

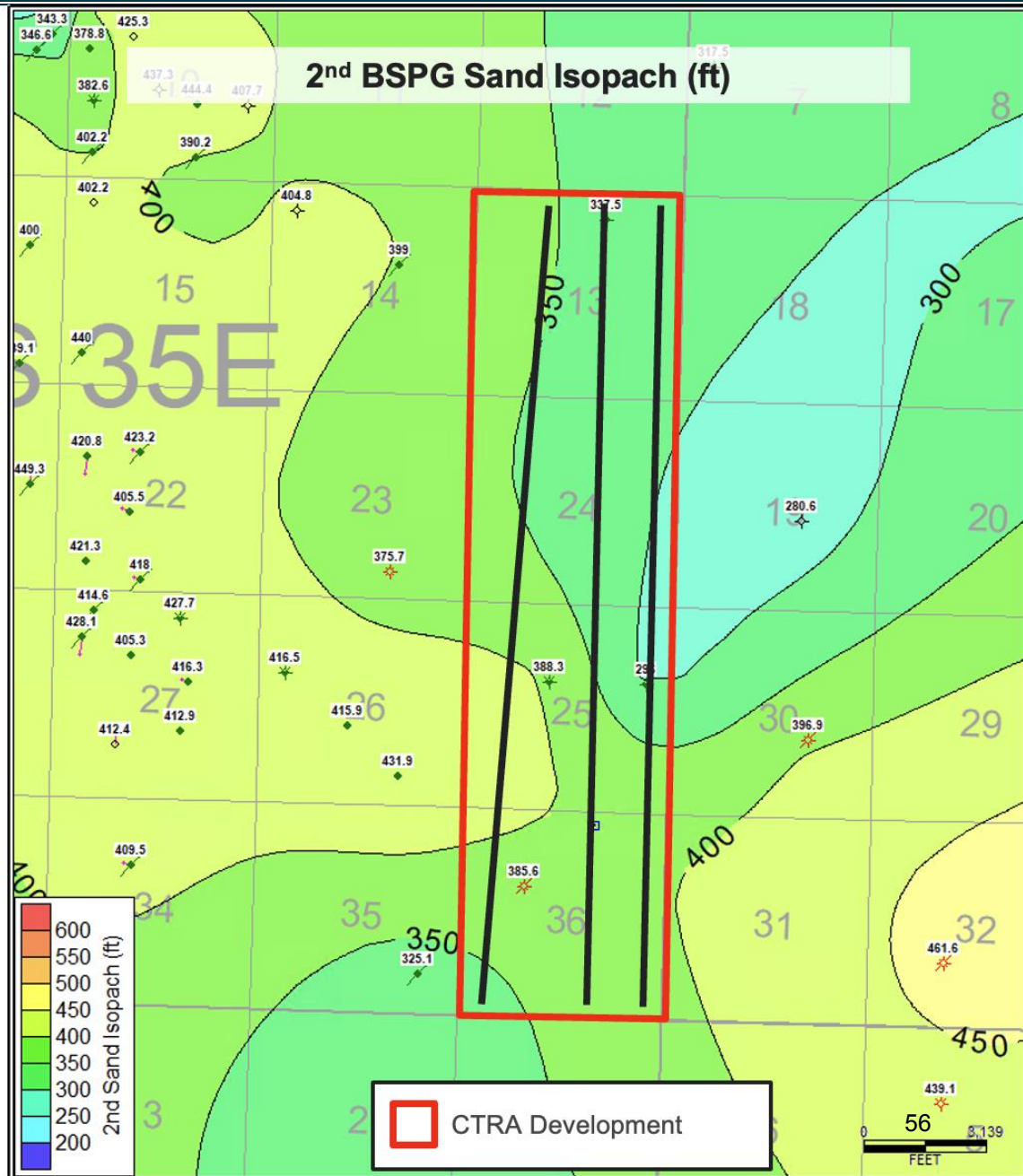

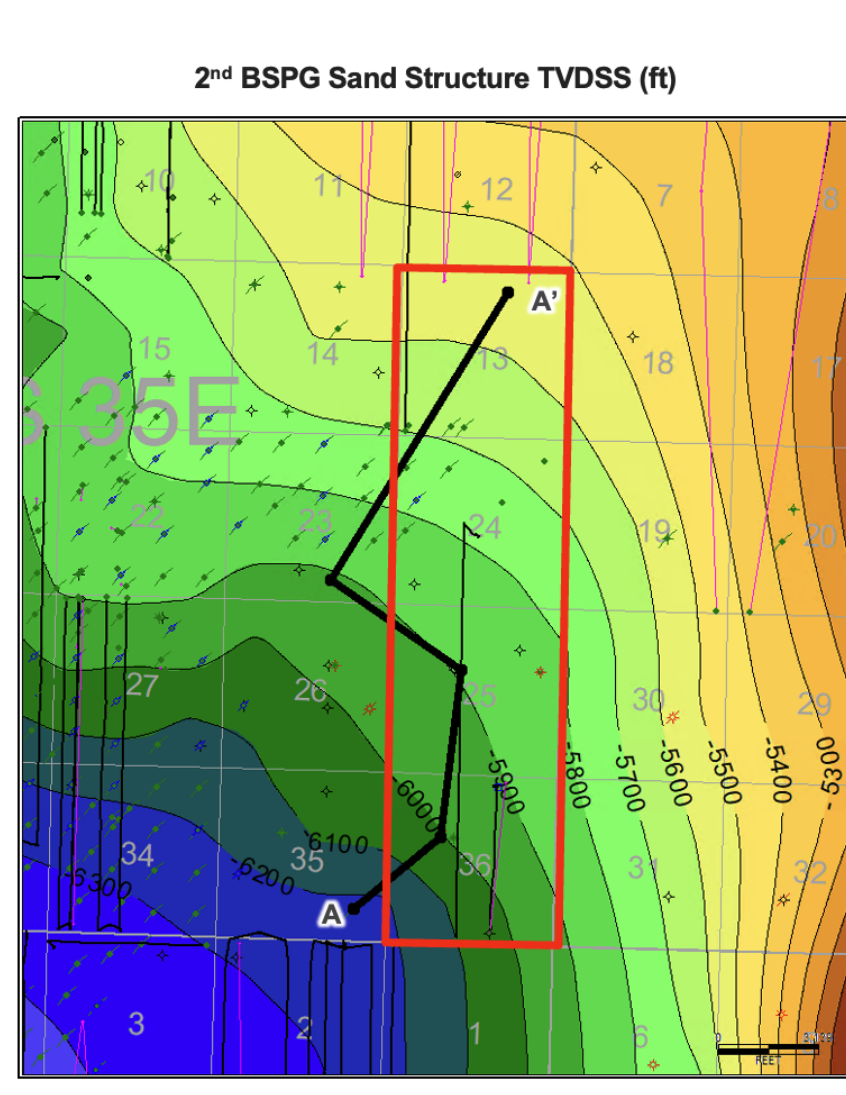
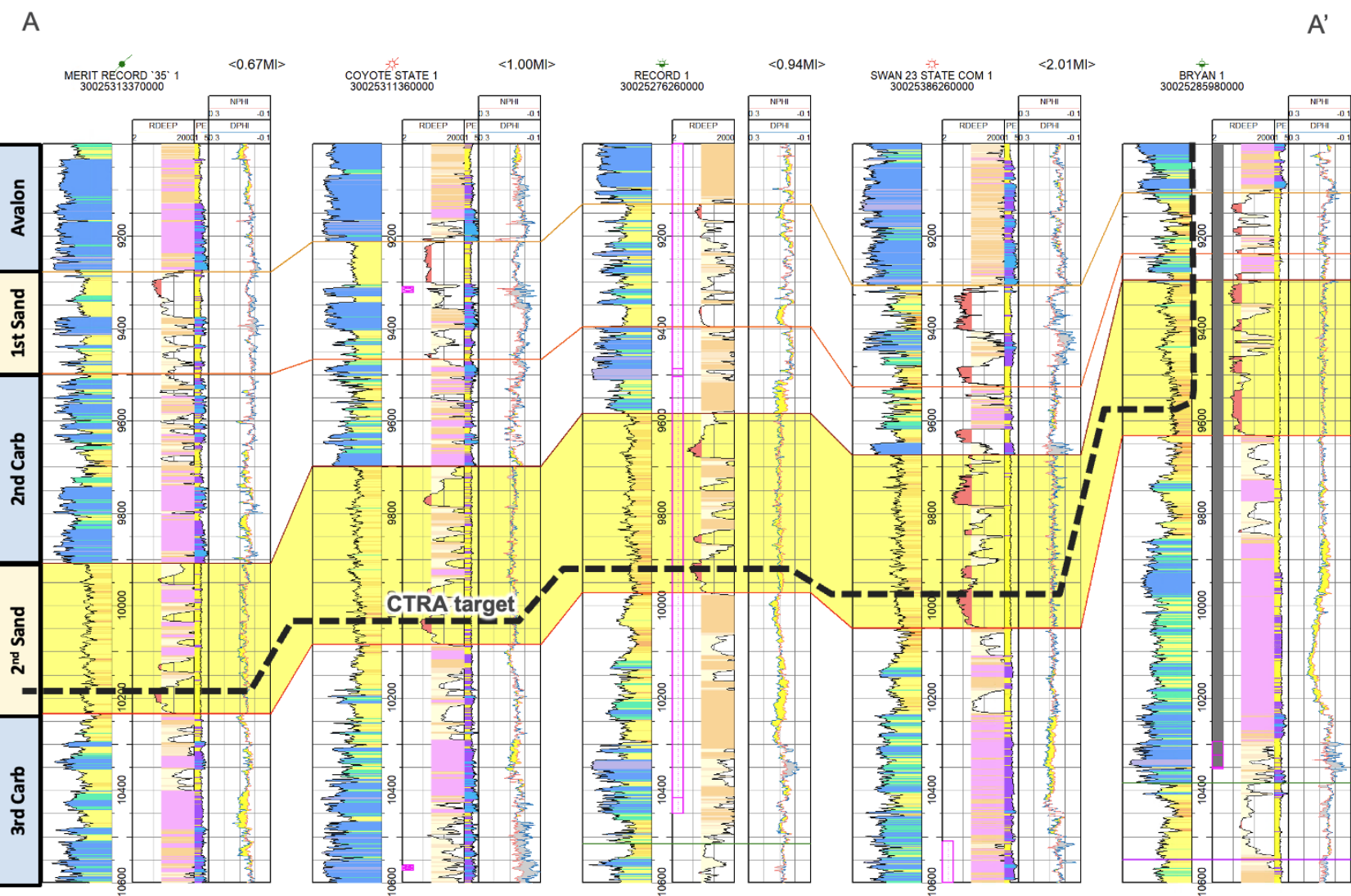
# Gun Barrel Diagram

The Application seeks to dedicate the Unit to the following well:

**Sun State Com 221H** (API No. PENDING), an oil well, with a surface hole location in the NW/4 NW/4 of Section 13, Township 19 South, Range 35 East, and a bottom hole location at approximately 100’ FSL & 888’ FWL of the SW/4 SW/4 of Section 36, Township 19 South, Range 35 East (the “Well”).

Pursuant to NMSA § 70-2-17, Coterra Energy Operating Co. (“Applicant”) (OGRID No. 215099), through its undersigned attorney, hereby files this Application with the Oil Conservation Division of the State of New Mexico (“Division”) for an order (1) creating a 1,280-acre, more or less, standard horizontal well spacing unit comprised of the W/2 of Sections 13, 24, 25, and 36, all located in Township 19 South, Range 35 East, NMPM, Lea County, New Mexico (“Unit”), and (2) pooling all uncommitted interest within the Bone Spring formation underlying said Unit. In support of its Application, Applicant states the following:

1. Applicant is a working interest owner in the Unit and has the right to drill thereon.
2. Applicant seeks to dedicate the above-referenced Unit to the following well, referred to herein as the Well:
  - a. **Sun State Com 221H** well (API No. Pending), which will be horizontally drilled from a surface hole location 320’ FNL and 1,263’ FWL of Section 13, Township 19 South, Range 35 East, to a bottom hole location 100’ FSL and 888’ FWL of Section 36, Township 19 South, Range 35 East.
3. Applicant provides notice that the proposed Unit partially overlaps 2 existing standard horizontal spacing units dedicated as follows:
  - a. Sun State Com #502H well (API No. 30-025-51880), a Pearl; Bone Spring, South [49685] well producing from the E/2 SW/4 of Section 24, and the E/2 W/2 of Sections 25 and 36, all located in Township 19 South, Range 35 East, NMPM, Lea County, New Mexico (400 acres). This well was pooled in Case No. 23906 by Order No. R-22989. This overlap affects approximately 400 acres in Sections 24, 25, and 36.
  - b.
