This cause came on for hearing at 9:00 a.m. on July 26, 1972, at Santa Fe, New Mexico, before Examiner Daniel S. Nutter.

NOW, on this 27th day of July, 1972, the Commission, a quorum being present, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for the creation of a new gas pool in Lea County, New Mexico, for the production of gas from the Fusselman formation, said pool to bear the designation of Crosby-Fusselman Gas Pool. Said Crosby-Fusselman Gas Pool was discovered by the Union Texas Petroleum Corporation Crosby Deep Well No. 1, located in Unit N of Section 28, Township 25 South, Range 37 East, NMPM. THE APPLICATION OF THE OIL CONSERVATION COMMISSION UPON ITS OWN MOTION FOR AN ORDER CREATING AND EXTENDING CERTAIN POOLS IN CHAVES, LEA, AND BOOSEVELT COUNTIES, NEW MEXICO.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9:00 a.m. on July 26, 1972, at Santa Fe, New Mexico, before Examiner Daniel S. Nutter.

NOW, on this day of July, 1972, the Commission, a quorum being present, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for the creation of a new gas pool in Lea County, New Mexico, for the production of gas from the Fusselman formation, said pool to bear the designation of Crosby-Fusselman Gas Pool. Said Crosby-Fusselman Gas Pool was discovered by the Union Texas Petroleum Corporation Crosby Deep Well No. 1, located in Unit N of Section 28, Township 25 South, Range 37 East, NMPM. It was completed in the Fusselman formation on March 10, 1972. The top of the perforations is at 8810 feet.

(3) That there is need for the creation of a new gas pool in Lea County, New Mexico, for the production of gas from the San Andres formation, said pool to bear the designation of North Eunice-San Andres Gas Pool. Said North Eunice-San Andres Gas Pool was discovered by the Sohio Petroleum Company Alves "A" Well No. 2, located in Unit M of Section 8, Township 21 South, Range 37 East, NMPM. It was completed in the San Andres formation on April 7, 1972. The top of the perforations is at 4096 feet.

(4) That there is need for the creation of a new gas pool in Roosevelt County, New Mexico, for the production of gas from the Cisco formation, said pool to bear the designation of Tanneyhill-Pennsylvanian Gas Pool. Said Tanneyhill-Pennsylvanian Gas Pool was discovered by the Ted Weiner Federal "14" Well No. 1, located in Unit K of Section 14, Township 6 South, Range 33 East, NMPM. It was completed in the Cisco formation on November 6, 1971. The top of the perforations is at 7602 feet.

(5) That there is need for certain extensions to the Many Gates-Abo Pool in Chaves County, New Mexico, the Blinebry'Gas Pool, the Blinebry'Oil Pool, the Dollarhide-Devonian Pool, the Drinkard Pool, the South Eunice-San Andres Pool, the Justig-Tubb-Drinkard Pool, the Townsend-Morrow Gas Pool, the North Vacuum-Abo Pool, the North Vacuum-Morrow Gas Pool, and the Wantz-Abo Pool, all in Lea County, New Mexico.

IT IS THEREFORE ORDERED:

(a) That a new pool in Lea County, New Mexico, classified as a gas pool for Fusselman production, is hereby created and designated as the Crosby-Fusselman Gas Pool, consisting of the following described area:

IT IS FURTHER ORDERED:

(1) That, pursuant to Section 65-3-14.5, NMSA 1953, contained in Chapter 271, Laws of 1969, any well which, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to dile new Forms C-102 dedicating a standard unit for the pool to said well, or to obtain a nonstandard unit approved by the Commission. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Forms C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Commission within said 60-day period shall subject the well to cancellation of allowable.

(2) That the effective date of this order and all creations and extensions included herein shall be August 1, 1972.
