MR. PEARCE: That is the application of Morris R. Antweil for a compulsory pooling, Lea County, New Mexico.

MR. CARR: May it please the Examiner, my name is William F. Carr, with the law firm Campbell, Byrd, and Black, P. A., Santa Fe, appearing on behalf of the applicant.

At this time I would request that this case be consolidated with the next case on the docket, which is a compulsory pooling application filed on behalf of Mr. Antweil. They involve adjoining tracts. The ownership is identical under both of the tracts. The testimony will be virtually identical and it will facilitate an unnecessary hearing if the cases are consolidated.

Williams, you said that you wished to pool to the base of the Drinkard and I see that the application in the docket says to the top of the Drinkard.

Is the docket erroneous?

A. Apparently, if that's what it says.

MR. CARR: It's an error in the application, as well. The application, Mr. Stamets, also refers to the top of the Drinkard, so I assume that there is an error that carries through, as well as the docket, also the legal application.

MR. STAMETS: Okay, in that event it will be necessary to readvertise these two cases.

MR. CARR: With your permission we would like to proceed with the hearing today and then have this readvertised for the earliest possible hearing that we can get this matter correctly advertised.

MR. STAMETS: I assume you will speak to Ms. Davidson after the hearing and get that taken care of.

MR. CARR: We will.

Q Mr. Williams, will you now refer to Exhibit
Number One and review this for Mr. Stamets?

A Exhibit Number One is a land map in the area of the requested compulsory pooling. The two 40-acre tracts on which pooling is sought are designated in yellow

and outlined in red. The other wells in the vicinity of these 40-acre tracts have been designated on the map. The other wells in the eastern portion of Section 5 are Blinebry and Drinkard completions. The well immediately east of the 40-acre tract designated to the Nuey No. 2 Well is currently drilling, approximately 5200 feet.

Q. Do both of the proposed -- are both of the proposed wells to be drilled at orthodox locations?

A. Yes, they will.

Q Would you now refer to what has been marked for identification as Antweil Exhibit Number Two and review this for Mr. Stamets?

A. Exhibit Number Two tabulates the unleased mineral interests in each of these 40-acre tracts and shows the amount of acreage that each of these mineral owners holds. There are five mineral owners. The addresses are given except for Donald Woods, whose address is unknown.

I might point out that these same parties have previously been force pooled in conjunction with four other 40-acre tracts for other wells: The Dewey No. 1 Well, the Dewey No. 2 Well, the Huey No. 1 Well, and the Huey No. 2 Well, shown on the Exhibit One.

In the case of the last well a forced pooling order was entered for the Huey No. 2 Well and when the

And all other interests other than those set out on Exhibit Two have voluntarily been committed to the well.

A. That is correct.

Q Would you now refer to Exhibit Number Three, identify this and review the information contained thereon?

A. Exhibit Number Three is our AFE cost estimate for the proposed drilling of a 7150 foot Blinebry-Drinkard test. The total cost of a completed well is currently estimated at \$510,000. I might mention, this is approximately \$50,000 less than our AFE's on the previous forced poolings.

The cost of ("silling is coming down some.

Q And these costs are in line with what other operators in the area are charging for similar wells?

A. That's correct.

Q. Will you now refer to what has been marked Antweil Exhibit Number Four, and using this exhibit review

for Mr. Stamets the efforts you've made to obtain voluntary joinder in the well.

fied mail letter, of March 19th to the unleased mineral interest owners, notifying them of the -- our application for a hearing on this date. We in this letter again invited them to consider leasing their mineral interest, pointing out that they would have the opportunity to join in the well as a working interest owner. This, as I pointed out, has been the fifth time that they've been notified in this manner and then notified of the forced pooling order in the four previous cases and for approximately a year prior to that through an independent landman, Dick Pollard, we sought to lease these interests, and it's mainly a situation of no response, to any ef-

fort to contact them.

The reply from Ms. Rule on this last well was really the first reply of any kind we've had from them.

Q Will you now identify Exhibit Number Five for the Examiner?

A. Exhibit Number Five is a set of letters of April 6th, '82, from our attorney to each of the unleased mineral interest owners, furnishing them a copy of the docket of this hearing. So they have been notified.

Q Mr. Williams, are you prepared to make a

recommendation to the Examiner as to the risk penalty that should be assessed against the nonconsenting mineral interest owners?

A Yes. We would request a risk penalty of 200 percent be imposed. This is the risk penalty that's been imposed under previous compulsory pooling hearings and we are continuing to move towards the edge of this -- of this field. The risk is at least as great.

Do you believe there is a chance that you might get a Drinkard well that would not be commercial at the proposed location?

A. The test of the Drinkard in the No. 1 Huey Well resulted in high water cuts and that well was completed in the Blinebry successfully, but the Drinkard, because of the amount of water production, was -- was not economical.

Q Is it fair to say that the quality of the Drinkard throughout this area varies substantially from well to well?

A. The Drinkard production characteristics vary considerably from well to well, changing from a commercial oil well to very high gas/oil ratio oil well, to water production.

The Blinebry production is -- has been fairly consistent in this area.

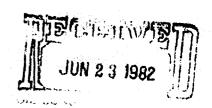

#### ORDER OF THE DIVISION

#### BY THE DIVISION:

This cause came on for hearing at 9 a.m. on May 26, 1982, at Santa Fe, New Mexico, before Examiner Daniel S. Nutter.

NOW, on this <a href="lith">11th</a> day of June, 1982, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

#### FINDS:

- (1) That due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, Morris R. Antweil, seeks an order pooling all mineral interests from the surface to the base of the Drinkard formation underlying the NW/4 SW/4 of Section 5, Township 20 South, Range 38 East, NMPM, Lea County, New Mexico.
- (3) That the applicant has the right to drill and proposes to drill a well at a standard location thereon.
- (4) That there are interest owners in the proposed proration unit who have not agreed to pool their interests.
- (5) That to avoid the drilling of unnecessary wells, to protect correlative rights, and to afford to the owner of each interest in said unit the opportunity to recover or receive without unnecessary expense his just and fair share of the oil and gas in said pool, the subject application should be approved by pooling all mineral interests, whatever they may be, within said unit.

- (6) That the applicant should be designated the operator of the subject well and unit.
- (7) That any non-consenting working interest owner should be afforded the opportunity to pay his share of estimated well costs to the operator in lieu of paying his share of reasonable well costs out of production.
- (8) That any non-consenting working interest owner who does not pay his share of estimated well costs should have withheld from production his share of the reasonable well costs plus an additional 200 percent thereof as a reasonable charge for the risk involved in the drilling of the well.
- (9) That any non-consenting interest owner should be afforded the opportunity to object to the actual well costs but that actual well costs should be adopted as the reasonable well costs in the absence of such objection.
- (10) That following determination of reasonable well costs, any non-consenting working interest owner who has paid his share of estimated costs should pay to the operator any amount that reasonable well costs exceed estimated well costs and should receive from the operator any amount that paid estimated well costs exceed reasonable well costs.
- (11) That \$3000.00 per month while drilling and \$300.00 per month while producing should be fixed as reasonable charges for supervision (combined fixed rates); that the operator should be authorized to withhold from production the proportionate share of such supervision charges attributable to each non-consenting working interest, and in addition thereto, the operator should be authorized to withhold from production the proportionate share of actual expenditures required for operating the subject well, not in excess of what are reasonable, attributable to each non-consenting working interest.
- (12) That all proceeds from production from the subject well which are not disbursed for any reason should be placed in escrow to be paid to the true owner thereof upon demand and proof of ownership.
- (13) That upon the failure of the operator of said pooled unit to commence drilling of the well to which said unit is dedicated on or before September 1, 1982, the order pooling said unit should become null and void and of no effect whatsoever.

#### IT IS THEREFORE ORDERED:

(1) That all mineral interests, whatever they may be, from the surface to the base of the Drinkard formation underlying the NW/4 SW/4 of Section 5, Township 20 South, Range 38 East, NMPM, Lea County, New Mexico, are hereby pooled to form a standard 40-acre oil spacing and proration unit to be dedicated to a well to be drilled at a standard location thereon.

PROVIDED HOWEVER, that the operator of said unit shall commence the drilling of said well on or before the 1st day of September, 1982, and shall thereafter continue the drilling of said well with due diligence to a depth sufficient to test the Drinkard formation;

PROVIDED FURTHER, that in the event said operator does not commence the drilling of said well on or before the 1st day of September, 1982, Order (1) of this order shall be null and void and of no effect whatsoever, unless said operator obtains a time extension from the Division for good cause shown.

PROVIDED FURTHER, that should said well not be drilled to completion, or abandonment, within 120 days after commencement thereof, said operator shall appear before the Division Director and show cause why Order (1) of this order should not be rescinded.

- (2) That Morris R. Antweil is hereby designated the operator of the subject well and unit.
- (3) That after the effective date of this order and within 90 days prior to commencing said well, the operator shall furnish the Division and each known working interest owner in the subject unit an itemized schedule of estimated well costs.
- (4) That within 30 days from the date the schedule of estimated well costs is furnished to him, any non-consenting working interest owner shall have the right to pay his share of estimated well costs to the operator in lieu of paying his share of reasonable well costs out of production, and that any such owner who pays his share of estimated well costs as provided above shall remain liable for operating costs but shall not be liable for risk charges.
- (5) That the operator shall furnish the Division and each known working interest owner an itemized schedule of actual well costs within 90 days following completion of the well; that if no objection to the actual well costs is received by the Division and the Division has not objected within 45 days following receipt of said schedule, the actual well costs shall

be the reasonable well costs; provided however, that if there is an objection to actual well costs within said 45-day period the Division will determine reasonable well costs after public notice and hearing.

- (6) That within 60 days following determination of reasonable well costs, any non-consenting working interest owner who has paid his share of estimated costs in advance as provided above shall pay to the operator his pro rata share of the amount that reasonable well costs exceed estimated well costs and shall receive from the operator his pro rata share of the amount that estimated well costs exceed reasonable well costs.
- (7) That the operator is hereby authorized to withhold the following costs and charges from production:
  - (A) The pro rata share of reasonable well costs attributable to each non-consenting working interest owner who has not paid his share of estimated well costs within 30 days from the date the schedule of estimated well costs is furnished to him.
  - (B) As a charge for the risk involved in the drilling of the well, 200 percent of the pro rata share of reasonable well costs attributable to each non-consenting working interest owner who has not paid his share of estimated well costs within 30 days from the date the schedule of estimated well costs is furnished to him.
- (8) That the operator shall distribute said costs and charges withheld from production to the parties who advanced the well costs.
- (9) That \$3000.00 per month while drilling and \$300.00 per month while producing are hereby fixed as reasonable charges for supervision (combined fixed rates); that the operator is hereby authorized to withhold from production the proportionate share of such supervision charges attributable to each non-consenting working interest, and in addition thereto, the operator is hereby authorized to withhold from production the proportionate share of actual expenditures required for operating such well, not in excess of what are reasonable, attributable to each non-consenting working interest.
- (10) That any unsevered mineral interest shall be considered a seven-eighths (7/8) working interest and a

one-eighth (1/8) royalty interest for the purpose of allocating costs and charges under the terms of this order.

- (11) That any well costs or charges which are to be paid out of production shall be withheld only from the working interest's share of production, and no costs or charges shall be withheld from production attributable to royalty interests.
- (12) That all proceeds from production from the subject well which are not disbursed for any reason shall immediately be placed in escrow in Lea County, New Mexico, to be paid to the true owner thereof upon demand and proof of ownership; that the operator shall notify the Division of the name and address of said escrow agent within 30 days from the date of first deposit with said escrow agent.
- (13) That jurisdiction of this cause is retained for the entry of such further orders as the Division may deem necessary.

# ORDER OF THE DIVISION

## BY THE DIVISION:

This cause came on for hearing at 9 a.m. on May 26, 1982, at Santa Fe, New Mexico, before Examiner Daniel S. Nutter.

NOW, on this \_\_\_\_\_ day of June, 1982, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, Morris R. Antweil, seeks an order pooling all mineral interests from the surface to the base of the Drinkard formation underlying the NW/4 SW/4 of Section 5, Township 20 South, Range 38 East, NMPM, Lea County, New Mexico.
- (3) That the applicant has the right to drill and proposes to drill a well at a standard location thereon.
- (4) That there are interest owners in the proposed proration unit who have not agreed to pool their interests.
- (5) That to avoid the drilling of unnecessary wells, to protect correlative rights, and to afford to the owner of each interest in said unit the opportunity to recover or receive without unnecessary expense his just and fair share of the gas in said pool, the subject application should be approved by pooling all mineral interests, whatever they may be, within said unit.
- (6) That the applicant should be designated the operator of the subject well and unit.
- (7) That any non-consenting working interest owner should be afforded the opportunity to pay his share of estimated well costs to the operator in lieu of paying his share of reasonable well costs out of production.

- (8) That any non-consenting working interest owner who does not pay his share of estimated well costs should have withheld from production his share of the reasonable well costs plus an additional 200 percent thereof as a reasonable charge for the risk involved in the drilling of the well.
- (9) That any non-consenting interest owner should be afforded the opportunity to object to the actual well costs but that actual well costs should be adopted as the reasonable well costs in the absence of such objection.
- (10) That following determination of reasonable well costs, any non-consenting working interest owner who has paid his share of estimated costs should pay to the operator any amount that reasonable well costs exceed estimated well costs and should receive from the operator any amount that paid estimated well costs exceed reasonable well costs.
- per month while drilling and per month while drilling and per month while producing should be fixed as reasonable charges for supervision (combined fixed rates); that the operator should be authorized to withhold from production the proportionate share of such supervision charges attributable to each non-consenting working interest, and in addition thereto, the operator should be authorized to withhold from production the proportionate share of actual expenditures required for operating the subject well, not in excess of what are reasonable, attributable to each non-consenting working interest.

- (12) That all proceeds from production from the subject well which are not disbursed for any reason should be placed in escrow to be paid to the true owner thereof upon demand and proof of ownership.

# IT IS THEREFORE ORDERED:

PROVIDED HOWEVER, that the operator of said unit shall commence the drilling of said well on or before the \_\_\_\_\_\_\_\_\_\_, 1982, and shall thereafter continue the drilling of said well with due diligence to a depth sufficient to test the Drinkard formation;

commence the drilling of said well on or before the \_\_\_\_\_\_\_\_, 1982, Order (1) of this order shall be null and void and of no effect whatsoever, unless said

operator obtains a time extension from the Division for good cause shown.

PROVIDED FURTHER, that should said well not be drilled to completion, or abandonment, within 120 days after commencement thereof, said operator shall appear before the Division Director and show cause why Order (1) of this order should not be rescinded.

- (2) That Morris R. Antweil is hereby designated the operator of the subject well and unit.
  - (3) That after the effective date of this order and within 90 days prior to commencing said well, the operator shall furnish the Division and each known working interest owner in the subject unit an itemized schedule of estimated well costs.
- estimated well costs is furnished to him, any non-consenting working interest owner shall have the right to pay his share of estimated well costs to the operator in lieu of paying his share of reasonable well costs out of production, and that any such owner who pays his share of estimated well costs as provided above shall remain liable for operating costs but shall not be liable for risk charges.
- (5) That the operator shall furnish the Division and each known working interest owner an itemized schedule of actual well costs within 90 days following completion of the well; that if no objection to the actual well costs is received by the Division and the Division has not objected within 45 days following receipt of said schedule, the actual well costs shall

be the reasonable well costs; provided however, that if there is an objection to actual well costs within said 45-day period the Division will determine reasonable well costs after public notice and hearing.

- (6) That within 60 days following determination of reasonable well costs, any non-consenting working interest owner who has paid his share of estimated costs in advance as provided above shall pay to the operator his pro rata share of the amount that reasonable well costs exceed estimated well costs and shall receive from the operator his pro rata share of the amount that estimated well costs exceed reasonable well costs.
- (7) That the operator is hereby authorized to withhold the following costs and charges from production:
  - (A) The pro rata share of reasonable well costs attributable to each non-consenting working interest owner who has not paid his share of estimated well costs within 30 days from the date the schedule of estimated well costs is furnished to him.
  - As a charge for the risk involved in the (B) drilling of the well, 200 rata ofpercent of the pro share reasonable well costs attributable to each non-consenting working interest owner who has not paid his share of estimated well costs within 30 days from the date the schedule of estimated well costs is furnished to him.
- (8) That the operator shall distribute said costs and charges withheld from production to the parties who advanced the well costs.
- per month while drilling and \$ 300 per month while producing are hereby fixed as reasonable charges for supervision (combined fixed rates); that the operator is hereby authorized to withhold from production the proportionate share of such supervision charges attributable to each non-consenting working interest, and in addition thereto, the operator is hereby authorized to withhold from production the proportionate share of actual expenditures required for operating such well, not in excess of what are reasonable, attributable to each non-consenting working interest.

- (10) That any unsevered mineral interest shall be considered a seven-eighths (7/8) working interest and a one-eighth (1/8) royalty interest for the purpose of allocating costs and charges under the terms of this order.
- (11) That any well costs or charges which are to be paid out of production shall be withheld only from the working interest's share of production, and no costs or charges shall be withheld from production attributable to royalty interests.
- (12) That all proceeds from production from the subject well which are not disbursed for any reason shall immediately be placed in escrow in Lea County, New Mexico, to be paid to the true owner thereof upon demand and proof of ownership; that the operator shall notify the Division of the name and address of said escrow agent within 30 days from the date of first deposit with said escrow agent.
- (13) That jurisdiction of this cause is retained for the entry of such further orders as the Division may deem necessary.
