The water will be accumulated in a water tank, 8 a two-hundred-and-ten barrel water tank. From this tank the 9 water will be disposed of into the appropriate disposal wells. 10 Any earned sulfide or trash from the five-hundred 11 barrel accumulator or from the heater-treater will be dumped 12 into a lined pit for further disposal. 13 Q.
