MR. PORTER: The next case will be Case No. 1423.

MR. PAYNE: Case 1423. Northwestern New Mexico nomenclature case calling for an order for the creation of new pools and the extension of existing pools in San Juan and Rio Arriba Counties, New Mexico.

(Witness sworn.)

A. R. HENDRICKS

called as a witness, having been first duly sworn, testified as follows:

DIRECT EXAMINATION

BY: MR. COOLEY:

Q Will the witness please state his name and position?

A A. R. Hendricks, engineer with the Oil Conservation Commission.

Q Mr. Hendricks, have you had an opportunity to make a study of the nomenclature regarding the extension of existing pools in San Juan and Rio Arriba Counties, New Mexico, and the creation of new pools in those counties?

A I have.

MR. COOLEY: Does the Commission accept the qualifications of this witness?

MR. PORTER: His qualifications are acceptable.

Q Mr. Hendricks, have you made a study for the creation of a new gas pool for Gallup production in Township 28 North, Range

A I have.

C What are your recommendations?

A I recommend this pool be created as advertised based on the Weaver-Brown No. 1 McAdams Well, which was completed in the Gallup formation for initial potential of 9010 cubic feet.

C What do you recommend as the vertical limits of the proposed Angel's Peak Gallup Gas Pool, Mr. Hendricks?

A The Gallup formation.

C Have you likewise made a study for the creation of a new oil pool for Gallup production in Township 24 North, Range 7 West?

A I have.

C What are your recommendations in that regard?

A I recommend that the acreage as advertised be created into this pool plus an unadvertised portion, that being the N/2 of Section 34, Township 24 North, Range 7 West, and this pool would be created based on seven wells completed capable of producing. The discovery well was the Standard of Texas' No. 1 Federal 4-27, in Unit 6, Section 27, 24 North, 7 West, with an initial potential of 70 barrels per day. Top of perforation is 5700 feet.

What are your recommendations for the vertical limits of the proposed Escritto-Gallup Oil Pool?

A The Gallup formation.

Mr. Hendricks, do you have any recommendations concerning the extension of South Bianco-Pictured Cliffs Gas Pool?

A I recommend the South Bianco-Pictured Cliffs Pool be extended as advertised based on two wells capable of producing.

Q What are your recommendations concerning the extension of the Bianco Mesaverde Gas Pool?

A I recommend the Bianco Mesaverde Gas Pool be extended as advertised based on two wells capable of producing.

Q What are your recommendations regarding the extension of the Bisti-Lower Gallup Oil Pool?

A I recommend the Bisti-Lower Gallup Oil Pool be extended as advertised plus an unadvertised portion, being the NW/4 of Section 3, 24 North, 10 West, based on five wells capable of producing located on this acreage. That is, the total acreage.

Q What are your recommendations concerning the extension of the Verde-Lower Gallup Oil Pool?

A I recommend the Verde-Lower Gallup Oil Pool be extended as advertised based on two wells capable of producing.

Q Mr. Hendricks, do you have any further recommendations in this case?

A No.

Q Have you prepared an exhibit to substantiate your recommendations in this case?

A I have an exhibit prepared by me, and three copies of Form C-129 submitted by operators requesting the creation of

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on April 16, 1958, at Roswell, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 25th day of April, 1958, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for the creation of a new pool in San Juan County, New Mexico, for the production of gas from the Gallup formation, said pool to bear the designation Angels Peak-Gallup Pool. Said Angels Peak-Gallup Pool was discovered by W. R. Weaver McAdams Well No. 1, located in the SE/4 NW/4 Section 34, Township 27 North, Range 10 West, NMPM. It was completed February 9, 1958. The top of the perforations is at 6,252 feet.

(3) That there is need for the creation of a new pool in Rio Arriba County, New Mexico, for the production of oil from the Gallup formation, said pool to bear the designation Escrito-Gallup Oil Pool. Said Escrito-Gallup Oil Pool was discovered by Standard of Texas Federal 1-27 Well No. 1, located in the SW/4 SE/4 Section 27, Township 24 North, Range 7 West, NMPM. It was completed April 22, 1957. The top of the perforations is at 5,700 feet.

(4) That there is need for certain extensions to the Bisti-Lower Gallup Oil Pool and the Verde-Gallup Oil Pool, both in San Juan County, New Mexico, and to the South Blanco-Pictured Cliffs Pool and the Blanco Mesaverde Pool, both in San Juan and Rio Arriba Counties, New Mexico.
