Case 6288

APPLICATION

Comes now Dorchester Exploration, Inc., and applies to the Oil Conservation Division for adoption of pool rules, with provision for 160 acre spacing for oil production, and in support thereof would show the Commission:

1. Applicant had completed its Wilson State Com Well No. 1, located 1980 feet from the South line, and 990 feet from the East line of Section 13, Township 21 South, Range 34 East. N.M.P.M., Lea County, New Mexico, for production of gas from the Morrow formation.

2. The Morrow formation was depleted, and applicant plugged the well back and re-completed in the Strawn formation in an undesignated Strawn Oil Pool. The well was recompleted for production of approximately 100 barrels of oil per day with a gas-oil ratio of 1200 to 1.

3. The information presently available indicated that the subject well is capable of, and is draining approximately 160 acres, and far in excess of the normal 40 acre spacing and proration unit dedicated to the well.

4. Applicant proposes to dedicate the SE/4 of Section 13 to the well. In the alternative, applicant seeks approval of an 80 acre spacing and proration unit, dedicating the N/2 SE/4 of Section 13 to the well.



WHEREFORE Applicant prays that this application be set for hearing before the Division or the Division's duly appointed examiner, and that after notice and hearing the Division adopt pool rules for the undesignated Strawn pool for a temporary period of one year, with provision for 160 acre spacing and proration units, or in the alternative, for adoption of temporary pool rules with provision for 80 acre spacing and proration units, and for such other and further provisions as

may be proper.
