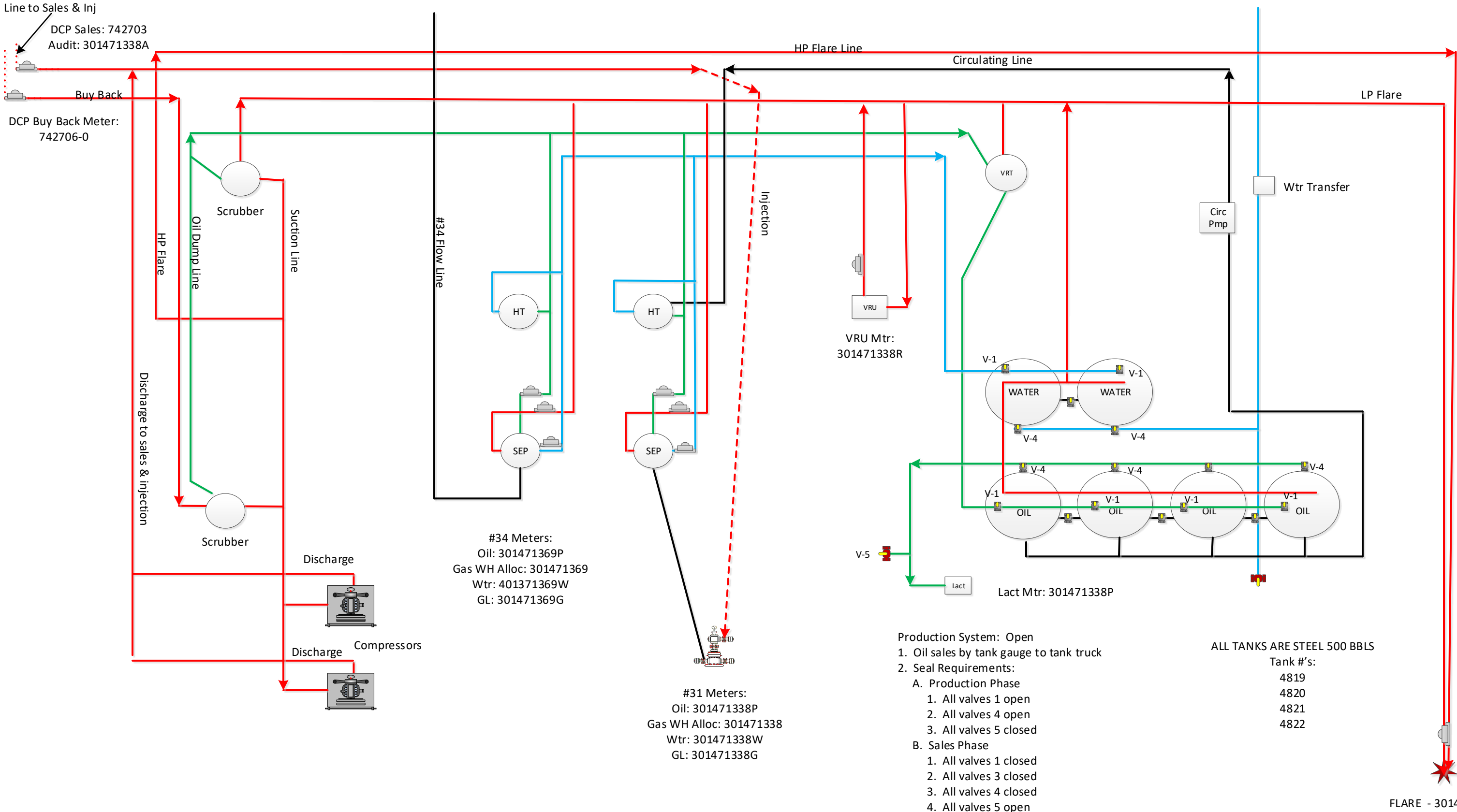


Site Facility Diagram
