Dear Mr. Pierard:

Western Refining Southwest LLC (Western Refining) received the above referenced Disapproval letter from the New Mexico Environment Department (NMED) dated December 14, 2021. That letter required that a Response to Comments Letter and the revised Closure Plan be provided to NMED on February 11, 2022.

Bid costs received in February 2022 from potential contractors for implementing the initial phase of the Closure Plan (excavation and disposal of Aerobic Lagoons AL-1 and AL-2) greatly exceeded the cost budgeted cost for the scope of work. The bids received exhibited the ongoing impacts associated with the Covid 19 pandemic recovery including supply chain disruptions and inflationary pressures. Western Refining is currently evaluating options for revising the Closure Plan to determine a path forward. Our continued progress has been communicated to NMED (D. Cobrain) and a formal submittal is being prepared for NMED consideration.

Western Refining looks forward to discussing options that will meet NMED requirements to address the impacts associated with SWMU-1 at the Gallup Refinery and will provide the required revised Closure Plan once a plan has been developed.
