# Cano San Andres Battery No. 6 Site Reclamation – Disposal Facilities and Time Estimate

Total time to complete the project is estimated at four weeks, weather permitting. FDI will use Teague Iron and Metal, LLC (Carlsbad, NM) for salvage/recycling operations. Acceptable Disposal/Landfill facilities will be based upon the New Mexico Environment Department's approved "Lists of Facilities and Haulers (<a href="https://www.env.nm.gov/solid-waste/lists-of-facilities-and-haulers">https://www.env.nm.gov/solid-waste/lists-of-facilities-and-haulers</a>)" permitted to accept Special Waste. For example, Lea County Landfill/Solid Waste Authority (Hobbs, NM) accepts special waste.
