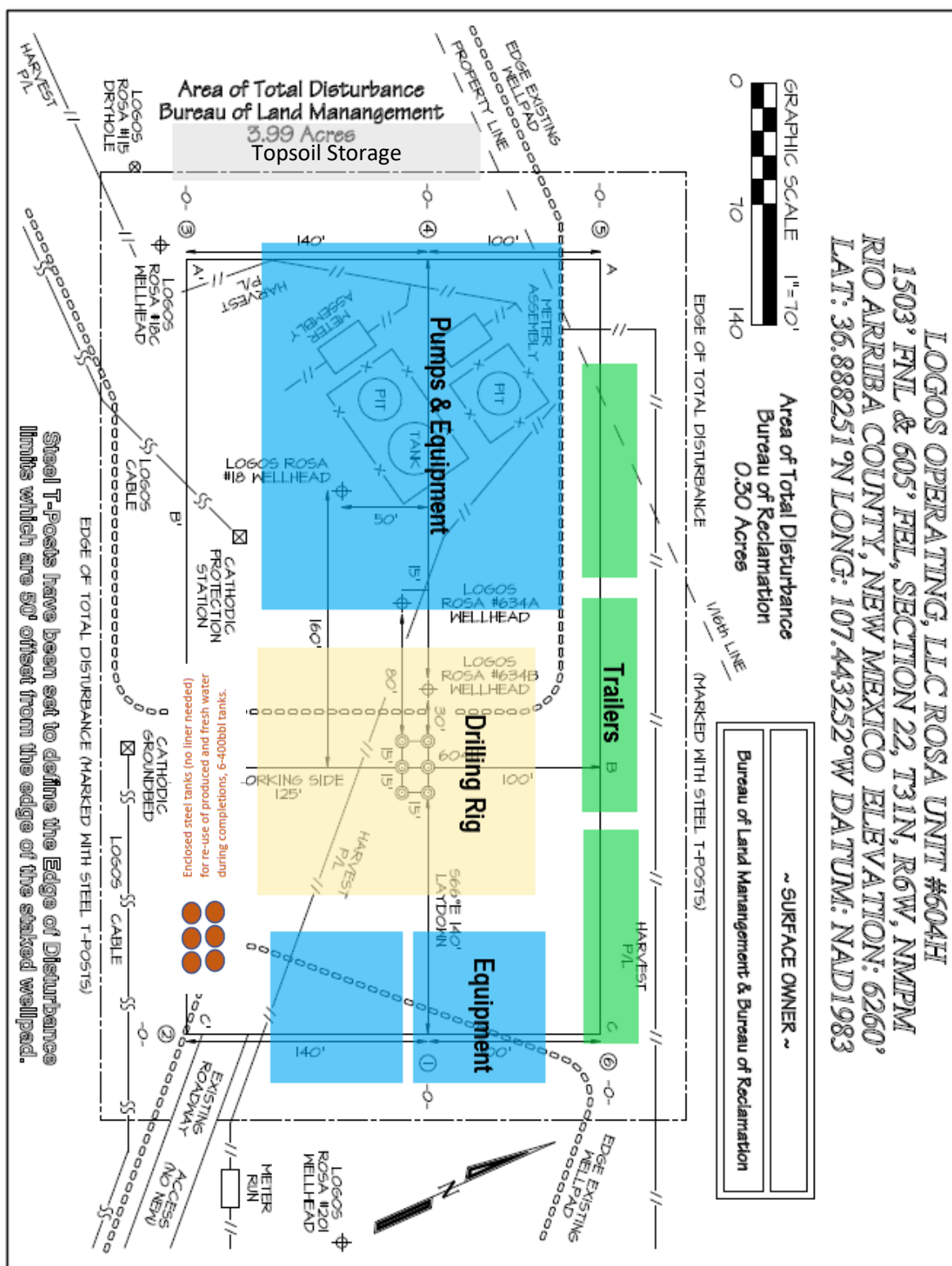

NMOCD has reviewed the facility registration submitted by [289408] LOGOS OPERATING, LLC on 12/28/2023, for 3RF-69 - ROSA UNIT 604H API 30-039-31434, ROSA UNIT 606H AP FACILITY ID [fVV2336342171] in H-22-31N-06W, Rio Arriba County, New Mexico. The registration is approved with the following conditions of approval:

- The purpose of this permit is for oil and gas activities regulated under the NMAC 19.15.34.3 STATUTORY AUTHORITY: 19.15.34 NMAC is adopted pursuant to the Oil and Gas Act, Paragraph (15) of Section 70-2-12(B) NMSA 1978, which authorizes the division to regulate the disposition of water produced or used in connection with the drilling for or producing of oil and gas or both and Paragraph (21) of Section 70-2-12(B) NMSA 1978 which authorizes the regulation of the disposition of nondomestic wastes from the exploration, development, production or storage of crude oil or natural gas.
