Good morning Deb,

Just to clarify, the 26 facility IDs (f#) listed on the spreadsheet you attached need to be transfer from [330447] Contango Resources, Inc. to [372290] Riley Permian Operating Company, LLC?

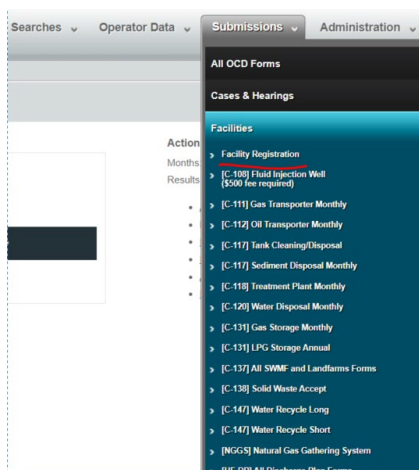
Here are my answers to your questions from yesterday.

- "Yes, that is correct for the tank batteries on the pad."
- "No, not regarding reporting of venting or flaring. I was just tasked with making sure information has been updated to Riley since the purchase. The wells have all been changed but no one had submitted for the facilities yet."

If the tank battery that shares the pad with the wellhead are only associated with that well, meaning that product from other wells is not stored in the tanks, that tank battery should not be registered as a facility. If a facility is created for a tank battery that is only associated with one well, it will skew the venting and flaring data.

- "Also, how does one register a facility with the OCD? I can't find any guidance."

If you have a central tank battery or gathering point that accepts product from multiple wells that needs to be registered as a facility, the registration is done through the OCD Permitting website. Once you log in under your OGRID, hover over the *Submissions* tab and move down to the *Facilities* group. Another drop down should appear and the first choice will be *Facility Registration*. Please see below for a snip of what to look for:



You will then select the type of facility you are registering (flare stack, tank battery, etc) by clicking on the link located in the far-right hand column. Please let me know if you need additional help after this step.
