Solaris Water Midstream, LLC. respectfully submits the enclosed C-147 form, summary of monthly inspections and leak detection for the Landes Water Recycling Facility. For original site plans and submittals, please refer to the facility's original registration application, OCD Registration number 2RF-134, received August 31st, 2018. In accordance with NMAC 19.15.34.10 RECYCLING CONTAINMENTS, Solaris Water Midstream wishes to seek a one-year extension to the facility. The annual extension dates requested will be from August 31st 2025, to August 31st, 2026.

NMAC 19.15.34.10 RECYCLING CONTAINMENTS

C. Registered recycling containments may be operated for five years from the date on which the registration is filed with the division. The operator may extend the allowed time on an annual basis thereafter with division approval if, 30 days prior to the registration expiration, the operator files a form C-147 with an attached summary showing all monthly inspections at the containment, including the monitoring of the leak detection system, showing the containment's integrity has not been compromised.

The NMOCD has reviewed the annual registration/permit extension request for 2RF-134 - LANDES WATER RECYCLING FACILITY ID [fAB1826252353] received from [371643] SOLARIS WATER MIDSTREAM, LLC on 08/12/2024. Application ID **494662**. The registration/permit extension request is approved with the following conditions of approval:

- 2RF-134 - LANDES WATER RECYCLING FACILITY ID [fAB1826252353] is approved for one (1) year of operation from the date of the previous registration/permit expiration date of August 31, 2025. The new registration/permit expiration date is August 31, 2026.
- [371643] SOLARIS WATER MIDSTREAM, LLC will continue to operate, maintain, and close the for 2RF-2RF-134 - LANDES WATER RECYCLING FACILITY ID [fAB1826252353] in compliance with 19.15.34 NMAC, to include but not limited to the performance of weekly inspections regardless of fluid levels in the containment; recording of detailed inspection reports; removal of debris, foreign objects and oil from the containment; and monthly reporting of recycling and reuse of produced water, drilling fluids, and liquid oil field waste via from C-148.
- [371643] SOLARIS WATER MIDSTREAM, LLC will maintain a liquid level in the containment that is at least equal to the weight of the liner plus 20%. [371643] SOLARIS WATER MIDSTREAM, LLC may maintain a higher liquid level if they choose.
- If less than 20% of the total fluid capacity is utilized every consecutive six months, operation of the facility is considered ceased and a notification of cessation of operations should be sent electronically through OCD Permitting. An extension to extend the cessation of operations, not to exceed six months, may be submitted using a C-147 form through the OCD Online system.
- If after that 6-month extension period, the containment is not utilized at a minimum of 20% fluid capacity, no additional extensions would be granted, and the operator would be directed to remove all fluids and proceed with the closure requirements.
- A minimum of 3-feet freeboard must be maintained in the recycling containment at all times.
- [371643] SOLARIS WATER MIDSTREAM, LLC will comply with 19.15.29 NMAC Releases in the event of any release of produced water or produced water or other oil field wastes at for 2RF-134 - LANDES WATER RECYCLING FACILITY ID [fAB1826252353]. [371643] SOLARIS WATER MIDSTREAM, LLC will comply with all other OCD rules.
- [371643] SOLARIS WATER MIDSTREAM, LLC must perform weekly inspections of the containment and leak detection system.
- If [371643] SOLARIS WATER MIDSTREAM, LLC wishes to extend the registration/permit past August 31, 2026, a registration/permit extension request must be submitted to OCD. Extension requests are reviewed on a case-by-case basis and evaluated on their merit. Extensions are considered for a maximum length of one year. Additional requests must be submitted to OCD through OCD Online on a Form C-147 (long form) as an Extension request and should include a formal extension request letter, a summary of the prior

registration/permit period inspection reports, and the copies of the detailed inspection records for the prior permit period. The extension request should be submitted no later than July 31, 2026.
