This minor modification does not affect the treatment, remediation, or disposal methods for the processing as detailed in the Blanco permit #NM1-50.



The New Mexico Oil Conservation Division (OCD) has received the Blanco Real Estate Holdings, LLC (BREH) application for a minor modification dated and submitted on December 31, 2025, requesting to revert cells 3,4,5,6,11 and 12 back to their original dedicated purpose as a treatment areas for soils with chlorides less than 500 mg/kg. BREH must adhere to the permit application and conditions approved by the OCD May 13, 2016, and the Minor Modification to permit approved by OCD June 18, 2024 (transfer of ownership from Crowe Blanco Properties, LLC to Blanco Real Estate Holdings LLC).
