ORDER NO. AG-N-2

GAS PRORATION ORDER FOR PERIOD FEBRUARY 1, 1956
THROUGH JULY 31, 1956

The Commission held public hearing at Santa Fe, New Mexico, on December 14, 1955, at 9 a. m., pursuant to legal notice for the purpose of setting the allowable production of gas from the following five (5) gas pools in San Juan and Rio Arriba Counties, New Mexico, for the six-month period, February 1, 1956 through July 31, 1956.

Blanco-Mesaverde, Aztec-Pictured Cliffs, Fulcher Kutz-Pictured Cliffs, South Blanco-Pictured Cliffs and West Kutz-Pictured Cliffs.

NOW, on this day the Commission, a quorum being present, having considered the nominations of purchasers, the capacity of producing wells and being otherwise fully advised in the premises,

FINDS:

1. That the total nominations of purchasers of gas produced from the above listed five (5) gas pools for the period February 1, 1956 through July 31, 1956, is 73,477,900 MCF. The individual pool nominations, which total 73,477,900 MCF, are as follows:

Blanco Mesaverde	58,271,100 MCF
Aztec-Pictured Cliffs	3,090,000
Fulcher Kutz-Pictured Cliffs	3,159,000
South Blanco-Pictured Cliffs	5,650,900
West Kutz-Pictured Cliffs	3,306,900

2. The potential producing capacity of all gas wells in the five (5) gas pools listed above is in excess of the nominations of purchasers of gas and in order to prevent waste and protect correlative rights, the production of gas from the above listed five (5) gas pools should be limited, allocated and distributed during the six-month proration period commencing February 1, 1956.

3. That all the producing gas wells together with the expected completed or recompleted wells in the five (5) gas pools listed above can produce a total of 73,477,900 MCF without causing waste within the six-month period commencing February 1, 1956, and an allocation based upon such production would be reasonable and protect correlative rights.

IT IS THEREFORE ORDERED:

1. For the six-month proration period commencing February 1, 1956, the total allowable production to be assigned the five (5) allocated gas pools in San Juan and Rio Arriba Counties, be and the same hereby is as follows:

2. That the allocation hereby set for said six-month proration period in the five (5) allocated pools in San Juan and Rio Arriba Counties, New Mexico, shall be in accordance with the provisions of Orders R-128-D, R-565-C and R-566-D, and the Commission's Rules and Regulations.

3. The total allowable production for each pool as set forth shall be allocated on a monthly basis in accordance with Schedule "A" attached hereto and such schedule shall be adjusted monthly to meet changes in market conditions reflected by purchasers' supplemental nominations and actual gas production in accordance with Orders R-128-D, R-565-C, and R-566-D.

The foregoing shall remain effective until further order of the Commission.
