APPLICATION OF THE OIL CONSERVATION DIVISION FOR AN ORDER CREATING, ASSIGNING A DISCOVERY ALLOWABLE, CONTRACTING VERTICAL LIMITS, REDESIGNATING, AND EXTENDING HORIZONTAL LIMITS OF CERTAIN POOLS IN LEA AND ROOSEVELT COUNTIES, NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on October 19, 2000, at Santa Fe, New Mexico before Examiner Michael E. Stogner.

NOW, on this 244 day of October, 2000, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

FINDS THAT:

(1) Due public notice has been given and the Division has jurisdiction of this case and its subject matter.

(2) There is need for the creation of a new pool in Lea County, New Mexico for the production of oil from the Queen formation, bearing the designation of Anderson Ranch-Queen Pool. The Anderson Ranch-Queen Pool was discovered by the Texaco Exploration and Production Inc. Green Star 14 State Well No. 1 located in Unit N of Section 14, Township 16 South, Range 32 East, NMPM, which was completed in the Queen formation on April 12, 2000. The top of the perforations is at 3,730 feet.

(3) There is need for the creation of a new pool in Lea County, New Mexico for the production of oil from the Wolfcamp formation, bearing the designation of Southeast Dean-Wolfcamp Pool. The Southeast Dean-Wolfcamp Pool was discovered by the Chesapeake Operating Inc. B Medlin 10 Well No. 1 located in Unit E of Section 10, Case No. 12521 Order No. R-11475 -2-

Township 16 South, Range 37 East, NMPM, which was completed in the Wolfcamp formation on January 10, 2000. The top of the perforations is at 10,624 feet.

(4) There is need for the creation of a new pool in Lea County, New Mexico for the production of oil from the Wolfcamp formation, bearing the designation of Northeast Echol-Wolfcamp Pool. The Northeast Echol-Wolfcamp Pool was discovered by the Manzano Oil Corporation SV Sundown State Well No. 1 located in Unit M of Section 14, Township 10 South, Range 37 East, NMPM, which was completed in the Wolfcamp formation on May 4, 2000. The top of the perforations is at 9,466 feet.

(5) There is need for the creation of a new pool in Lea County, New Mexico for the production of gas from the Atoka formation, bearing the designation of Eight Mile Draw-Atoka Gas Pool. The Eight Mile Draw-Atoka Gas Pool was discovered by the Yates Petroleum Corporation Carper McAlester ATE State Well No. 1 located in Unit C of Section 25, Township 11 South, Range 34 East, NMPM, which was completed in the Atoka formation on November 24, 1999. The top of the perforations is at 11,771 feet.

(6) There is need for the creation of a new pool in Lea County, New Mexico for the production of oil from the Wolfcamp formation, bearing the designation of Klein Ranch-Wolfcamp Pool. The Klein Ranch-Wolfcamp Pool was discovered by the Louis Dreyfus Natural Gas Corporation Toro 27 Well No. 2 located in Unit E of Section 27, Township 19 South, Range 35 East, NMPM, which was completed in the Wolfcamp formation on November 18, 1999. The top of the perforations is at 10,980 feet.

(7) There is need for the creation of a new pool in Lea County, New Mexico for the production of oil from the Drinkard formation, bearing the designation of Northeast Monument-Drinkard Pool. The Northeast Monument-Drinkard Pool was discovered by the Chevron USA, Inc. 13 State Well No. 27 located in Unit B of Section 13, Township 19 South, Range 36 East, NMPM, which was completed in the Drinkard formation on November 12, 1999. The top of the perforations is at 6,724 feet.

(8) There is need for the creation of a new pool in Lea County, New Mexico for the production of gas from the Atoka formation, bearing the designation of South Quail Ridge-Atoka Gas Pool. The South Quail Ridge-Atoka Gas Pool was discovered by the Louis Dreyfus Natural Gas Corporation Greenstone Federal Com Well No. 1 located in Unit O of Section 19, Township 20 South, Range 34 East, NMPM, which was completed in the Atoka formation on November 30, 1999. The top of the perforations is at 12,662 feet.

(9) There is need for the creation of a new pool in Lea County, New Mexico for the production of oil from the Delaware formation, bearing the designation of Southeast Teas-Delaware Pool. The Southeast Teas-Delaware Pool was discovered by the Santa Fe Snyder Corporation Sinagua 18 Federal Well No. 2 located in Unit J of Section 18, Township 20 South, Range 34 East, NMPM, which was completed in the Delaware formation on May 23, 2000. The top of the perforations is at 5,670 feet.

(10) There is need for the creation of a new pool in Lea County, New Mexico for the production of oil from the Blinebry formation, bearing the designation of Northeast Vacuum-Blinebry Pool. Further, the discovery well for the Northeast Vacuum-Blinebry Pool, the Southwestern Energy Production Company Bimini 13 State Well No. 1 located in Unit E of Section 13, Township 17 South, Range 35 East, NMPM, is entitled to and should receive a bonus discovery allowable in the amount of 34,835 barrels of oil to be produced over a two-year period. The discovery well was completed in the Blinebry formation on May 1, 2000. The top of the perforations is at 6,985 feet.

(11) There is need for the contraction of the vertical limits of the Eight Mile Draw-Permo Pennsylvanian Pool in Lea County, New Mexico to include only the Wolfcamp, Cisco, Canyon and Strawn formations and the redesignation of the pool as the Eight Mile Draw-Permo Upper Pennsylvanian Pool.

(12) There is need for the contraction of the vertical limits of the Northeast Lovington-Pennsylvanian Pool in Lea County, New Mexico to include only the Cisco, Canyon and Strawn formations and the redesignation of the pool as the Northeast Lovington-Upper Pennsylvanian Pool.

(13) There is need for the contraction of the vertical limits of the Northwest Vacuum-Pennsylvanian Pool in Lea County, New Mexico to include only the Cisco, Canyon and Strawn formations and the redesignation of the pool as the Northwest Vacuum-Upper Pennsylvanian Pool.

(14)There is need for certain extensions to the Southwest Anderson Ranch-Wolfcamp Pool, the Austin-Permo Upper Pennsylvanian Pool, the Baish-Wolfcamp Pool, the DK-Abo Pool, the Diamond-Strawn Pool, the Southwest Diamondtail-Delaware Pool. the Eumont-Yates-Seven Rivers-Queen Pool, the Feather-Morrow Pool, the North Gem-Wolfcamp Pool, the Goodwin-Drinkard Pool, the North Hardy-Strawn Pool, the House-Abo Pool, the House-Blinebry Pool, the Humble City-Strawn Pool, the South Kemnitz-Atoka-Morrow Gas Pool, the Southeast Lane-Abo Pool, the Lea-San Andres Pool, the Lovington-Drinkard Pool, the Northeast Lovington-Upper Pennsylvanian Pool, the West Lovington-Strawn Pool, the Lusk-Bone Spring Pool, the North Monument-Abo Pool, the North Monument-Drinkard Gas Pool, the Nadine-Drinkard-Abo Pool, the West Nadine-Paddock-Blinebry Pool, the West Ojo Chiso-Morrow Gas Pool, the Southeast Scharb-Wolfcamp Pool, the North Shoe Bar-Atoka Gas Pool, the North Shoe Bar-Morrow Gas Pool, the Northeast Shoe Bar-Strawn Pool, the Northwest Shoe Bar-Strawn Pool, the Townsend-Morrow Gas Pool, the Trinity-Devonian Pool, the Triste Draw-Delaware Pool, the North Vacuum-Atoka-Morrow Gas Pool, the Vacuum-Blinebry Pool, the Vacuum-Morrow Gas Pool, the Northwest Vacuum-Upper Pennsylvanian Pool, the Weir-Blinebry Pool, the Wilson-Morrow Gas Pool, and the North Young-Delaware Pool, all in Lea County, New Mexico, and the Bluitt-San Andres Associated Pool in Roosevelt County, New Mexico.

IT IS FURTHER ORDERED THAT:

(1) Pursuant to Section 70-2-18, NMSA, 1978, an operator of any well that, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one presently dedicated thereto, shall have 60 days from the effective date of this order to file Form C-102 dedicating a standard unit for the pool to that well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard Case No. 12521 Order No. R-11475 -12-

unit to the well or to obtain a non-standard unit approved by the Division within that 60day period shall subject the well to cancellation of allowable.

(2) The effective date of this order and all creations, assignments of discovery allowable, redesignations, contractions of vertical limits, and extensions of horizontal limits included herein shall be November 1, 2000.
