## BEFORE THE OIL CONSERVATION COMMISSION OF THE STATE OF NEW MEXICO

IN THE MATTER OF THE HEARING CALLED BY THE OIL CONSERVATION COMMISSION OF NEW MEXICO FOR THE PURPOSE OF CONSIDERING:

APPLICATION OF THE OIL CONSERVATION COMMISSION UPON ITS OWN MOTION, AT THE REQUEST OF THE STATE ENGINEER, FOR AN ORDER PRESCRIBING RULES AND REGULATIONS TO GOVERN THE DISPOSAL OF SALT WATER IN AREAS OF LEA COUNTY, NEW MEXICO.

## ORDER OF THE COMMISSION

## BY THE COMMISSION:

This cause originally came on for hearing at 9 o'clock a.m. on May 16, 1956, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission," and was continued from time to time, and was heard again on June 18, 1958, and again on September 17, 1958.

NOW, on this  $35^{t/t}$  day of October, 1958, the Commission, a quorum being present, having considered the evidence adduced and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof by virtue of its implied powers and the express powers conferred upon the Commission by sub-section (2) and (7) of Section 65-3-11 of the New Mexico Statutes Annotated (1953).

(2) That the surface disposal of oil field brines in unlined pits in the following-described areas constitutes a hazard to the fresh waters in the Lea County Underground Water Basin, as the same is defined by the State Engineer of the State of New Mexico, and that such method of disposal should be prohibited in said areas, to-wit:

(3) That only a portion of the Eunice-Monument-Eumont Area (Eunice-Monument, Eumont, Monument-Blinebry, and Monument -2-Case No. 1053 Order No. R-1224-A

Paddock Pools) lies within the boundaries of the said Lea County Underground Water Basin.

(4) That the disposal of oil field brines in unlined pits in that portion of the Eunice-Monument-Eumont Area which lies within the boundaries of the Lea County Underground Water Basin constitutes a hazard to the fresh waters in said basin and that such method of disposal should be prohibited in that portion of said area.

(5) That the testimony presented at the September 17, 1958, hearing of this case has raised a question as to whether the disposal of oil field brines in unlined pits in any area of Lea County other than those areas referred to in Findings No. 2 and 4 above constitutes a hazard to the fresh water supplies of Lea County.

(6) That paragraph (3) of Order No. R-1224 should, therefore, be rescinded.

(7) That a detailed localized study should be made of each area in Lea County, not included in Findings No. 2 and 4, where substantial quantities of oil field brines are produced, to determine whether the surface disposal of said brines in unlined pits constitutes a hazard to the fresh water supplies of Lea County. Further, that the Secretary-Director of the Commission should, from time to time, appoint pool committees to make such studies.

(8) That any well which produces one half  $(\frac{1}{2})$  barrel or less of oil field brines per day should be exempt entirely from the provisions of this order, since there is no evidence that the disposal of such insignificant quantities of oil field brines in unlined pits would constitute a hazard to the fresh waters in the area.

(9) That provision should be made to empower the Secretary-Director to grant administrative exceptions to this order in individual cases where it appears that the granting of such exception would cause no danger of contamination, provided the State Engineer's Office has waived objection to the exception.

## IT IS THEREFORE ORDERED:

1. That the surface disposal of oil field brines in unlined pits in the following-described areas be and the same is hereby prohibited as of the effective dates shown below: -3-Case No. 1053 Order No. R-1224-A

The provisions of this paragraph apply only to that portion of the Eunice-Monument-Eumont Area which lies within the Lea County Underground Water Basin as the same was declared by the State Engineer in his Order No. 3, dated August 21, 1931, and as the same was extended by Order No. 33, dated October 1, 1952.

PROVIDED HOWEVER; that any well which produces one half  $(\frac{1}{2})$  barrel, or less, of oil field brines per day shall be entirely exempt from the provisions of this order.

2. The Secretary-Director of the Commission shall have authority to extend the effective dates set forth in paragraph 1. above without notice and hearing where good cause is shown.

That nothing contained in this order shall be construed as prohibiting the disposal of oil field brines in impervious lined pits, provided said pits are inspected and approved by a representative of the Commission prior to being used.

That the Secretary-Director of the Commission shall 4. have authority to grant exceptions without notice and hearing, to paragraph (1) above where, in his opinion, the granting of such exception would not create a hazard to any fresh water supply, provided the State Engineer has waived objection to the proposed exception.

5. That the Secretary-Director of the Commission shall appoint a committee for each area in Lea County, New Mexico, where substantial quantities of oil field brines are produced, which committees shall make studies as to whether the disposal of oil field brines in unlined pits constitutes a hazard to any fresh water source in said areas. The State Engineer shall be a member of each of said committees.

Such committees will not be required to submit formal reports of their findings to the Commission. If, however, a committee or any member thereof is of the opinion that the surface disposal of oil field brines in unlined pits constitutes a hazard to any fresh water supply, the Commission shall be so notified and the matter shall be set for hearing.

That paragraph (3) of Order No. R-1224 be and the 6. same is hereby rescinded.
