ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on January 14, 1959, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 21st., day of January, 1959, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Tapacito-Pictured Cliffs Pool and the South Los Pinos-Dakota Pool in Rio Arriba County, New Mexico, to the Verde-Gallup Oil Pool in San Juan County, New Mexico, and to the South Blanco-Pictured Cliffs Pool and the Blanco-Mesaverde Pool in San Juan and Rio Arriba Counties, New Mexico.

IT IS THEREFORE ORDERED:

(a) That the South Blanco-Pictured Cliffs Pool in San Juan and Rio Arriba Counties, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(c) That the Blanco-Mesaverde Pool in San Juan and Rio Arriba Counties, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

Section 30: E/2

TOWNSHIP 29 NORTH, RANGE 4 WEST, NMPM
Section 6: All

TOWNSHIP 30 NORTH, RANGE 4 WEST, NMPM

(d) That the South Los Pinos-Dakota Pool in Rio Arriba County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(e) That the Verde-Gallup Oil Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

Section 8: SW/4 SE/4
Section 17: SW/4

IT IS FURTHER ORDERED:


That the effective date of this order and of all the extensions included herein shall be February 1, 1959.


