## ORDER OF THE COMMISSION

#### BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on March 18, 1959, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

Now on this <u>20th</u> day of March, 1959, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

#### FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Otero-Gallup Oil Pool in Rio Arriba County, New Mexico, to the Aztec-Pictured Cliffs Pool, the West Kutz-Pictured Cliffs Pool, the Bisti-Lower Gallup Oil Pool, the Gallegos-Gallup Oil Pool, the Horseshoe-Gallup Oil Pool, the Verde-Gallup Oil Pool, and the West Kutz-Dakota Pool all in San Juan County, New Mexico.
