## ORDER OF THE COMMISSION

## BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on April 8, 1959, at Santa Fe, New Mexico, before E. J. Fischer, Examiner duly appointed by the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission," in accordance with Rule 1214 of the Commission Rules and Regulations.

NOW, on this 7 th., day of May, 1959, the Commission, a quorum being present, having considered the application, the evidence adduced, and the recommendations of the Examiner, E. J. Fischer, and being fully advised in the premises,

## FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the applicant, Humble Oil & Refining Company, is the owner and operator of the SE/4 of Section 18 and the NE/4 of Section 19, Township 22 South, Range 37 East, NMPM, Lea County, New Mexico.

(3) That the applicant is the owner and operator of the State "M" Well No. 1, located 1980 feet from the South line and 1980 feet from the East line of said Section 18.

(4) That the applicant proposes the establishment of a 320acre non-standard gas proration unit in the Eumont Gas Pool consisting of the SE/4 of Section 18 and the NE/4 of Section 19, Township 22 South, Range 37 East, NMPM, Lea County, New Mexico, to be dedicated to the said State "M" Well No. 1. -2-Case No. 1629 Order No. R-1388

That all of the acreage in the proposed non-standard gas (5) proration unit can reasonably be presumed to be productive of gas from the Eumont Gas Pool.

That approval of the subject application will not cause (6) waste.

That in view of the location of said State "M" Well No. (7) 1, approval of the subject application will not impair correlative rights.

IT IS THEREFORE ORDERED:

That the application of Humble Oil & Refining Company (1)for the establishment of a 320-acre non-standard gas proration unit in the Eumont Gas Pool, consisting of the SE/4 of Section 18 and the NE/4 of Section 19, Township 22 South, Range 37 East, NMPM, Lea County, New Mexico, be and the same is hereby granted. Said unit is to be dedicated to the applicant's State "M" Well No. 1, located 1980 feet from the South line and 1980 feet from the East line of said Section 18.

That the said State "M" Well No. 1 shall be assigned an (2)allowable for the Eumont Gas Pool in the proportion that the acreage dedicated to the well bears to a standard gas proration unit in the Eumont Gas Pool, subject to the special rules and regulations for said Eumont Gas Pool.
