ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on May 12, 1959, at Santa Fe, New Mexico, before Daniel S. Nutter, Examiner duly appointed by the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission," in accordance with Rule 1214 of the Commission Rules and Regulations.

NOW, on this <u>5th</u> day of June, 1959, the Commission, a quorum being present, having considered the appli cation, the evidence adduced, and the recommendations of the Examiner, Daniel S. Nutter, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the applicant, Sunray Mid-Continent Oil Company, is the operator of the Central Bisti LPG-Gas-Water Injection Project, Bisti-Lower Gallup Oil Pool, San Juan County, New Mexico.

(3) That in connection with the aforesaid Injection Project, the applicant seeks permission to convert the following-described wells to water injection for purposes of pressure maintenance:

Federal "C" Well No. 3, SW/4 NW/4 of Section 6, Township 25 North, Range 12 West, NMPM

Federal "C" Well No. 5, SW/4 SW/4 of Section 6, Township 25 North, Range 12 West, NMPM

(4) That approval of the subject appli cation will not impair correlative rights and it will prevent waste.

IT IS THEREFORE ORDERED:

That the applicant, Sunray Mid-Continent Oil Company, be and the same is hereby authorized, effective June 1, 1959, to convert the following-described wells to water injection:

> Federal "C" Well No. 3, SW/4 NW/4 of Section 6, Township 25 North, Range 12 West, NMPM

> Federal "C" Well No. 5, SW/4 SW/4 of Section 6, Township 25 North, Range 12 West, NMPM

Bisti-Lower Gallup Oil Pool, San Juan County, New Mexi co.

PROVIDED HOWEVER, That the zone of injection in the above-described wells shall be the entire Lower Gallup perforated interval in each of the wells prior to the time of conversion.
