ORDER OF THE COMMISSION

BY THE COMMISSION:

NOW, on this 11th day of April 1952, the Commission, a quorum being present, having considered the testimony adduced and the exhibits received at said hearing and being fully advised in the premises,

FINDS:

(1) That due notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That a new pool should be created, classified as an oil pool, and designated as the Teague-Devonian pool, described as:

T. 23S, R. 37E, NMPM All of sections 26, 27, 34 and 35

(3) That a new pool should be created, classified as an oil pool, and designated as the Maljamar-Devonian pool, described as:

T. 17S, R. 32E NMPM E/2 Sec. 21; all of sec. 22

(4) That a new pool should be created, classified as an oil pool, and designated as the Wantz-Abo pool, described as:

T. 21S, R. 37E, NMPM S/2 section 21

(5) That the South Saunders pool, Lea County, New Mexico, as heretofore classified, defined, and described, should be extended to include:

T. 15S, R. 33E, NMPM All of Sec. 19

(6) That the Saunders pool, Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include:

T. 14S, R. 33E, NAPM S/2 sec. 10 and all of sec. 15

(7) That the West Dollarhide pool, Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include:

<u>T. 24S. R. 38E, NMPM</u> Lots, 1, 2, 3 and 4 in sec. 33

<u>T. 255, R. 38E, NMPM</u> Lots 1 and 4 in sec. 4 (8) That the Brunson pool, Lea County, New Mexico, heretofore classified, defined and described, should be extended to include:

(9) That the Turkey-Track pool, Eddy County, New Mexico, as heretofore classified, defined and described, should be extended to include:

(10) That the Lovington-Abo pool, Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include:

(2) That a new pool, be, and the same hereby is created, designated for oil production, denominated the Maljamar-Devonian pool and described as follows:

<u>T. 175, R. 32E, NMPM</u> E/2 sec. 21; all of sec. 22

(3) That a new pool, be, and the same hereby is created, designated for oil production, denominated the Wantz-Abo pool and described as follows:

(4) That the boundaries of the South Saunders pool, Lea County, New Mexico, be, and the same hereby are extended to include:

(5) That the boundaries of the Saunders pool, Lea County, New Mexico, be, and the same here y are extended to include:

T. 14S, R. 33E, NMPM S/2 sec. 10 and all of sec. 15

(6) That the boundaries of the West Dollarhide pool, Lea County, New Mexico, be, and the same hereby are extended to include:

Lots 1 and 4 in sec. 4

(7) That the boundaries of the Brunson pool, Lea County, New Mexico, be, and the same hereby are extended to include:
