# ORDER OF THE COMMISSION

#### BY THE COMMISSION:

This cause came on for hearing at 9:00 o'clock a.m. on July 15, 1959, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW on this <u>21st</u> day of July, 1959, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

#### FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Otero-Gallup Oil Pool in Rio Arriba County, New Mexico, to the Aztec-Pictured Cliffs Pool, the Bisti-Lower Gallup Oil Pool, the Chimney Rock-Gallup Oil Pool, the Horseshoe-Gallup Oil Pool, and to the Angels Peak-Dakota Pool in San Juan County, New Mexico, to the South Blanco-Pictured Cliffs Pool and the Blanco-Mesaverde Pool in Rio Arriba and San Juan Counties, New Mexico, and to the Ballard-Pictured Cliffs Pool in Rio Arriba, Sandoval, and San Juan Counties, New Mexico. Further, that the proposed extension to the Fulcher Kutz-Pictured Cliffs Pool, San Juan County, New Mexico, should be dismissed to permit further study.
