APPLICATION OF THE ATLANTIC REFINING COMPANY FOR THE ESTABLISHMENT OF TWO NON-STANDARD OIL PRORATION UNITS AND FOR APPROVAL OF TWO UN-ORTHODOX WELL LOCATIONS IN THE HORSESHOE-GALLUP OIL POOL, SAN JUAN COUNTY, NEW MEXICO

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on October 7, 1959, at Santa Fe, New Mexico, before Elvis A. Utz, Examiner duly appointed by the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission," in accordance with Rule 1214 of the Commission Rules and Regulations.

NOW, on this 19th day of October, 1959, the Commission, a quorum being present, having considered the application, the evidence adduced, and the recommendations of the Examiner, Elvis A. Utz, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the applicant is the operator of two 40-acre tracts in portions of Sections 28 and 33, both in Township 31 North, Range 16 West, NMPM, San Juan County, New Mexico, comprising the following described acreage:

(a) A 40-acre tract consisting of a portion of the W/2 W/2 of said Section 33, more particularly described as follows:

Beginning at the Southwest corner of the SW/4 SW/4 of said Section 33; thence North 3,583.46 feet; thence East 486.1 feet; thence South 3,584.8 feet to the South line of said Section 33; thence West 486.1 feet to the point of beginning. -2-Case No. 1786 Order No. R-1503

(b) A 40-acre tract consisting of a portion of the W/2 SW/4 of said Section 28 and a portion of the W/2 NW/4 of said Section 33, more particularly described as follows:

Beginning at a point 339.6 feet South of the Southwest corner of the NW/4 NW/4 of said Section 33; thence North 3,584.5 feet along the West lines of said Sections 33 and 28; thence East 486.1 feet; thence South 3,584.5 feet; thence West 486.1 feet to the point of beginning.

3. That the applicant proposes the establishment of two non-standard oil proration units in the Horseshoe-Gallup Oil Pool, the first of which would comprise the 40-acre tract described in Part (a) of Finding No. (2), and the second of which would comprise the 40-acre tract described in Part (b) of Finding No. (2).

4. That the applicant proposes to dedicate the abovedescribed units respectively to wells to be drilled at the following unorthodox locations:

(a) A well located 1,980 feet from the South line and 386 feet from the West line of said Section 33.

(b) A well located 660 feet from the North line and 386 feet from the West line of said Section 33.

5. That approval of the subject application will neither cause waste nor impair correlative rights.

IT IS THEREFORE ORDERED:

(1) That two 40-acre non-standard oil proration units in the Horseshoe-Gallup Oil Pool be and the same are hereby established in portions of Sections 28 and 33, Township 31 North, Range 16 West, NMPM, San Juan County, New Mexico, comprising respectively:

(a) A 40-acre tract consisting of a portion of the W/2 W/2 of said Section 33, specifically described as follows:

Beginning at the Southwest corner of the SW/4 SW/4 of said Section 33; thence North 3,583.46 feet; thence East 486.1 feet; thence South 3,584.8 feet to the South line of said Section 33; thence West 486.1 feet to the point of beginning. -3-Case No. 1786 Order No. R-1503

(b) A 40-acre tract consisting of a portion of the W/2 SW/4 of said Section 28 and a portion of the W/2 NW/4 of said Section 33, specifically described as follows:

> Beginning at a point 339.6 feet South of the Southwest corner of the NW/4 NW/4 of said Section 33; thence North 3,584.5 feet along the West lines of said Sections 33 and 28; thence East 486.1 feet; thence South 3,584.5 feet; thence West 486.1 feet to the point of beginning.

(2) That the applicant be and the same is hereby authorized to dedicate the above-described non-standard oil proration units respectively to wells to be drilled at unorthodox locations as follows:

(a) A well located 1,980 feet from the South line and 386 feet from the West line of said Section 33.

(b) A well 660 feet from the North line and 386 feet from the West line of said Section 33.
