ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on October 14, 1959, at Roswell, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 28th day of October, 1959, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Tapacito-Pictured Cliffs Pool in Rio Arriba County, New Mexico; to the Blanco-Pictured Cliffs Pool, the Horseshoe-Gallup Oil Pool, the Verde-Gallup Oil Pool, the Angels Peak-Dakota Pool, and the West Kutz-Dakota Pool, all in San Juan County, New Mexico; and to the Ballard-Pictured Cliffs Pool in Rio Arriba, Sandoval, and San Juan Counties, New Mexico.

IT IS THEREFORE ORDERED:

(a) That the Blanco-Pictured Cliffs Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(b) That the Tapacito-Pictured Cliffs Pool in Rio Arriba County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(c) That the Horseshoe-Gallup Oil Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 30 NORTH, RANGE 16 WEST, NMPM
Section 13: NE/4 SW/4

TOWNSHIP 31 NORTH, RANGE 16 WEST NMPM
Section 20: N/2 SW/4
Section 28: S/2 & E/2 NE/4

(d) That the Verde-Gallup Oil Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(e) That the Angels Peak-Dakota Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 28 NORTH, RANGE 10 WEST, NMPM
Section 17: All
Section 20: All
Section 21: All
Section 28: W/2
Section 29: All
Section 34: E/2

(f) That the West Kutz-Dakota Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

Section 17: NE/4

IT IS FURTHER ORDERED:


That the effective date of this order and of all the extensions included herein shall be November 1, 1959.
