APPLICATION OF SHELL OIL COMPANY FOR AN AMENDMENT OF RULE 1114.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on May 17, 1961, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this <u>25th</u> day of May, 1961, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the applicant, Shell Oil Company, seeks an amendment of Rule 1114 to provide for Form C-115-EDP to be used for monthly production reports prepared by mechanical data processing equipment, as an alternative to Form C-115 used for manually prepared reports.

(3) That in some instances operators may be able to effect substantial savings in time and manpower and may be able to increase the efficiency of reporting procedures by use of mechanical data processing equipment to prepare monthly production reports.

(4) That Form C-115-EDP, as shown on Exhibit A attached hereto, should be adopted effective May 17, 1961.

(5) That a revised Form C-115 for manually prepared monthly production reports should be adopted which will incorporate substantially the same data required on said Form C-115-EDP.

(6) That a revised Form C-115, as shown on Exhibit B attached hereto, should be adopted effective October 1, 1961,

provided, however, that said form should be authorized for use by Aztec Oil & Gas Company on a trial basis effective May 17, 1961.

IT IS THEREFORE ORDERED:

(1) That Rule 1114 is hereby amended to permit the submission of monthly production reports prepared by mechanical data processing equipment on Form C-115-EDP, as shown on Exhibit A attached hereto, effective May 17, 1961.

(2) That the size of said Form C-115-EDP as prepared by any operator using said form shall be limited to a maximum paper size of 11 inches by 15 inches, unless approval for a larger size has been obtained from the Secretary-Director of the Commission.

(3) That Rule 1114 is hereby further amended to permit the submission of monthly production reports prepared manually on revised Form C-115, as shown on Exhibit B attached hereto, effective October 1, 1961.

<u>PROVIDED HOWEVER</u>, That Aztec Oil & Gas Company shall be authorized to use said revised Form C-115 on a trial basis, effective May 17, 1961.

(4) That jurisdiction of this cause is retained for the entry of such further orders as the Commission deems necessary.
