THE APPLICATION OF THE OIL CONSERVATION COMMISSION UPON ITS OWN MOTION FOR AN ORDER EXTENDING CERTAIN POOLS IN EDDY, LEA, AND ROOSEVELT COUNTIES, NEW MEXICO.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on June 14, 1961, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 16th day of June, 1961, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Culwin-Queen Pool, the North Hackberry-Yates Pool, the East Red Lake-Queen Pool, the North Shugart Queen-Grayburg Pool, and the Turkey Tract Pool, all in Eddy County, New Mexico, to the Allison-Pennsylvanian Pool, the Double X-Delaware Pool, the Drinkard Pool, the Justis Tubb-Drinkard Pool, the Lea-Bone Springs Pool, the Paduca-Delaware Pool, the Pearl-Queen Pool, the Saunders Pool, and the East Vacuum-Abo Pool, all in Lea County, New Mexico, and to the South Prairie-Pennsylvanian Pool in Roosevelt County, New Mexico.

IT IS THEREFORE ORDERED:

(a) That the Allison-Pennsylvanian Pool in Lea County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(b) That the Culwin-Queen Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:
