ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on August 16, 1961, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 18th day of August, 1961, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Aztec-Pictured Cliffs Pool, to the Bisti-Lower Gallup Oil Pool, to the Cha Cha-Gallup Oil Pool, to the Horseshoe-Gallup Oil Pool and to the Totah-Gallup Oil Pool in San Juan County, New Mexico, to the Devils Fork-Gallup Pool and to the Tapacito-Pictured Cliffs Pool in Rio Arriba County, New Mexico, to the Blanco-Mesaverde Pool and to the Escrito-Gallup Oil Pool in Rio Arriba and San Juan Counties, New Mexico, and to the Ballard-Pictured Cliffs Pool in Rio Arriba, Sandoval and San Juan Counties, New Mexico.

IT IS THEREFORE ORDERED:

(a) That the Aztec-Pictured Cliffs Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

Section 32: SE/4

(g) That the Devils Fork-Gallup Pool in Rio Arriba County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 24 NORTH, RANGE 6 WEST, NMPM
Section 7: W/2 SE/4

(h) That the Escrito-Gallup Oil Pool in Rio Arriba and San Juan Counties, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

Section 22: W/2 NE/4
Section 28: N/2 NE/4

(i) That the Horseshoe-Gallup Oil Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(j) That the Totah-Gallup Oil Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

Section 19: SW/4
Section 35: E/2 SW/4

That the effective date of this order and all the extensions herein shall be September 1, 1961.
