ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on November 15, 1961, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this <u>17th</u> day of November, 1961, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Pecos-Delaware Pool, the North Benson-Queen Pool, the North Hackberry-Yates Pool and the West Henshaw-Grayburg Pool, all in Eddy County, New Mexico, to the Bell Lake-Devonian Gas Pool, and the Blinebry (Oil) Pool, the Caudill-Permo Penn Pool, the South Crossroads-Devonian Pool, the Drinkard Pool, the Jalmat Gas Pool, the Justis Tubb-Drinkard Pool, the South Paddock Pool, the Paduca-Delaware Pool, the Teas Pool, the Vacuum-Abo Pool, and the Vacuum-Queen Pool, all in Lea County, -2-CASE NO. 2433 ORDER NO. R-2119

New Mexico, and to the Bluitt-Wolfcamp Gas Pool in Roosevelt County, New Mexico. Further, that the proposed extensions to the Angell-Seven Rivers Pool and the North Shugart Queen-Grayburg Pool, both in Eddy County, New Mexico, should be dismissed pending further study.
