ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on January 17, 1962, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 19th day of January, 1962 the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Boulder Mancos Oil Pool, to the Devils Fork-Gallup Pool and to the Tapacito Pictured Cliffs Pool in Rio Arriba County, New Mexico, to the Cha Cha-Gallup Oil Pool, to the Totah-Gallup Oil Pool and to the Verde-Gallup Oil Pool in San Juan County, New Mexico, to the South Blanco Pictured Cliffs Pool and the Escrito-Gallup Oil Pool in Rio Arriba and San Juan Counties, New Mexico and to the Ballard-Pictured Cliffs Pool in Rio Arriba, Sandoval and San Juan Counties, New Mexico.

(3) That the proposed extension to the Flora Vista-Mesaverde Pool in San Juan County, New Mexico should be dismissed.

IT IS THEREFORE ORDERED

(a) That the Ballard-Pictured Cliffs Pool in Rio Arriba, Sandoval and San Juan Counties, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(b) That the South Blanco-Pictured Cliffs Pool in Rio Arriba and San Juan Counties, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

TOWNSHIP 25 NORTH, RANGE 4 WEST, NMPM

(c) That the Tapacito-Pictured Cliffs Pool in Rio Arriba County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(d) That the proposed extension to the Flora Vista-Mesaverde Pool in San Juan County, New Mexico to include certain acreage is hereby dismissed.

(e) That the Boulder-Mancos Oil Pool in Rio Arriba County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

TOWNSHIP 28 NORTH, RANGE 1 WEST, NMPM

(f) That the Cha Cha-Gallup Oil Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

TOWNSHIP 29 NORTH, RANGE 13 WEST, NMPM

(g) That the Escrito-Gallup Oil Pool in Rio Arriba and San Juan Counties, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(h) That the Totah-Gallup Oil Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:
