ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on July 11, 1962, at Santa Fe, New Mexico, before Daniel S. Nutter, Examiner duly appointed by the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission," in accordance with Rule 1214 of the Commission Rules and Regulations.

NOW, on this 17th day of July, 1962, the Commission, a quorum being present, having considered the application, the evidence adduced, and the recommendations of the Examiner, Daniel S. Nutter, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the applicant, Continental Oil Company, seeks permission to complete its Hawk B-3 Well No. 21, located in Unit L of Section 3, Township 21 South, Range 37 East, NMPM, Lea County, New Mexico, as a triple completion (conventional) in the Blinebry, Tubb and Drinkard Pools with the production of hydrocarbons from the Blinebry and Tubb zones and the production of oil from the Drinkard zone to be through parallel strings of 2 1/16-inch tubing.

(3) That the mechanics of the proposed triple completion are feasible and in accord with good conservation practices.

(4) That approval of the subject application will neither cause waste nor impair correlative rights.

IT IS THEREFORE ORDERED:

(1) That the applicant, Continental Oil Company, is hereby authorized to complete its Hawk B-3 Well No. 21, located in Unit L

of Section 3, Township 21 South, Range 37 East, NMPM, Lea County, New Mexico, as a triple completion (conventional) in the Blinebry, Tubb and Drinkard Pools with the production of hydrocarbons from the Blinebry and Tubb zones and the production of oil from the Drinkard zone to be through parallel strings of 2 1/16-inch tubing.

PROVIDED HOWEVER, That the applicant shall complete, operate, and produce said well in accordance with the provisions of Rule 112-A of the Commission Rules and Regulations.

PROVIDED FURTHER, That the applicant shall take packer-leakage tests upon completion and annually thereafter during the Gas-Oil Ratio Test Period for the Drinkard formation.

(2) That jurisdiction of this cause is retained for the entry of such further orders as the Commission may deem necessary.
