NOW, on this <u>26th</u> day of December, 1962, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

## FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Tapacito-Pictured Cliffs Pool, the Boulder-Mancos Oil Pool, the Devils Fork-Gallup Pool and the Puerto Chiquito-Gallup Oil Pool in Rio Arriba County, New Mexico, the Aztec-Pictured Cliffs Pool, the Angels Peak-Gallup Oil Pool and the Cha Cha-Gallup Oil Pool in San Juan County, New Mexico, and to the Ballard-Pictured Cliffs Pool and the South Blanco-Pictured Cliffs Pool in Rio Arriba, Sandoval and San Juan Counties, New Mexico.
