### ORDER OF THE COMMISSION

#### BY THE COMMISSION:

This cause came on for hearing at 9 o'clcok a. m. on December 16, 1952, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission".

NOW, on this 9th day of January, 1953, the Commission, a quorum being present, having considered said application and the evidence introduced in support thereof, and being fully advised in the premises,

## FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the propsed unit plan will in principle tend to promote the conservation of oil and gas and the prevention of waste.

# IT IS THEREFORE ORDERED:

SECTION 1: That this order shall be known as the

## SAN JUAN 28-7 UNIT AGREEMENT ORDER

<u>SECTION</u> 2: (a) That the project herein referred to shall be known as the San Juan 28-7 Unit Agreement, and shall hereafter be referred to as the "Project".

(b) That the plan by which the Project shall be operated shall be embraced in the form of a unit agreement for the development and operation of the San Juan 28-7 Unit Area referred to in the Applicant's application and filed with said application, and such plan shall be known as the San Juan 28-7 Unit Agreement Plan.

SECTION 3: That the San Juan 28-7 Unit Agreement Plan shall be, and hereby is, approved in principle as a proper conservation measure; provided however, that notwithstanding any of the provisions contained in said unit agreement this approval shall not be considered as waiving or relinquishing in any manner any rights, duties or obligations which are now, or may hereafter be, vested in the New Mexico Oil Conservation Commission by law relative to the supervision and control of operations for exploration and development of any lands committed to said San Juan 28-7 Unit Agreement, or relative to the production of oil or gas therefrom. SECTION 4: (a) That the Unit Area Shall be:

Township 27 North, Range 9 West All of Sections 1 through 12, incl. W/2 Section 15; All of Sections 16 through 21, incl. W/2 Section 22; All of Section 29 and 30: N/2 Section 28; NW/4 Section 27

Township 28 North, Range 7, West All of partial Sections 7 through 12, incl; All of Sections 13 through 36, incl.

containing 30,684.76 acres, more or less

(b) The unit area may be enlarged or contracted as provided in said Plan.

<u>SECTION</u> 5: That the unit operator shall file with the Commission an executed counterpart of the San Juan 28-7 Unit Agreement within 30 days after the effective date thereof.

<u>SECTION 6</u>: That any party owning rights in the unitized substances who dose not commit such rights to said unit agreement before the effective date thereof may thereafter become a party thereto by subscribing to such agreement or counter part thereof, or by ratifying the same and, if the owner of a working interest, by joinder in the ralated unit operating agreement. The unit operator shall file with the Commission within 30 days a duplicate original of any such counterpart or ratification.

<u>SECTION</u> 7: That this order shall become effective upon approval of said unit agreement by the <sup>C</sup>ommissioner of Public Lands of the State of New Mexico and the Director of the United States Geological Survey, and shall terminate ipso facto upon the termination of said unit agreement. The last unit operator shall file with the Commissioner in writing immediate notice of such termination.
