THE APPLICANTION OF EL PASO NATURAL GAS COMPANY FOR AN ORDER APPROVING A PROPOSED UNIT AGREEMENT FOR THE DEVELOPMENT AND OPERATION OF THE SAN JUAN 32-9 UNIT AREA, CONSISTING OF 34,654.41 ACRES, MORE OR LESS, SISTUATED IN TOWNSHIP 31 NORTH, RANGE 9 WEST, TOWNSHIP 31 NORTH, RANGE 10 WEST, TOWNSHIP 32 NORTH, RANGE 9 WEST AND TOWNSHIP 32 NORTH, RANGE 10 WEST, SAN JUAN COUNTY, NEW MEXICO

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9:00 o'clock a. m., March 17, 1953, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Gommission".

NOW, on this 27th day of March, 1953, the Commission having before it for consideration the testimony adduced at the haring of said case and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the proposed unit plan will principle tend to promote the conservation of oil and gas and the prevention of waste.

IT IS THEREFORE ORDERED:

That the order herein shall be known as the :

"SAN JUAN 32-9 UNIT AGREEMENT ORDER"

SECTION 1. (a) That the project herein shall be known as the San Juan 32-9 Unit Agreement and shall hereafter be referred to as the "Project".

(b) That the plan by which the Project shall be operated shall be embraced in the form of a unit agreement for the development and operation of the San Juan 32-9 Unit Area referred to in the Petitioner's petition and filed with said petition and such plan shall be known as the San Juan 32-9 Unit Agreement Plan.

<u>SECTION 2.</u> That the San Juan 32-9 Unit Agreement shall be, and is hereby approved in principle as a proper conservation measure; provided, however, that notwithstanding any of the provisions contained in said unit agreement, this approval of said agreement shall not be considered as waiving or relinquishing in any manner any rights, duties, or obligations which are now or may hereafter be vested in the NEW Mexico Oil Conservation Commission by law relative to the supervision and control of operations for exploration and development of any lands committed to said San Juan 32-9 Unit Agreement or relative to the production of oil or gas therefrom.

<u>SECTION 3.</u> (a) That the Unit Area shall be:

NEW MEXICO PRINCIPAL MERIDIAN

Township 31 North, Range 9 West Sections 2 through 10, All Sections 15 through 18, All

Township 31 North, Range 10 West, Sections 1 and 2, All Sections 11 through 14, All

Township 32 North, Range 9 West

Sections 7 through 36, All

Township 32 North, Range 10 West Sections 11 through 14, All Sections 23 through 26, All Sections 35 and 36, All Containing 34,654.41 acres, more or less.

(b) That Unit Area may be enlarged or contracted as provided in said Plan.

<u>SECTION 4</u>. That the unit operator shall file with Commission an executed original or executed counterpart thereof of the San Juan 32-9 Unit Agreement not later than 30 days after the effective date thereof.

<u>SECTION 5.</u> That any party owning rights in the unitized substances who does not commit such rights to said Unit Agreement before the effective date thereof may thereafter become a party thereto by subscribing to such agreement or a counterpart thereof. The Unit Operator shall file with the Commission within 30 days an original or any such counterpart.

<u>SECTION 6.</u> That this order shall become effective on the first day of the calendar month next following the approval of the Commissioner of Public Lands and the Director of the United States Geological Survey and shall terminate ipso facto on the termination of said Unit Agreement. The Last Unit Operator shall immediately notify the Commission in writing of such termination.
