BY THE COMMISSION:

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the Attorney for the Commission stated at the hearing that the subject wells had been plugged prior to the hearing in accordance with a Commission-approved plugging program and moved to dismiss the case.

(3) That Case No. 3439 should be dismissed.

IT IS THEREFORE ORDERED:

That Case No. 3439 is hereby dismissed.
