ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on August 20, 1953, an Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, heldeinafter referred to as the "Commission."

NOW, on this 17th day of September, 1953, the Commission, a quorum using present, having considered the testimony adduced and the exhibits received at said hearing, and being fully advised in the premises,

FINDS;

(1) That due notice having been given as required by law, the Commission cas jurisdiction of this cause and the subject matter thereof.

(2) That the respective boundaries of the Gladiola-Wolfcamp, Lazy 'J', Lovington-Abo, Lovington-Paddock, Square Lake, and Cooper-Jal oil pools include be extended to include in such pools the respectively described lands in accordance with the testimony adduced and recommendations made for each pool at the hearing.

(3) That the boundary of the Langlie-Mattix Oil Pool should be contracted we eliminate therefrom the W/2 E/2 Section 19, Township 25 South, Range 37 East, NMPM.

IT IS THEREFORE ORDERED:

(1) That the boundary of the Gladiola-Wolfcamp Oil Pool in Lea County, New Mexico, as the same existed heretofore, be, and the same hereby is extended to include therein and make a part of said pool;

Township 12 South, Range 37 East, NMPM E/2 Section 25 -2-Case No. 571 Order No. R-365

(2) That the boundary of the Lazy 'J' (Pennsylvanian) Oil Pool in Lea County, New Mexico, as the same existed heretofore, be, and the same hereby is extended to include therein and make a part of said pool:

> Township 13 South, Range 33 East, NMPM W/2 Section 34

(3) That the boundary of the Lovington-Abo Oil Pool in Lea County, New Mexico, as the same existed heretofore, be, and the same hereby is extended to include therein and make a part of said pool:

Township 17 South, Range 36 East, NMPM NE/4 Section 2

(4) That the boundary of the Lovington-Paddock Oil Pool in Lea County, New Mexico, as the same existed heretofore, be, and the same hereby is extended to include therein and make a part of said pool:

Township 16 South, Range 37 East, NMPM SW/4 Section 30

(5) That the boundary of the Square Lake (Grayburg-San Andres) Oil Pool in Eddy County, New Mexico, as the same existed heretofore, be, and the same hereby is extended to include therein and make a part of said pool:

Township 17 South, Range 30 East, NMPM S/2 NW/4, NE/4 Section 12

(6) That the boundary of the Langlie-Mattix (Yates-Queen -Seven Ravers) Oil Pool in Lea County, New Mexico, as the same existed heretofore, be, and the same hereby is contracted to eliminate from the said boundary and pool:

Township 25 South, Range 37 East, NMPM W/2 E/2 Section 19

(7) That the boundary of the Cooper-Jal (Yates-Seven Rivers) Oil Pool in Lea County, New Mexico, as the same existed heretofore, be, and the same hereby is extended to include therein and make a part of said pool:

Township 25 South, Range 37 East, NMPM W/2 E/2 Section 19
