THE APPLICATION OF THE OIL CONSERVATION DIVISION UPON ITS OWN MOTION FOR AN ORDER CREATING AND EXTENDING VERTICAL AND HORIZONTAL LIMITS OF CERTAIN POOLS IN CHAVES, EDDY, LEA, AND ROOSEVELT COUNTIES, NEW MEXICO.

## ORDER OF THE DIVISION

#### BY THE DIVISION:

This cause came on for hearing at 9 a.m. on July 23, 1980, at Santa Fe, New Mexico, before Examiner Richard L. Stamets.

NOW, on this <u>4th</u> day of August, 1980, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

#### FINDS:

(1) That due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the Bone Spring formation, said pool to bear the designation of Forty Niner Ridge-Bone Spring Pool. Said Forty Niner Ridge-Bone Spring Pool was discovered by the Getty Oil Company Forty Niner Ridge Unit Well No. 2 located in Unit G of Section 21, Township 23 South, Range 30 East, NMPM. It was completed in the Bone Spring formation on October 19, 1977. The top of the perforations is at 7514 feet.

(3) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Mississippian formation, said pool to bear the designation of Gladiola-Mississippian Pool. Said Gladiola-Mississippian Pool was discovered by the Skelton Oil Company Z. Taylor Well No. 2 located in Unit G of Section 7, Township 12 South, Range 38 East, NMPM. It was completed in the Mississippian formation -2-Case No. 6986 Order No. R-6420

on May 25, 1980. The top of the perforations is at 11,405 feet.

(4) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Strawn formation, said pool to bear the designation of Pawnee-Strawn Gas Pool. Said Pawnee-Strawn Gas Pool was discovered by the Gifford, Mitchell & Wisenbaker White Eagle Well No. 1 located in Unit F of Section 22, Township 26 South, Range 36 East, NMPM. It was completed in the Strawn formation on April 18, 1980. The top of the perforations is at 12,505 feet.

(5) That there is need for the creation of a new pool in Chaves County, New Mexico, for the production of gas from the Abo formation, said pool to bear the designation of Penjack-Abo Gas Pool. Said Penjack-Abo Gas Pool was discovered by the McClellan Oil Corporation Penjack Well No. 1 located in Unit D of Section 6, Township 10 South, Range 26 East, NMPM. It was completed in the Abo formation on February 3, 1979. The top of the perforations is at 4312 feet.

(6) That there is need for the creation of a new pool in Roosevelt County, New Mexico, for the production of oil from the Pennsylvanian formation, said pool to bear the designation of North Peterson-Pennsylvanian Pool. Said North Peterson-Pennsylvanian Pool was discovered by the Enserch Exploration, Inc. Amoco State Well No. 1 located in Unit L of Section 16, Township 4 South, Range 33 East, NMPM. It was completed in the Pennsylvanian formation on June 4, 1980. The top of the perforations is at 7826 feet.

(7) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Morrow formation, said pool to bear the designation of Red Hills-Morrow Gas Pool. Said Red Hills-Morrow Gas Pool was discovered by the Amoco Production Company Andrikopoulos Federal Well No. 1 located in Unit L of Section 24, Township 25 South, Range 33 East, NMPM. It was completed in the Morrow formation on April 14, 1980. The top of the perforations is at 14,986 feet.

(8) That there is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Atoka formation, said pool to bear the designation of Sand Point-Atoka Gas Pool. Said Sand Point-Atoka Gas Pool was discovered by the Perry R. Bass Big Eddy Unit Well No. 72 located in Unit R of Section 3, Township 21 South, Range 28 East, NMPM. It was completed in the Atoka formation on May 28, 1980. The top of the perforations is at 11,265 feet. -3-Case No. 6986 Order No. R-6420

(9) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Morrow formation, said pool to bear the designation of Young-Morrow Gas Pool. Said Young-Morrow Gas Pool was discovered by the Harvey E. Yates Company Young Deep Unit Well No. 1 located in Unit D of Section 10, Township 18 South, Range 32 East, NMPM. It was completed in the Morrow formation on April 18, 1980. The top of the perforations is at 12,835 feet.

(10) That there is need for the extension of the vertical limits of the Nadine-Drinkard Pool in Lea County, New Mexico, to include the Abo formation and the redesignation of said pool as the Nadine Drinkard-Abo Pool.

(11) That there is need for the extension of the vertical limits of the Sioux Tansill-Yates Pool in Lea County, New Mexico, to include the Seven Rivers formation and the redesignation of said pool as the Sioux Tansill-Yates-Seven Rivers Pool and the extension of the horizontal limits of said pool.

That there is need for certain extensions to the West (12)Bitter Lake-San Andres Pool, the Buffalo Valley-Pennsylvanian Gas Pool, the Cato-San Andres Pool, the Race Track-San Andres Pool, the Railroad Mountain-San Andres Pool, the Round Tank-Queen Associated Pool, the Tom-Tom San Andres Pool, and the Twin Lakes-San Andres Associated Pool, all in Chaves County, New Mexico, and the Baldridge Canyon-Morrow Gas Pool, the North Benson Queen-Grayburg Pool, the Boyd-Morrow Gas Pool, the Diamond Mound-Atoka Gas Pool, the Diamond Mound-Morrow Gas Pool, the East Eagle Creek Atoka-Morrow Gas Pool, the Indian Flats-Atoka Gas Pool, the Indian Flats-Morrow Gas Pool, the Southwest Indian Flats-Morrow Gas Pool, the Penasco Draw-Morrow Gas Pool, the Red Lake-Pennsylvanian Gas Pool, the Richard Knob Atoka-Morrow Gas Pool, the Sand Point-Morrow Gas Pool, and the North Turkey Track-Morrow Gas Pool, all in Eddy County, New Mexico, and the Airstrip-Wolfcamp Pool, the Mid Bell Lake-Devonian Gas Pool, the Brunson-Fusselman Pool, the Gem-Morrow Gas Pool, the East Grama Ridge-Morrow Gas Pool, and the La Rica-Morrow Gas Pool, all in Lea County, New Mexico, and the South Peterson-Pennsylvanian Pool and the Tomahawk-San Andres Pool, both in Roosevelt County, New Mexico.

### IT IS FURTHER ORDERED:

That pursuant to Section 70-2-18, NMSA 1978, contained (1)in Chapter 271, Laws of 1969, any well which, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Forms C-102 dedicating a standard unit for the pool to said well, or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within said 60-day period shall subject the well to cancellation of allowable.

(2) That the effective date of this order and all creations and extensions of vertical and horizontal limits included herein shall be August 1, 1980.
