THE APPLICATION OF THE OIL CONSERVATION COMMISSION UPON ITS OWN MOTION FOR AN ORDER REVISING RULE 1109 OF SECTION 'M', REPORTS, OF THE RULES AND REGULATIONS OF THE COMMISSION, AND FOR REVISION OF COMMISSION FORM C-110, 'CERTIFICATE OF COMPLIANCE AND AUTHORIZATION TO TRANSPORT OIL AND NATURAL GAS'.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m., on May 18, 1955, at Santa Fe, New Mexico, before the Oil Conservation Commission, hereinafter referred to as the "Commission".

NOW, on this $20^{\frac{1}{2}}$ day of June, 1955, the Commission, a quorum being present, having considered the testimony adduced at said hearing, and being fully advised in the premises,

FINDS:

(1) That due notice of hearing having been given as required by law, the Commission has jurisdiction of this case and the subject matter thereof.

(2) That Rule 1109 of the official Rules and Regulations, which rule relates to Certificate of Compliance and Authorization to Transport Oil and Natural Gas, should be revised and clarified.

(3) That Commission Form C-ll0, 'Certificate of Compliance and Authorization to Transport Oil and Natural Gas', should be revised as set out in Exhibit "A" attached hereto.

IT IS THEREFORE ORDERED:

(1) That Rule 1109 of Section 'M' of the official Rules and Regulations of the Commission be, and the same hereby is amended to read as follows:

<u>RULE 1109:</u> <u>AUTHORIZATION TO TRANSPORT OIL</u> <u>AND NATURAL GAS - (FORM C-110):</u>

- (a) Each producer of crude petroleum oil, casinghead gas, liquid hydrocarbons, and natural gas shall execute, in QUINTUPLICATE, and file Form C-110 with the Commission, setting forth fully therein the data and information indicated by such form covering each well from which crude petroleum oil, casinghead gas, natural gas or liquid hydrocarbons are produced.
- (b) Whenever there shall occur a change in operating ownership of any producing well or whenever there shall occur a change of transporter from any producing well, Form C-110 shall be executed and filed in accordance with instructions; except that in the case of a temporary change in transporter involving less than the allowable for one proration period the producer may, in lieu of filing a new application, notify the Commission, and the transporter then authorized, by a letter of the estimated amount of crude petroleum, casinghead gas, dry gas or liquid hydrocarbons to be moved by the temporary transporter and a copy of such notice shall also be furnished such temporary transporter. In no instance shall the temporary transporter move any greater quantity of crude petroleum oil, liquid hydrocarbons or natural gas than the estimated amount shown in said notice.

(2) Commission Form C-110 is hereby revised as set out in Exhibit "A" hereto attached and made a part hereof.
