THE APPLICATION OF THE OIL CONSERVATION DIVISION UPON ITS OWN MOTION FOR AN ORDER CREATING, ASSIGNING A DISCOVERY ALLOWABLE, CONTRACTING AND EXTENDING CERTAIN POOLS IN CHAVES, EDDY, LEA, AND ROOSEVELT COUNTIES, NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 9 a.m. on December 16, 1981, at Santa Fe, New Mexico, before Examiner Richard L. Stamets.

NOW, on this <u>22nd</u> day of January, 1982, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Upper Pennsylvanian formation, said pool to bear the designation of Draper Mill-Upper Pennsylvanian Gas Pool with vertical limits defined as from the top of the Pennsylvanian formation at 14,128 feet to the top of the Morrow formation at 15,003 feet as found on the log of the discovery well, the HNG Oil Company Vaca Draw 16 State Well No. 1 located in Unit E of Section 16, Township 25 South, Range 33 East, NMPM. It was completed in the Upper Pennsylvanian formation on September 23, 1981. The top of the perforations is at 14,248 feet. -2-Case No. 7447 Order No. R-6876

(3) That there is need for the creation of a new pool in Roosevelt County, New Mexico, for the production of oil from the Pennsylvanian formation, said pool to bear the designation of Dora-Pennsylvanian Pool. Said Dora-Pennsylvanian Pool was discovered by the Enserch Exploration, Inc. Annie Harvey Well No. 1 located in Unit J of Section 6, Township 5 South, Range 33 East, NMPM. It was completed in the Pennsylvanian formation on July 19, 1981. The top of the perforations is at 8,190 feet.

(4) That there is need for the creation of a new pool in Chaves County, New Mexico, for the production of gas from the Montoya formation, said pool to bear the designation of Lightcap-Montoya Gas Pool. Said Lightcap-Montoya Gas Pool was discovered by the Aikman Petroleum, Inc. Sanders Well No. 1 located in Unit E of Section 8, Township 8 South, Range 30 East, NMPM. It was completed in the Montoya formation on September 21, 1981. The top of the perforations is at 7,903 feet.

(5) That there is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the Cherry Canyon formation, said pool to bear the designation of Loving-Cherry Canyon Pool. Further, that the discovery well for said pool, the Pogo Production Company NEL Well No. 2 located in Unit I of Section 9, Township 23 South, Range 28 East, NMPM, is entitled to and should receive a bonus discovery allowable in the amount of 18,240 barrels, to be assigned over a two-year period. Said discovery well was completed in the Cherry Canyon formation on August 1, 1981. The top of the perforations is at 3,648 feet.

(6) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Strawn formation, said pool to bear the designation of Midway-Strawn Pool. Said Midway-Strawn Pool was discovered by the David Fasken Consolidated State Well No. 2 located in Unit A of Section 8, Township 17 South, Range 37 East, NMPM. It was completed in the Strawn formation on July 2, 1981. The top of the perforations is at 10,725 feet.

(7) That there is need for the creation of a new pool in Chaves County, New Mexico, for the production of gas from the Abo formation, said pool to bear the designation of Pecos Slope-Abo Gas Pool. Said Pecos Slope-Abo Gas Pool was discovered by the Yates Petroleum Corporation Federal HY Well No. 2 located in Unit 0 of Section 33, Township 7 South, Range 25 East, NMPM. It was completed in the Abo formation on May 16, 1979. The top of the perforations is at 3,548 feet. -3-Case No. 7447 Order No. R-6876

(8) That there is need for the creation of a new pool in Chaves County, New Mexico, for the production of gas from the Abo formation, said pool to bear the designation of West Pecos Slope-Abo Gas Pool. Said West Pecos Slope-Abo Gas Pool was discovered by the Mesa Petroleum Company Rock Federal Well No. 1 located in Unit J of Section 7, Township 8 South, Range 23 East, NMPM. It was completed in the Abo formation on October 7, 1980. The top of the perforations is at 2,810 feet.

(9) That there is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the Bone Spring formation, said pool to bear the designation of Red Bluff-Bone Spring Pool. Said Red Bluff-Bone Spring Pool was discovered by the HCW Exploration, Inc. Dorstate Well No. 1 located in Unit H of Section 27, Township 25 South, Range 28 East, NMPM. It was completed in the Bone Spring formation on July 8, 1981. The top of the perforations is at 6,412 feet.

(10) That there is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the Bone Spring formation, said pool to bear the designation of Willow Lake-Bone Spring Pool. Said Willow Lake-Bone Spring Pool was discovered by the Maddox Energy, Inc. Union Federal Well No. 1 located in Unit H of Section 33, Township 24 South, Range 28 East, NMPM. It was completed in the Bone Spring formation on August 6, 1981. The top of the perforations is at 6,155 feet.

(11) That there is need for the contraction of the vertical limits of the North Shoebar-Pennsylvanian Pool in Lea County, New Mexico, to the Strawn formation only and the redesignation of said pool to Northwest Shoebar-Strawn Pool.

(12) That there is need for certain extensions to the Diamond Mound-Morrow Gas Pool, the Tomahawk-San Andres Pool, and the Twin Lakes-San Andres Associated Pool, all in Chaves County, New Mexico, and the Avalon-Morrow Gas Pool, the Bunting Ranch-Morrow Gas Pool, the West Burton Flat-Atoka Gas Pool, the South Culebra Bluff-Bone Spring Pool, the North Loving-Morrow Gas Pool, the South Millman-Morrow Gas Pool, the Penasco Draw San Andres-Yeso Associated Pool, the Robina Draw-Morrow Gas Pool, and the Turkey Track-Atoka Gas Pool, all in Eddy County, New Mexico, and the South Bell Lake-Morrow Gas Pool, the Gem-Morrow Gas Pool, the Inbe-Permo Pennsylvanian Pool, the West Nadine-Blinebry Pool, the Nadine Drinkard-Abo Pool, the Oil Center-Blinebry Pool, the Oil Center-Glorieta Gas Pool, the Sawyer-San Andres Associated Pool, all in Lea County, New Mexico.

IT IS FURTHER ORDERED:

(1) That pursuant to Section 70-2-18, NMSA 1978, contained in Chapter 271, Laws of 1969, any well which by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Forms C-102 dedicating a standard unit for the pool to said well, or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within said 60-day period shall subject the well to cancellation of allowable.

(2) That the effective date of this order and all creations, contractions of vertical limits, and extensions included herein shall be January 1, 1982.
