THE APPLICATION OF THE OIL CONSERVATION DIVISION UPON ITS OWN MOTION FOR AN ORDER CREATING, CONTRACTING, AND EXTENDING CERTAIN POOLS IN CHAVES, EDDY, AND LEA COUNTIES, NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 9 a.m. on October 12, 1983, at Santa Fe, New Mexico, before Examiner Richard L. Stamets.

NOW, on this <u>20th</u> day of October, 1983, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Bone Spring formation, said pool to bear the designation of Northeast Black River-Bone Spring Gas Pool. Said Northeast Black River-Bone Spring Gas Pool was discovered by The Desana Corporation State AK Well No. 1 located in Unit K of Section 32, Township 23 South, Range 27 East, NMPM. It was completed in the Bone Spring formation on February 24, 1982. The top of the perforations is at 5,496 feet.

(3) That there is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the Yeso formation, said pool to bear the designation of Cemetery-Yeso Pool. Said Cemetery-Yeso Pool was discovered by the Amoco Production Company Rio Siete Well No. 1 located in Unit J of Section 11, Township 20 South, Range 25 East, NMPM. It was completed in the Yeso formation on January 10, 1983. The top of the perforations is at 2,948 feet. -2-Case No. 7981 Order No. R-7372

(4) That there is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Morrow formation, said pool to bear the designation of Chosa Draw-Morrow Gas Pool. Said Chosa Draw-Morrow Gas Pool was discovered by The Superior Oil Company Delta Federal Well No. 1 located in Unit G of Section 7, Township 25 South, Range 26 East, NMPM. It was completed in the Morrow formation on May 22, 1980. The top of the perforations is at 11,333 feet.

(5) That there is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the Delaware formation, said pool to bear the designation of West Dark Canyon-Delaware Pool. Said West Dark Canyon-Delaware Pool was discovered by the Exxon Corporation New Mexico DI State Well No. 1 located in Unit E of Section 19, Township 23 South, Range 26 East, NMPM. It was completed in the Delaware formation on June 9, 1983. The top of the perforations is at 4,690 feet.

(6) That there is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the Yeso formation, said pool to bear the designation of East Dayton-Yeso Pool. Said East Dayton-Yeso Pool was discovered by the Read and Stevens, Inc. Fair Well No. 1 located in Unit F of Section 30, Township 18 South, Range 27 East, NMPM. It was completed in the Yeso formation on September 23, 1982. The top of the perforations is at 3,150 feet.

(7) That there is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Atoka formation, said pool to bear the designation of Empire-Atoka Gas Pool. Said Empire-Atoka Gas Pool was discovered by the Exxon Corporation New Mexico CY State Well No. 1 located in Unit J of Section 23, Township 17 South, Range 28 East, NMPM. It was completed in the Atoka formation on August 26, 1980. The top of the perforations is at 9,956 feet.

(8) That there is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Morrow formation, said pool to bear the designation of Owen Mesa-Morrow Gas Pool. Said Owen Mesa-Morrow Gas Pool was discovered by The Superior Oil Company Oscar State Well No. 1 located in Unit G of Section 36, Township 24 South, Range 29 East, NMPM. It was completed in the Morrow formation on July 30, 1980. The top of the perforations is at 13,594 feet.

(9) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Atoka formation, said pool to bear the designation of South Red Hills-Atoka Gas Pool. Said South Red Hills-Atoka Gas Pool was -3-Case No. 7981 Order No. R-7372

discovered by the Amoco Production Company State IT Well No. 1 located in Unit F of Section 16, Township 26 South, Range 33 East, NMPM. It was completed in the Atoka formation on October 15, 1981. The top of the perforations is at 14,418 feet.

(10) That there is need for the contraction of the vertical limits of the Rhodes Yates-Seven Rivers Gas Pool in the E/2 of Section 5, Township 26 South, Range 37 East, NMPM, to be defined as being from the top of the Yates formation to a point in the Seven Rivers formation which is 100 feet above the top of the Queen formation, in order to correct an overlap with the Langlie Mattix Seven Rivers-Queen-Grayburg Pool.

(11)That there is need for certain extensions to the South Haystack-San Andres Pool, the Railroad Mountain-San Andres Pool, and the Sams Ranch-Grayburg Gas Pool, all in Chaves County, New Mexico, and the South Carlsbad-Bone Spring Pool, the South Carlsbad-Morrow Gas Pool, the Dublin Ranch-Atoka Gas Pool, the Grayburg-Upper Pennsylvanian Pool, the McMillan-Upper Pennsylvanian Gas Pool, the Sand Dunes-Morrow Gas Pool, the Square Lake Grayburg-San Andres Pool, the Travis-Yates Gas Pool, and the Turkey Track Seven Rivers-Queen-Grayburg-San Andres Pool, all in Eddy County, New Mexico, and the Antelope Ridge-Atoka Gas Pool, the Blinebry Oil and Gas Pool, the South Humble City-Strawn Pool, the Justis-Paddock Pool, the South Kemnitz Atoka-Morrow Gas Pool, the Langlie Mattix Seven Rivers-Queen-Grayburg Pool, the Pitchfork Ranch-Morrow Gas Pool, the Sawyer-San Andres Associated Pool, the Scharb-Bone Spring Pool, the Southeast Scharb-Wolfcamp Pool, the Wantz-Granite Wash Pool, and the North Young-Bone Spring Pool, all in Lea County, New Mexico.

IT IS THEREFORE ORDERED:

(a) That a new pool in Eddy County, New Mexico, classified as a gas pool for Bone Spring production is hereby created and designated as the Northeast Black River-Bone Spring Gas Pool, consisting of the following described area:

TOWNSHIP 23 SOUTH, RANGE 27 EAST, NMPM Section 32: SW/4

(b) That a new pool in Eddy County, New Mexico, classified as an oil pool for Yeso production is hereby created and designated as the Cemetery-Yeso Pool, consisting of the following described area:

> TOWNSHIP 20 SOUTH, RANGE 25 EAST, NMPM Section 11: SE/4

(c) That a new pool in Eddy County, New Mexico, classified as a gas pool for Morrow production is hereby created and designated as the Chosa Draw-Morrow Gas Pool, consisting of the following described area:

TOWNSHIP 25 SOUTH, RANGE 26 EAST, NMPM Section 7: E/2

(d) That a new pool in Eddy County, New Mexico, classified as an oil pool for Delaware production is hereby created and designated as the West Dark Canyon-Delaware Pool, consisting of the following described area:

(e) That a new pool in Eddy County, New Mexico, classified as an oil pool for Yeso production is hereby created and designated as the East Dayton-Yeso Pool, consisting of the following described area:

(h) That a new pool in Lea County, New Mexico, classified as a gas pool for Atoka production is hereby created and designated as the South Red Hills-Atoka Gas Pool, consisting of the following described area:

IT IS FURTHER ORDERED:

(1) That pursuant to Section 70-2-18, NMSA 1978, contained in Chapter 271, Laws of 1969, any well, which by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Forms C-102 dedicating a standard unit for the pool to said well, or to obtain a non-standard unit approved by the Division. Pending such compliance the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within said 60-day period shall subject the well to cancellation of the allowable. -9-Case No. 7981 Order No. R-7372

(2) That the effective date of this order and all creations, contractions, and extensions included herein shall be November 1, 1983.
